We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan of National Center for Youth Law, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### **Basis for Opinion**

#### **1. Description of Plan**

The following description of 403(b) Thrift Plan of National Center For Youth Law (“the Plan”) provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a 403(b) tax-deferred annuity plan covering all employees of National Center for Youth Law (“NCYL”).

##### **Contributions**

Participants may elect to contribute any portion of their eligible compensation to the Plan each year up to the maximum limited as permitted by the Internal Revenue Code. Additionally, participants have no minimum age requirement nor minimum service requirement to make salary reduction contributions to this plan. There are no minimum age requirement nor minimum service requirement to receive employer base contributions under this plan participants may also contribute amounts on the entry date immediately following date of hire.

NCYL contributes 4% of each participant's annual compensation.

##### **Participants Accounts**

Each participant’s account is credited with the allocation of NCYL’s contribution and the Plan earnings. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### **Vesting**

Participants are fully vested in their salary deferral plus actual earnings thereon. The value of the individual account is fully and immediately vested from the date of participation in the Plan. In addition, participants are 100% vested at all times in any contributions made to the Plan.

##### **Payment of Benefits**

In general, on termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the fair value of the participant's account balance. Participant may also elect to receive benefits in partial lump sum distributions and installments (monthly, quarterly, or annually).

#### 2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

##### **Basis of Presentation**

The financial statements of the Plan are reported on the accrual basis of accounting.

##### **Investments Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend rate. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold, as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants on the Statement of Net Assets Available for Benefits as of December 31, 2024, is recorded at their unpaid balance. Interest income on notes receivable from participants is recorded when it is earned, and the related fees are recorded as administrative expenses and expensed when incurred.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Fair Value Measurements**

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relate to the element.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

##### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect a participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

##### **Subsequent Events**

Management has evaluated subsequent events through October 11, 2024, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

#### 3. Notes Receivable from Participants

Notes receivable from participants are repaid semi-monthly, at an interest rate of 4.6%, maturing in October 1, 2028. Notes receivable from participants outstanding at December 31, 2024 and 2023, were \$113,138 and \$65,807 respectively.

#### 4. Information Prepared and Certified by the Custodian

No auditing procedures were performed on investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The following summarizes the information certified by Mutual of America Life Insurance Company, the custodian of the Plan, as of December 31, 2024 and 2023 respectively.

The general account (interest accumulation account) is comparable to a cash equivalent and therefore exempt from classification as a Level 1, 2, or 3 asset under ASU-820-10 for the following reasons: 1) there are no front-or-back end charges, so investments in the general account are completely liquid; 2) the interest rate credited to investments in the general account is a current rate, and is not dependent upon the length of time the assets are invested with Mutual of America Life Insurance Company; 3) requests for withdrawal can be made at any time and are processed on the day that they are received; they are not dependent on the company having to liquidate securities in order to generate a payment; and 4) the value shown on the pension fund report is the redeemable value of the fund; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of a withdrawal request.

#### **7. Related Party and Party-in-Interest Transactions**

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$1,598.

The Plan's investment options include funds managed by Mutual of America Life Insurance Company or its affiliates. As custodian and recordkeeper, Mutual of America Life Insurance Company's transactions qualify as exempt parties-in-interest transactions.

#### **8. Plan Termination**

Although it has not expressed any intent to do so, NCYL has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **9. Tax Status**

The Plan presently does not have a tax determination letter from the Internal Revenue Service ("IRS") since 403(b) plans currently are not required to submit plans to the IRS for determination. However, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
