1. Plan Description

The following description of the SCARC, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

SCARC, Inc. (the "Company" or "Sponsor") established the Plan, a participant-directed defined contribution plan, effective July 1, 1976. The Plan was amended and restated as a profit-sharing plan as of February 15, 2001. The Plan was amended and restated as a profit-sharing plan and trust as of January 1, 2009. The Company had terminated the Plan status as established under the Internal Revenue Code ("IRC") 401(a) and elected the status under IRC 401(k). Effective July 1, 2011, the Plan was amended and restated, as a profit-sharing and retirement savings plan for the benefit of participating employees of the Company. The Plan offers options in which participants may elect to direct Company contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Company are generally eligible to participate in the Plan on the first day of the quarter subsequent to attaining the age 21 and completing 90 days of service having completed at least 83.3 hours of service during each month. The Plan was amended in 2003 to specifically exclude "Substitute Employees" as defined by the Plan.

Contributions

Eligible participants may elect to contribute compensation, excluding bonuses, overtime and commissions, to the plan, and not to exceed amounts established by the IRC. In addition, participants who have attained the age 50 before the end of the year are eligible to make catch-up contributions up to the amount established by the IRC. The Company can elect to make a discretionary contribution to the plan.

The Company elected to make a profit sharing contribution for each participant totaling 4% of each participant's eligible compensation. The Company may make discretionary matching contributions to the Plan, in which all eligible employees will receive a proportionate amount of the Company's contribution based on the amount of the participant's contribution for an amount up to 3% of the participant's compensation. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Account

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Sponsor's discretionary contributions and Plan earnings.

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the respective participant's vested account.

Payment of Benefits

No distributions from the Plan are made until participants retire, become disabled, die (in which case, payments are made to their beneficiary or if none, their legal representative), can demonstrate a financial hardship, or otherwise terminate employment with the Company. Participants who otherwise terminate employment with the Company are immediately vested in their account plus the actual earnings thereon upon retirement, as defined by the plan, disability or death. Benefit payments to participants are recorded upon distribution.

Vesting

All plan participants hired before August 1, 1995 are fully vested in their account balances as of that date. After August 1, 1995 vesting for plan participants is based on years of continuous service as follows:

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6 and \$1,149, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024 and 2023, employer contributions were reduced by \$25,135 and \$41,735, respectively from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Modified Cash Basis of Accounting

The Plan's financial statements have been prepared on the modified cash basis. Therefore, with the exception of appreciation or depreciation in the market value of investments, income and expense items are recognized only as cash is received or paid and receivables, payables and accrued expenses are not reflected.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the amounts of assets and liabilities, revenues and expenses and changes therein, and disclosures of contingent assets and contingent liabilities and accompanying notes. It is reasonably possible that the Plan's estimates may change in the near term.

Plan Administration Expense

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan's administrator has reviewed subsequent events and transactions that occurred after December 31, 2024 through the date of the independent auditors' report and the date the financial statements were available to be issued, July 24, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with the modified cash basis of accounting. Management has determined that there are no nonrecognized subsequent events that require additional disclosure.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the daily closing price as reported by the fund. The money market funds held by the Plan are deemed to be actively traded.

5. Group Annuity Contract with Nationwide Life Insurance Company

In 2019, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Nationwide Life Insurance Company. The investments at contract value at December 31, 2024 and 2023 totaled \$1,077,277 and \$968,608, respectively. Nationwide Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The Fixed Select Contract crediting rate is reset quarterly. The Fixed Select rates were 2.22% (first quarter), 2.10% (second quarter), 1.98% (third quarter), and 1.86% (fourth quarter). The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by Nationwide Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

7. Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated July 22, 2013, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirement of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions

Certain Plan investments are managed by Nationwide Life Insurance Company during the years ended December 31, 2024 and 2023. Nationwide Life Insurance Company also provides administrative services to the Plan, and therefore, these transactions qualify as exempt party-in-interest.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (modified cash basis).
