#### Note 1 - Description of the Plan

The following description of the KPFF, Inc. 401(k) Plan (the Plan) provides general information only. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

**General** - The Plan is a qualified defined contribution plan covering substantially all employees of KPFF, Inc. (the Company). Union employees, nonresident aliens, leased and on-call employees, residents of Puerto Rico, interns, and temporary employees are excluded from the Plan. Employees are eligible to participate in the Plan upon attainment of 18 years of age and completion of three months total service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration** - The Plan is administered by an investment committee consisting of six members appointed by the Company. Although certain administrative functions are performed by officers or employees of the Company, no such officer or employee receives compensation from the Plan.

**Contributions** - Participants may elect to defer up to 100% of their eligible compensation as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible defined benefit or defined contribution plans (rollover).

At its sole discretion, the Company may make a nonelective contribution. Nonelective contributions are shared with participants who completed six months total service or completed 1,000 hours of service in the computation period. For the year ended December 31, 2024, the Company elected to make nonelective contributions equal to 3% of eligible compensation for each participant satisfying the eligibility requirements. Total nonelective contributions were \$3,805,315 for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contributions as well as allocations of the Company's nonelective contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** - Participants are immediately vested in their salary deferral and Company nonelective contributions plus actual earnings thereon.

**Payment of Benefits** - Upon termination of service, death, disability, or retirement, a participant or their beneficiary may elect to receive a lump sum distribution or substantially equal installment payments of their vested account balance. Participants who have attained age 59½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). For balances greater than \$5,000, the distribution may be in the form of a lump-sum payment or partial withdrawals. For balances less than \$5,000, the distribution will only be paid as a lump-sum payment. The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

#### Note 1 - Continued

**Notes Receivable From Participants** - The Plan allows participants to borrow from their accounts using their vested balance as collateral for the loans. The maximum amount that a participant may borrow is equal to the lesser of 50% of their vested account balance or \$50,000. The minimum amount required to be borrowed is \$1,000. A participant may not have more than two outstanding loans at any time. Loan terms range from one to five years unless it is used to acquire a principal residence, in which case the loan term may be up to fifteen years. Loans bear interest at the Wall Street Journal prime rate plus 1.0%. Principal and interest are paid ratably through payroll deductions.

#### Note 2 - Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Benefits Paid to Participants** - Benefits paid to participants are recognized when they are paid. At December 31, 2024 and 2023, there were \$0 and \$4,089, respectively, of amounts allocated to accounts of participants who had elected to withdraw from the Plan, but had not yet been paid.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains or losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

**Subsequent Events** - The Plan's management has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued.

#### Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts - The fair value of participation units in the pooled separate accounts is determined by Voya based on the valuation of the underlying investments at the end of the year. Net asset value (NAV) per unit is used as a practical expedient for measuring fair value. Participant transactions (purchases and sales) may occur daily. Participants eligible to receive benefit payments may withdraw the value of their pooled separate accounts, in whole or in part, at any time without penalty. There are no participant redemption restrictions for these investments.

Interest-Bearing Cash - Valued at cost plus accrued interest, which approximates fair value.

Self-Directed Brokerage Accounts - Accounts primarily consist of mutual funds, common stocks, unit investment trusts, and money market funds that are valued on the basis of readily determinable market prices.

#### **Note 4 - Fully Benefit-Responsive Investment Contracts**

The Plan entered into a fully benefit-responsive investment contract with Standard Insurance Company (Standard). The contract was terminated in July 2024. The market value adjustment as a result of the termination was not material to the financial statements as a whole and did not limit the ability of the plan to transact at contract value with the participants.

Standard maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Standard was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by Standard but may not be less than 1%. The crediting rate was reviewed on a quarterly basis for resetting.

This contract met the fully benefit-responsive criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### **Note 5 - Certified Information**

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank and Voya Institutional Trust Company, qualified institutions. Effective June 25, 2024, the Plan changed its qualified institution from Charles Schwab Trust Bank to Voya Institutional Trust Company. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

#### **Note 6 - Tax Status**

The Company adopted a Voya Retirement Insurance and Annuity Company (Voya) pre-approved plan document. Voya received an approval letter from the IRS dated June 30, 2020, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### Note 8 - Party-in-Interest Transactions

Certain Plan investments are managed by Charles Schwab, Voya, and their affiliates. Charles Schwab and Voya are custodians for the Plan and, therefore, transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

#### Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 1 - Description of the Plan

The following description of the KPFF, Inc. 401(k) Plan (the Plan) provides general information only. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

**General** - The Plan is a qualified defined contribution plan covering substantially all employees of KPFF, Inc. (the Company). Union employees, nonresident aliens, leased and on-call employees, residents of Puerto Rico, interns, and temporary employees are excluded from the Plan. Employees are eligible to participate in the Plan upon attainment of 18 years of age and completion of three months total service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration** - The Plan is administered by an investment committee consisting of six members appointed by the Company. Although certain administrative functions are performed by officers or employees of the Company, no such officer or employee receives compensation from the Plan.

**Contributions** - Participants may elect to defer up to 100% of their eligible compensation as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible defined benefit or defined contribution plans (rollover).

At its sole discretion, the Company may make a nonelective contribution. Nonelective contributions are shared with participants who completed six months total service or completed 1,000 hours of service in the computation period. For the year ended December 31, 2024, the Company elected to make nonelective contributions equal to 3% of eligible compensation for each participant satisfying the eligibility requirements. Total nonelective contributions were \$3,805,315 for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contributions as well as allocations of the Company's nonelective contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** - Participants are immediately vested in their salary deferral and Company nonelective contributions plus actual earnings thereon.

**Payment of Benefits** - Upon termination of service, death, disability, or retirement, a participant or their beneficiary may elect to receive a lump sum distribution or substantially equal installment payments of their vested account balance. Participants who have attained age 59½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). For balances greater than \$5,000, the distribution may be in the form of a lump-sum payment or partial withdrawals. For balances less than \$5,000, the distribution will only be paid as a lump-sum payment. The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

#### Note 1 - Continued

**Notes Receivable From Participants** - The Plan allows participants to borrow from their accounts using their vested balance as collateral for the loans. The maximum amount that a participant may borrow is equal to the lesser of 50% of their vested account balance or \$50,000. The minimum amount required to be borrowed is \$1,000. A participant may not have more than two outstanding loans at any time. Loan terms range from one to five years unless it is used to acquire a principal residence, in which case the loan term may be up to fifteen years. Loans bear interest at the Wall Street Journal prime rate plus 1.0%. Principal and interest are paid ratably through payroll deductions.

#### Note 2 - Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Benefits Paid to Participants** - Benefits paid to participants are recognized when they are paid. At December 31, 2024 and 2023, there were \$0 and \$4,089, respectively, of amounts allocated to accounts of participants who had elected to withdraw from the Plan, but had not yet been paid.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains or losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

**Subsequent Events** - The Plan's management has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued.

#### Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts - The fair value of participation units in the pooled separate accounts is determined by Voya based on the valuation of the underlying investments at the end of the year. Net asset value (NAV) per unit is used as a practical expedient for measuring fair value. Participant transactions (purchases and sales) may occur daily. Participants eligible to receive benefit payments may withdraw the value of their pooled separate accounts, in whole or in part, at any time without penalty. There are no participant redemption restrictions for these investments.

Interest-Bearing Cash - Valued at cost plus accrued interest, which approximates fair value.

Self-Directed Brokerage Accounts - Accounts primarily consist of mutual funds, common stocks, unit investment trusts, and money market funds that are valued on the basis of readily determinable market prices.

#### **Note 4 - Fully Benefit-Responsive Investment Contracts**

The Plan entered into a fully benefit-responsive investment contract with Standard Insurance Company (Standard). The contract was terminated in July 2024. The market value adjustment as a result of the termination was not material to the financial statements as a whole and did not limit the ability of the plan to transact at contract value with the participants.

Standard maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Standard was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by Standard but may not be less than 1%. The crediting rate was reviewed on a quarterly basis for resetting.

This contract met the fully benefit-responsive criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### **Note 5 - Certified Information**

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank and Voya Institutional Trust Company, qualified institutions. Effective June 25, 2024, the Plan changed its qualified institution from Charles Schwab Trust Bank to Voya Institutional Trust Company. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

#### **Note 6 - Tax Status**

The Company adopted a Voya Retirement Insurance and Annuity Company (Voya) pre-approved plan document. Voya received an approval letter from the IRS dated June 30, 2020, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### Note 8 - Party-in-Interest Transactions

Certain Plan investments are managed by Charles Schwab, Voya, and their affiliates. Charles Schwab and Voya are custodians for the Plan and, therefore, transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

#### Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
