### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Dustrol, Inc. ## **Note 1. Description of the Plan**

### ***General***

The following description of the Dustrol, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Dustrol, Inc. and its parent company, Recycling Enterprises, Inc. (collectively, the Company), for the benefit of its employees who have at least one year of service and are age 21 or older. DIRE Truck Parts, Inc., a wholly-owned subsidiary of Recycling Enterprises, Inc., is also a participating employer in the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Certain members of management serve as the trustees of the Plan. Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company serve as Plan custodians. Principal Global Investors Trust Company serves as trustee of the collective investment trusts.

### ***Contributions***

Participants may elect to make contributions to the Plan, as provided by the Plan Document, subject to the maximum allowable amount by the Internal Revenue Code. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company may contribute a discretionary matching amount to the Plan each year which is allocated to Plan participants based upon the elective deferrals of each participant. The Company may also contribute a discretionary profit sharing amount, as defined in the Plan Document. For the years ended December 31, 2024 and 2023, no matching or profit sharing contributions were made by the Company.

Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Participants may direct their accounts to be invested in any of the investment options offered by the Plan and may change the allocations daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation, which is increased by one percent each year to a maximum of six percent, and their contributions are invested in a designated balanced fund until changed by the participant. Effective January 1, 2025, newly eligible employees are automatically enrolled at four percent of eligible compensation and automatically enrolled participant's deferrals will be increased by one percent each year to a maximum of ten percent.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's matching contribution, if any, an allocation of the Company's profit sharing contribution, if any, plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is vested at a rate of 20 percent after two years of service and an additional 20 percent for each of the next four years, becoming fully vested after six years of continuous service.

To be credited with a year of service, the participant must have worked 1,000 hours during the Plan year.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance less outstanding notes. The notes receivable are secured by the balance in the participant's account and shall bear a reasonable rate of interest as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Participants may have only one note outstanding at any time. The notes may have a term of five years or less.

***Payment of Benefits***

Plan benefits are available to participants upon retirement, death, disability or termination of employment. Benefits are paid in a lump-sum amount equal to the value of the participant's vested account. In addition, participants may elect in-service distributions, including financial hardship distributions, as defined by the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, there are no forfeited nonvested accounts. These accounts are used to reduce future Company contributions, pay the administrative expenses of the Plan or may be reallocated to participants. No forfeitures were incurred or used during the year ended December 31, 2024 and 2023.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Pooled separate accounts are valued at estimated fair value as provided by Principal Life Insurance Company.

The Plan's interest in the collective investment trusts are valued based on information reported by the investment advisor using the audited financial statements of the collective investment trusts at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Company, if any, are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Loan processing fees and distribution fees are charged to the participants' accounts.

**Note 3. Certification of Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company (PLIC), Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, and PLIC on behalf of Principal Global Investor's Trust Company, collectively qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds, units of pooled separate accounts, and units of collective investment trusts managed by the custodians and trustee. Therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$85,955 and \$73,943 of recordkeeping fees to PLIC during 2024 and 2023, respectively. The Company provides certain administrative services at no costs to the Plan. The Company directly pays any other fees related to the Plan's operations.

#### **Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 7. Tax Status**

The Plan operates under a nonstandardized pre-approved profit-sharing plan document sponsored by Principal Life Insurance Company. This pre-approved plan document received an opinion letter from the IRS stating the form of the plan is acceptable under the appropriate section of the Internal Revenue Code (IRC). The Plan itself has not obtained or requested a determination letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan to recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through August 28, 2025, which is the date the financial statements were available to be issued.
