## Notes to Financial Statements

### Note 1. Description of Plan

The following description of the Martin Automatic, Inc. 401(k) Plan (Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan that covers employees of Martin Automatic, Inc. (the Company), with the exception of employees represented under a collective bargaining agreement, leased employees, non-resident aliens, and interns. To participate, employees must be at least 18 years of age and meet certain service requirements. Full-time employees must complete two months of service, and Part-time employees must complete a year of service, consisting of 1,000 hours. Eligible employees may enter the Plan on the first day of the month following their fulfillment of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may make pre-tax and Roth contributions, which, in the aggregate, may not exceed 80% of eligible compensation and are subject to certain Internal Revenue Code (IRC) limitations. Upon satisfying eligibility requirements, employees are automatically enrolled in the Plan and contribute 3% of compensation unless an alternate election is made. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company may make discretionary matching contributions. In 2024, the Company made matching contributions equal to 50% of each dollar a participant contributed, up to the first 6% of their eligible compensation.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund as investment options for participants.

**Participant Accounts:** Each participant's account is credited with the participant's contributions, Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in Company contributions (and earnings thereon) is based on years of service. Participants vest over a 5-year schedule: 0-1 year-0%; 2 years-25%; 3 years-50%; 4 years-75%; 5 years-100%.

A participant will become fully vested in the event of death or total and permanent disability.

### Note 1. Description of Plan (cont.)

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator at the inception of each loan. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits:** On termination of service due to death, disability, separation or retirement, a participant may elect to receive a lump-sum or installments equal to the value of the participant's vested interest in his or her account. In addition, in-service withdrawals are allowed after participants reach age 59 ½ or in cases of financial hardship.

The Plan has the ability to make automatic distributions without participant consent for terminated participants who fail to affirmatively elect a distribution and have a vested account balance under \$1,000.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$75 and \$3,024, respectively. These accounts will be used to reduce expenses or future Company contributions. Forfeited non-vested accounts totaling \$17,869 were used to pay eligible expenses during 2024.

**Plan Expense Account:** Effective January 1, 2024, excess amounts generated by revenue sharing agreements between the record keeper and the various mutual funds that the Plan invests in are deposited by the record keeper in an account that can be utilized to pay allowable plan expenses. On December 31, 2024 there was no balance in this account. During 2024, Plan expenses of \$39,094 were paid from the plan expense account

### Note 2. Summary of Accounting Policies

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition:** Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Note 2. Summary of Accounting Policies (cont.)

**Use of Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Excess Contributions Payable:** Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in February of 2025.

**Payment of Benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to withdrawals and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of the fair value of investments.

**Subsequent Events:** The Plan has evaluated subsequent events through September 2, 2025, the date the financial statements were issued.

### Note 3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### Note 3. Fair Value Measurement (cont.)

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company (the trustee of the Plan) and Matrix Trust Company (the former trustee of the Plan).

### **Note 5. Fully Benefit-Responsive Investment Contract**

The Plan has entered into a fully benefit-responsive contract (contract) with Transamerica Life Insurance Company (Transamerica). Investments in the contract are in the Transamerica Stable Value Ascend Fund (Fund). This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Transamerica maintains the contributions in a general account. The fund is credited with participant contributions, earnings on the underlying investments, and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at any time. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Interest rates for the contract are declared by Transamerica on a semi-annual basis and apply for a six-month period. Rates are determined at least 45 days prior to the effective date based on prevailing market conditions. Interest is credited using the daily equivalent of the applicable effective annual rate. There is no minimum guaranteed interest rate under the contract.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) removal of the Fund as an investment option, (2) layoffs, (3) termination of the contract by the Plan, (4) transfer of assets to a competing investment option or another provider, and (5) mergers. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### **Note 6. Related-Party Transactions and Party in Interest Transactions**

Transamerica Retirement Solutions provides recordkeeping services to the Plan. These transactions qualify as exempt party-in-interest transactions. Administrative expenses of \$14,693 were paid to Transamerica Retirement Solutions for the year ended December 31, 2024.

### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any Company contributions.

### Note 8. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
