## Independent Auditor's Report

To the Board of Directors of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Acme Truck Line 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Notes to Financial Statements

#### Note 1. Description of Plan

The following description of the Acme Truck Line 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all of the employees of Acme Truck Line, Inc. (the Company) who have 90 days of service and are age eighteen or older. The employees may join the Plan on the first day of the first quarter following completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

##### **Contributions**

Each year, participants may contribute to the Plan, as a percentage of eligible compensation, a minimum of 1% up to a maximum of 80% of pre-tax annual compensation, as defined in the Plan, up to the maximum allowable by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Any catch-up contributions made by participants will be taken into account in determining any employer matching contribution made to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who do not affirmatively elect not to participate in the Plan upon becoming eligible, will automatically have compensation deferred at 3%. Automatic deferral amounts will increase each plan year by 1% to a maximum of 6% of plan compensation.

The Plan also allows Roth contributions for all participants. A participant's Roth elective deferrals are separately accounted for, as are gains and losses attributed to those Roth elective deferrals.

The Company may contribute, at its discretion, a matching contribution to the Plan to be determined each contribution period by the Company. For the year ended December 31, 2024, this matching contribution was 50% of participant pre-tax contributions up to 3% of eligible gross compensation. Matching contributions totaled \$393,408 for the year ended December 31, 2024.

##### **Participant Accounts**

Participants direct the investment of their contributions and Company matching contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, and an allocation of plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

The benefit to which a participant is entitled is limited to the vested balance in the participant's account.

#### Note 1. Description of the Plan (Continued)

##### **Vesting**

Participants are immediately vested in their contributions and the actual earnings thereon. Vesting in the Company's discretionary matching contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after two years of credited service. Participants automatically become 100% vested in the Company's contributions and earnings thereon at normal retirement age, death, disability, or termination of the Plan.

##### **Notes Receivable from Participants**

Participants may borrow from their accounts an amount determined by the Plan Administrator, provided the loan, including accrued interest thereon, does not exceed 50% of the sum of the vested portion of the participant's account. The loans are secured by the balance of the participant's vested account and bear interest at variable rates. The participant loan is required to be at least \$1,000. The maximum number of outstanding loans per participant is one. Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

Distributions from plan assets are made upon the participant's death, disability, retirement, termination of service, or other circumstances, as described in the Plan Document. Upon termination, participants with a balance of \$7,000 (\$5,000 prior to March 2024) or less are immediately cashed out. Benefits attributable to employer contributions are not payable prior to separation from service. Optional forms of payment include lump sum and installment as permitted by the Plan Document. The participant also may elect to have the balance of the account roll over into another qualified retirement plan or into an IRA. After attainment of age 59½, withdrawals can be made from any of the participant's accounts under the Plan. Additionally, under certain circumstances, hardship withdrawals of the participant's deferral contributions are permitted.

##### **Forfeited Accounts**

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures can be used to reduce employer contributions and plan expenses. During 2024, employer contributions were reduced by \$100,683 from forfeited non-vested accounts. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$38,542 and \$38,202, respectively.

##### **Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination or partial termination of the Plan, or the complete discontinuance of contributions, the rights of all affected participants to their accrued benefits shall be fully vested and non-forfeitable.

#### Note 2. Summary of Significant Accounting Policies

##### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

##### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense when they are incurred and are charged directly to the participant's account. No credit allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are treated as distributions based upon the terms of the Plan Document.

##### **Contributions**

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### Administrative Expenses

Administrative expenses of the Plan may be paid by the Company or the Plan as provided in the Plan Document. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

##### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### Note 3. Information Certified by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (Empower), qualified institutions.

#### Note 4. Fair Value Measurements

The *Fair Value Measurement* Topic of the FASB Accounting Standards Codification (ASC) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1 Valuations based on unadjusted quoted prices in active markets for identical assets or liabilities as of the reporting date. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these securities does not entail a significant degree of judgment.
- Level 2 Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly, as of the reporting date.
- Level 3 Valuations based on inputs that are unobservable and include situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require significant management judgment or estimation.

In some instances, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such instances, an investment's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's measurements of fair value are made on a recurring basis. There have been no changes in the methodology used at December 31, 2024 and 2023. The valuation technique for assets and liabilities recorded at fair value is as follows:

*Pooled Separate Accounts:* Valued at the market value of the underlying investments as adjusted for the Plan's units of participation in the pooled account. Units are established for each investment division (sub-account) of the pooled separate account. The value of these units is determined at the close of the stock exchange each day and the exchange is open for regular trading. The values increase or decrease based on the investment performance of the corresponding underlying portfolios.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

##### **Investments Measured Using the Net Asset Value per Share Practical Expedient (Continued)**

- (a) This category is made up of conservative, moderate, and aggressive allocation funds, all seeking current income and capital appreciation. The funds invest in fixed income and equity funds. The degree of allocation in fixed income and equity funds varies, with the conservative funds investing a larger percentage in fixed income, and the aggressive funds investing a larger percentage in equity funds.
- (b) This category is made up of bond investment options which generally try to maximize current income while maintaining stability of principal. Strategies often invest in securities that pay a fixed rate of return or fixed dividend. This usually refers to securities such as bonds, money market instruments, or preferred stock issued by U.S. governments, state, and local governments, publicly held companies, banks, and savings and loans.
- (c) This category is made up of investment options that emphasize investments in stocks of multinational or global companies. The focus includes opportunities based on assets located outside the United States, including emerging markets.
- (d) This category is made up of investment options seeking to invest in shares of companies with a market capitalization value of more than \$10 billion.
- (e) This category is made up of investment options seeking to invest in shares of companies with relatively small market capitalization. Generally, these consist of companies with market capitalization between \$300 million and \$2 billion.
- (f) This category is made up of investment options in specialized markets. This includes healthcare, communications and information, real estate, gold and other minerals, and natural resources.
- (g) This category is made up of mutual funds that invest money across asset classes, including a mix of low to medium risk stocks and bonds seeking both income and capital appreciation.

#### Note 5. Investment Contract with Massachusetts Mutual Life Insurance Company

The Plan allows participants to invest in a traditional annuity contract in which the invested funds are held in an insurance company general account which supports insurance obligations. This option is the MassMutual Fixed Account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported in the Plan by Massachusetts Mutual Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### **Note 5. Investment Contract with Massachusetts Mutual Life Insurance Company (Continued)**

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The investment contract has a guarantee that the interest rate will not go below a floor rate, which is 1%. Such interest rate is reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan Document (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options; (3) bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations; (4) the failure of the Plan to qualify under 401(a) of the IRC or the failure of the trust to be tax exempt under Section 501(a) of the IRC; or (5) premature termination of the contract.

The Plan Administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, and a material amendment to the agreement without consent of the issuer.

#### **Note 6. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
