Notes to Financial Statements

NOTE 1 – PLAN DESCRIPTION

The following description of the Visalia Medical Clinic, Inc. 401(k) Profit Sharing Plan (the Plan), provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of the Plan's provisions.

General – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Visalia Medical Clinic, Inc. (the Company), and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as Plan administrator.

Eligibility – Employees of the Company are eligible to participate in salary deferrals and safe harbor nonelective contributions after 30 days of employment following their date of hire, and are eligible to receive safe harbor contributions upon reaching age 19 and after completing 30 days of service. Shareholders are eligible to participate in the profit sharing program after completing one year of service in which at least 1,000 hours are worked. Participants must complete at least 250 hours of service during the quarter and be employed on the last day of the Plan quarter to be eligible to receive any employer profit sharing contributions, unless terminated in the event of death, disability, or retirement.

Contributions

Participant contributions – Participants may elect to contribute up to 100% of eligible compensation to the Plan each year subject to a maximum of the Internal Revenue Service's annual Section 402(g) limit. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer profit sharing contributions – The Company may elect to make discretionary profit sharing contributions to the Plan. Profit sharing contributions are initially allocated to participants on a percentage of covered compensation ranging from 0% to 8% based on certain physician specialties. The Plan's profit sharing percentage is determined individually for each participant. Any remaining unallocated profit sharing contribution is allocated to eligible participants in the ratio of their covered compensation to total covered compensation. The profit sharing contribution for the year ended December 31, 2024, was \$166,992.

Employer safe harbor nonelective contributions – The Company makes safe harbor nonelective contributions to the Plan equal to 4% of the participant's eligible compensation, regardless of the employee's hours of service or employment on the last day of the Plan year. The nonelective contribution is made at the end of each quarter of the Plan year. The safe harbor contribution for the year ended December 31, 2024, was \$1,281,041.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contribution and Company safe harbor contributions as well as allocations of: (1) the Company's profit sharing contributions, and (2) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions and the Company's safe harbor contributions, plus actual earnings thereon. Vesting in the Company's profit sharing contributions, plus earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credited service.

Visalia Medical Clinic, Inc. 401(k) Profit Sharing Plan Notes to Financial Statements

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to 50% of the participant's vested accounts, but not in excess of \$50,000. Loans are secured by the balance of the participant's account and bear fixed, reasonable rates of interest, as determined by the Plan administrator. The maximum loan term is five years unless the loan term qualifies as a home loan, in which case longer repayment terms are available. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rate of interest on all outstanding loans ranged from 4.25% to 9.50% with various maturities through May 2032.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account balance, an annuity insurance contract, or annual installments not extending beyond the life expectancy of the participant or the joint life and last survivor expectancy of such participant and such participant's designated beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures – Forfeitures are the nonvested portion of a participant's account that are lost on termination of employment. Forfeitures are retained in the Plan and will first be used to pay Plan administrative expenses and then to reduce future employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation – Investments are stated at fair value as certified by the Plan's custodian, Matrix Trust Company (Matrix Trust). If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Cash equivalents – Investments in cash equivalents are not valued at fair value, but instead are valued and face value.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance, plus accrued but unpaid interest, and are classified as notes receivable. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits – Benefits are recorded when paid.

Expenses – Administrative expenses and transaction fees are primarily paid by the Plan. The Company provides certain accounting and administrative services for which no fees are charged. Remaining Plan expenses are allocated among participants based on the fair value of investments held.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through August 28, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Visalia Medical Clinic, Inc. 401(k) Profit Sharing Plan Notes to Financial Statements

Following are descriptions of the valuation methodologies used for assets measured at fair value.

Registered investment companies (mutual funds) and money market funds – Shares of registered investment company funds (or mutual funds) are valued at the net asset value (NAV) of shares held by the Plan and are valued at the closing price reported on the active market on which the individual securities are traded.

Common stock – Valued at the closing price reported on the active market on which the individual securities are traded.

Collective trust fund – Units held in a collective trust (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. One of the investment holdings in the Plan is the Wells Fargo Stable Value Fund C (the Fund).

The NAV practical expedient of the Fund is determined daily. Units are issued and redeemed at the latest net asset value. The use of NAV practical expedient as fair value is deemed appropriate as the Fund does not have a finite life, unfunded commitments, or significant restrictions on redemptions.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – TAX STATUS

The plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. It is reasonably possible that, given the level of risk associated with investment securities, changes in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

NOTE 6 – CERTIFIED INVESTMENT INFORMATION BY THE CUSTODIAN

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, and interest and dividends reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

- Investments reflected on the Schedule of Assets as of December 31, 2024.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Matrix Trust holds certain pending investments as cash. Matrix Trust is the Plan custodian and, therefore, these pending investment transactions qualify as party-in-interest transactions. The balances in this cash account at December 31, 2024 and 2023, totaled \$1,545 and \$64,657, respectively.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
