INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Plan Participants
Popli, Architecture + Engineering & L.S., D.P.C. Savings and Investment Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Popli, Architecture + Engineering & L.S., D.P.C. Savings and Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Popli, Architecture + Engineering Savings and Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Popli, Architecture + Engineering & L.S., D.P.C. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTE A: DESCRIPTION OF THE PLAN

The following description of the Popli, Architecture + Engineering & L.S., D.P.C. Savings and Investment Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Popli, Architecture + Engineering & L.S., D.P.C. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was effective on January 1, 1986, and was amended and restated as of January 1, 2021. Employees of the Company must be at least 21 years of age to be eligible to participate in the Plan.

Contributions

Eligible participants are entitled to defer up to the maximum amount or percentage allowed of their annual compensation, as defined in the Plan, as a qualified pre-tax contribution subject to the maximum annual dollar contribution restrictions of ERISA and the Internal Revenue Service. Effective January 1, 2025, the Plan was amended to allow participants to make Roth deferrals and participants may elect to convert all or any portion of their vested account balance, excluding any outstanding loan amount, to an In-Plan Roth Conversion Account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make a discretionary matching contribution in an amount equal to either a percentage of compensation or a dollar amount as it directly relates to elective deferrals made during the year by eligible participants. The Company also has the option of making a discretionary profit-sharing contribution and discretionary qualified nonelective employer contribution to the Plan. Employees are eligible to receive the discretionary matching, profit sharing, and qualified nonelective contributions upon completing at least 1,000 hours of service during the Plan year and are employed on the last day of the Plan Year. Effective January 1, 2025, the Plan was amended whereby employees are eligible to receive the discretionary matching, profit sharing, and qualified nonelective contributions upon completing the earlier of at least 500 hours of service during the first six months of employment or the completion of a year of service and are employed on the last day of the Plan Year. The Plan includes a Qualified Automatic Contribution Arrangement (QACA) Safe Harbor provision. This provision includes an automatic deferral feature, where the Company will automatically withhold 3% of compensation, unless an alternative deferral amount is elected, from eligible employees as a salary deferral to the Plan. The automatic deferral rate will increase by 1% each year up to a maximum of 6%. The Company will make safe harbor matching contributions of 100% of salary deferrals up to 1% of compensation plus 50% matching contributions on salary deferrals above 1% up to 6% of compensation.

Participants direct the investment of contributions into various investment options offered by the Plan. Participants may change their investment allocation on a daily basis.

Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s discretionary match, (b) the Company’s discretionary profit-sharing contribution, (c) plan earnings, and (d) charged an allocation of investment and administrative expenses. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes receivable from participants

Notes receivable from participants are measured and valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Participants are permitted to borrow up to 50% of the vested balance in their plan account, up to a maximum of \$50,000. The notes are payable over terms up to five years (longer if for the purchase of a principal residence) and bear interest at a fixed rate. The fixed interest rate is derived from the prime rate of interest at origination. Principal and interest payments on the notes are redeposited into the participants' accounts based on their current investment allocation elections. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits

Upon termination of service due to death, disability, or retirement, benefits may be paid in a lump-sum amount in the form of cash or direct rollover, a partial rollover, or installment payments, payable monthly, quarterly, or annually. Vested account balances that are less than \$1,000 upon separation of service will be paid in one lump-sum distribution in accordance with the provisions of the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become vested in Company contributions plus actual earnings thereon based on years of continuous service. A participant receives credit for a year of service if they complete at least 1,000 hours of service during the plan year. Participants vest in employer contributions on a graduated basis for each year of service. Participants are fully vested in employer discretionary matching contributions and employer discretionary profit sharing contributions after six years of service. Participants are fully vested in employer safe harbor matching contributions after two years of service. Participants are immediately vested in employer discretionary qualified matching contributions.

Forfeited amounts

Any forfeitures arising under the Plan are first used to pay the administrative expenses under the Plan and then to reduce the Company's contributions to the Plan. There was \$63,000 in forfeitures utilized for the year ended December 31, 2023. There were no forfeitures utilized for the year ended December 31, 2024. As of December 31, 2024 and 2023, \$56,369 and \$24,434, respectively, was held in the plan as forfeited amounts.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Historical cost is used to determine the net appreciation of investments, as reported by the Plan's custodians.

Concentration of credit risk

The Plan invests in certain money market funds which are not insured or guaranteed by the Federal Deposit Insurance Corporation ("FDIC") or any other government agency. Although the money market funds seek to preserve the value of the Plan's investment at \$1 per share, they are exposed to various risks, such as interest rate, market and credit risk, and it is at least reasonably possible that changes in risk could affect the Plan.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits. Participant loan fees are allocated to the respective participant's account.

Payment of benefits

Benefits are recorded when paid.

Use of estimates in the preparation of financial statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through August 28, 2025, which is the date the financial statements are available to be issued. See Note A.

NOTE D: FAIR VALUE MEASUREMENTS

Accounting principles establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 Measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Fair value equals cost.

Mutual funds: Valued at the closing price reported on the active market on which the individual funds are traded.

Exchange traded funds: Exchange traded funds are valued at quoted market prices from a national securities exchange.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E: TAX STATUS

The Internal Revenue Service has determined and informed the Plan applicant by a letter dated June 30, 2020, that the Pre-approved Defined Contribution Plan under which the Plan was adopted, as then designed, was in compliance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified, and the related trust is exempt from taxation as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company, as the plan sponsor, has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would immediately be 100% vested in their accounts.

NOTE G: TRANSACTIONS WITH PARTIES-IN-INTEREST

In 2024 and 2023, certain plan investments are managed by Matrix Trust Company, the custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

Investments in notes receivable from participants are considered parties-in-interest transactions.

As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE H: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
