### **Trustees and Plan Administrator Mahlum Architects, Inc. Retirement Plan**

#### ***Scope and Nature of ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the accompanying financial statements of Mahlum Architects, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***1. Description of Plan***

The following description of the Mahlum Architects, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Mahlum Architects, Inc. (the Employer) who are 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Administrative Committee maintained by the Employer is the Plan's administrator and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Employer is the Plan's sponsor. Certain members of the Plan's Administrative Committee have been designated as the trustees of the Plan. The Plan's third party administrator is Northwest Plan Services, Inc. The Plan's custodian is Matrix Trust Company.

#### ***Employee Contributions***

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined by the Plan. Participants may elect to categorize a portion or all of their contribution under the Plan's Roth deferral feature. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants can request a withdrawal of their automatic contributions if applied within 90 days of the first automatic deferral. Participant salary deferral contributions are funded to the Plan following each pay date. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers).

#### ***Employer Contributions***

The Employer may elect, at its discretion, to make matching or profit sharing contributions to the Plan. Employees are eligible for the Employer's contributions on the first day of the month following attainment of age 21. In addition, employees must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to be eligible to receive the profit sharing contribution. During 2024, the Employer matched 50% of each participant's contributions (excluding rollover contributions); up to 3% of each participant's eligible compensation. Matching contributions are determined on a plan year basis but are funded to the Plan by the Employer following each pay date. During 2024, the Employer elected to make a profit sharing contribution, which was funded subsequent to year end.

#### ***1. Description of Plan, continued***

##### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as an allocation of the Employer's profit sharing contributions, if any, and plan earnings. Participants direct the investment of their account balances into various investment options offered by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions and/or statuses, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are vested immediately in their contributions and employer matching contributions plus actual earnings thereon. Vesting in the Employer's profit sharing portion of their accounts is based on years of continuous service. Vesting is on a graded schedule with the participant being fully vested after six years of service. In the event a participant reaches the Plan's normal retirement age (65), becomes disabled or deceased while employed by the Employer, the participant's account will become fully vested.

##### ***Notes Receivable from Participants***

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at a reasonable interest rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

##### ***Payment of Benefits***

On termination of service, a participant or their beneficiary with vested benefits of \$7,000 or less will be paid out as a lump-sum distribution. Vested benefits larger than \$7,000 will be distributed either in a lump-sum or installment payments (monthly, quarterly, or annually) over a fixed reasonable period of time. Distributions may also be made in installments to comply with minimum distribution rules required by the Internal Revenue Code (The Code). The Plan permits in-service withdrawals to participants meeting certain requirements, including distributions for financial hardship. Furthermore, a participant may withdraw the portion of their vested account resulting from rollover contributions at any time.

##### ***Forfeited Accounts***

Forfeitures of the non-vested portion of terminated participants' accounts are maintained in a separate account and can be used to pay administrative expenses or reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$30,808 and \$26,277, respectively. During 2024, employer contributions totaling \$35,490 were funded from forfeited non-vested accounts.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year as well as those held at year end.

### ***Contributions***

Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation and contributions from the Employer are recorded in the year in which the participant compensation is earned.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### ***Benefit Payments***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and for distributions are included in administrative expenses. Fees related to investment advisory, custodial, administration, and recordkeeping services are charged to participant accounts based on the participant's proportional share of the Plan's assets and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### **Subsequent Events**

The Plan has evaluated subsequent events were identified through August 19, 2025, the date the financial statements were available to be issued.

#### **3. Certified Information**

Certain information related to investments and cash disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the custodian of the Plan).

#### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are (unadjusted) quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### ***4. Fair Value Measurements, continued***

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Collective Trust Funds:** Valued at the fund's per unit NAV provided by the fund's custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The redemption frequency for participant transactions (purchases and sales) in the collective trust fund occurs daily.
  - **Columbia Trust Stable Income I-0:** Were the Plan to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments in this fund.
  - **Flexpath Large Cap Growth R1 and MFS Mid Cap Growth 2W:** Advance written notice of 5 business days is required for any withdrawal exceeding \$1,000,000. Were the Plan to initiate a full redemption of the fund, thirty-days written notice is required. There are no unfunded commitments in these funds.

#### 5. Related-Party and Party-In-Interest Transactions

Notes receivable from participants held by the Plan are party-in-interest transactions under ERISA. In addition, expenses paid by the Plan are to parties-in-interest as defined by ERISA.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer profit sharing contributions.

#### **7. Tax Status**

The Employer has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Code. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts as reported in the financial statements.

#### **9. Reconciliation of Financial Statements to Form 5500**

Amounts allocated to withdrawing participants are recorded on the Form 5500 for benefit claims that have been processed and approved for payment prior to year-end, but not yet paid as of that date. These claims are not recorded by the Plan's financial statements until the year paid.
