Opinion

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of Power House Plastering Employee Stock Ownership Plan (the “Plan”) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

Power House Plastering (the “Sponsor”) established the Plan, with an effective date of January 1, 2013, as a defined contribution employee stock ownership plan. The primary purpose of the Plan is to enable participants to acquire a proprietary interest in the Sponsor. The Plan agreement was written to comply with the requirements of the Employee Retirement Income Security Act of 1974 and the provisions of the Tax Reform Act of 1986.

**Eligibility**

Each employee is eligible to participate in the Plan coinciding with the following date on which 1 year of service has been completed measured from the employee’s commencement date. Enrollment dates semiannual on January and July 1<sup>st</sup>. A year of service is defined as 12 consecutive months of employment with at least 1,000 hours of service, measured from the employee’s employment commencement date. An employee who leaves the service of the employer before completing 1,000 hours of service will not forfeit any previous hours of service for the purposes of eligibility.

**Contributions**

Contributions shall be made to the Plan in such amounts as may be determined by the Sponsor’s Administrative Committee, provided that such contributions do not exceed the maximum amounts deductible under Section 404(a)(3). Contributions may be paid in cash or shares of Sponsor stock as determined by the Plan’s Board of Directors. Shares of Sponsor stock will be valued at their then fair market value. For the year ending December 31, 2024, the employer did not make any cash contributions to the Plan.

**Participant accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited with allocations of the Sponsor’s contribution up to the lesser of a maximum of \$58,000 for 2024 or the participant’s annual compensation. Allocations are based on participant gross compensation as a percentage of total employee compensation paid by the Sponsor. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

**Vesting**

Vesting for elective employer contributions are based on years of continuous service. A participant is generally 100% vested after six years of service.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

**Put Option**

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradeable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Sponsor buy shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock.

**Distribution of Benefits**

The form of distribution upon termination of employment depends upon the vested account balance. Payments exceeding \$2,500 are paid in equal annual installments over a five-year period, while payments under that amount are paid as a lump sum.

**Voting Rights**

All Sponsor stock held by the Plan shall be voted by the plan administrator in accordance with instructions from the Plan Committee. Notwithstanding the foregoing, participants and/or beneficiaries shall be entitled to direct the Trustee as to the voting of any voting shares of Sponsor stock allocated to their Sponsor stock accounts with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all the assets of a trade or business, or other similar transactions prescribed by regulation.

**Forfeitures**

Forfeitures shall be charged first against a participant's other investments account, second against Sponsor stock which was not acquired with the proceeds of a Securities Acquisition Loan, and third against Sponsor stock acquired with a Securities Acquisition Loan. In addition, previously forfeited amounts related to participants who are subsequently rehired are reinstated. For the year ended December 31, 2024, \$64,620 in cash forfeitures and \$79,694 in stock forfeitures was reallocated to participants.

**Plan Expenses**

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Sponsor. The Sponsor has historically paid the operating expenses for the Plan.

**Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Sponsor common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution, unless eligible for floor price protection, in which case, shares are distributed. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The fair value of the Sponsor's common stock shares is considered to be a significant estimate.

**Investment Valuation and Income Recognition**

The shares of the Company common stock are reported at fair value, based upon an independent appraisal. As of December 31, 2024, the Plan held 48,000 shares of Sponsor common stock with a cost of \$6,120,000 and an estimated fair value of \$6,628,800.

The net income or loss of the Plan will be determined annually as of each anniversary date. Any stock dividends on shares of Sponsor stock held by the Plan shall be allocated to each participant's account in the ratio in which the cumulative number of shares allocated to the participant's account as of the preceding anniversary date bears to the total cumulative number of shares of Sponsor stock allocated to the accounts of all participants as of that date. For the year ended December 31, 2024, the Plan received \$0 in stock dividends and \$0 in contributions from the Sponsor.

**Payment of Benefits**

Benefits are recorded when payable.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 – TAX STATUS**

The IRS has determined and informed the Sponsor by a letter dated February 9, 2015 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the plan's financial statements. Also, members of the Plan are not subject to taxes on either the Plan income or the employer's contributions until such time a distribution is made.

The Plan is no longer subject to potential income tax examinations by tax authorities for years for which the statute of limitations has expired.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Employer Securities: The fair value of the Sponsor’s common stock was determined by an independent appraisal. This appraisal was based upon a combination of the Capitalization of Earnings Method, Discounted Cash Flow Method, and the Guideline Merger and Acquisition Method. The appraiser took into account historical and projected cash flow and market comparables. Unobservable inputs used in the valuation of the Sponsor’s common stock include earnings before interest, taxes, and amortization, net income, weighted average cost of capital, discount rate, discount for lack of marketability, and discount for lack of control.

US Government Securities: Cash related values are valued at cost plus accrued interest, which approximates value. US Treasury Notes are valued at quoted market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – RISKS AND UNCERTAINTIES**

The Plan invests in stock equity of the Sponsor. Equity securities of the Sponsor are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 – PRIORITIES UPON TERMINATION**

Although the Sponsor has established the Plan with the bona fide intention and expectation that it will be maintained indefinitely, nevertheless, the Sponsor is not under any obligation or liability to continue the Plan for any given length of time. The Sponsor may in its sole discretion discontinue or terminate the Plan in whole or in part in accordance with its provisions at any time without any liability for such discontinuance or termination. In the event the Plan terminates, no further contributions will be made to the Plan and all amounts credited to the participants' accounts will continue to be vested in accordance with the Plan agreement. The Sponsor will direct the distribution of the participants' accounts in a manner permitted by the Plan as soon as practicable.

**NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

At times, the Plan pays administrative expenses to service providers. In addition, the Plan Sponsor may, at times, pay Plan expenses as described in Note 2. These are considered to be parties in interest; however, the transactions with these parties are exempt from the prohibited transaction rules of ERISA.
