SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed an audit of the financial statements of Macon Community Hospital 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

OPINION

In our opinion, based on our audits and on procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

BASIS FOR OPINION

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of Macon Community Hospital 403(b) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan, covering substantially all eligible employees of Macon Hospital, Inc. (the "Employer"). The Employer is a non-profit organization as determined by Section 501(c)(3) of the Internal Revenue Code (the "IRC"). Therefore, the Plan is subject to the provisions governing 403(b) plans of the Employee Retirement Income Security Act of 1974 ("ERISA"). The purpose of the Plan is to provide retirement benefits for participants and their beneficiaries. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees, excluding employees who work less than 20 hours per week, are eligible to participate in the Plan beginning immediately upon hire for purposes of making elective deferrals, as defined in the plan document.

Participants are eligible for Employer matching contributions on the first day of the plan year quarter following the participant's completion of one year of service (1,000 hours) as defined in the plan document.

Participants are eligible for Employer nonelective contributions as of the first day of the plan year quarter following the participant's completion of one year of service. No such Employer nonelective contributions were made for the year ended December 31, 2024.

Contributions

Each year, participants may elect to defer up to 100% of their compensation, as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified plans. Participants may change their salary deferral percentage at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Employer matching contributions are allowed under the Plan, and are calculated using a discretionary rate as determined by management. The matching rate was 3% in both 2024 and 2023.

Contributions are subject to certain limitations in accordance with applicable regulatory requirements.

Participant accounts

Each participant's account is credited with the participant's contributions, allocations of Employer contributions and plan earnings, and reduced by an allocation of administrative expenses, any distributions and plan losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in Employer contributions is based on years of continuous service. Participants vest 20% ratably over two to six years, resulting in 100% vesting after six years of credited service, as defined in the plan document. Participants are also 100% vested upon reaching the Plan's normal retirement (age 65), or upon their death or disability.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at a rate as determined by the Plan Administrator. Loan terms are for a maximum of 5 years, or longer if used for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, all outstanding loans had interest rates between 5.25% and 10.50%.

Payment of benefits

Benefit distributions equal to a participant's vested account balance are payable to the participant or their beneficiaries upon normal retirement, death, disability or termination of employment. The method of distribution shall be determined by the Plan Administrator in accordance with the provisions of the Plan.

In-service withdrawals

In-service withdrawals are permitted by participants who have reached the age of 59 and 1/2. Earlier withdrawals may also be made in the case of financial hardship, as determined by the Employer.

Forfeitures

Forfeitures result from termination of employment under circumstances which do not entitle the participant to be fully vested in his Employer contributions and are available to be used to reduce Employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited accounts totaled \$7,084 and \$7,728, respectively. Forfeitures of \$4,373 were used to pay Plan expenses during 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the Custodians. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measure of that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses as incurred.

No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefit payments are recognized in the year paid.

Expenses

The Plan is responsible for its administrative expenses unless paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Events occurring after reporting date

The Plan has evaluated events and transactions that occurred between December 31, 2024 and July 22, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN

Except for the fair value of the investment contracts, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified by American United Life Insurance Company ("One America") and Empower Annuity Insurance Company of America and Empower Trust Company, LLC ("Empower"), the Custodians of the Plan. Effective September 15, 2022, participants were given the option of transferring their assets to One America or remaining with Empower, however, all incoming funds into the Plan after this date are deposited with One America. The contract value of the investment contracts were certified by the Custodians.

NOTE 4 - FAIR VALUE

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using unadjusted quoted prices from active markets for identical assets), Level 2 (not traded on an active market, but for which observable market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value:

Nonfully benefit-responsive investment contract	Valued at fair value by Empower by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. See Note 6.
Pooled separate accounts	Valued based on net asset value (NAV), which is determined daily, of the units of participation in the account held by the Plan. On a daily basis, the units of participation are revalued to reflect the performance of the underlying mutual funds less any fees and charges. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no participant redemption restrictions for these investments; the notice period is applicable only to the Plan. If the Plan initiates a full redemption of the account, the issuer reserves the right to require 30 days notification in order to ensure that security liquidations will be carried out in an orderly business manner.

The description of the significant investment strategies for each category of investment in the pooled separate accounts follows:

- (a) These funds seek current income along with preservation of capital. They invest primarily in investment-grade, publicly traded debt securities which include bonds issued by the U.S. Government, its agencies, and U.S. corporations.
- (b) These funds seek long-term growth of capital with investments in common stocks of companies with medium market capitalization.
- (c) These funds seek capital appreciation by investing in growth stocks issued by companies with small-sized market capitalization believed to possess growth potential.
- (d) This category seeks to provide long-term capital appreciation primarily through investing in stocks of companies located outside of the United States. Stocks selected are believed to possess above-average growth potential.

- (e) These funds seek current income and capital appreciation appropriate for the asset allocation associated with the target retirement dates. As the target retirement dates approaches, the funds moves toward preservation of capital and production of income.
- (f) These funds invest in a mix of equity funds and fixed funds to achieve a specific proportion of asset classes or to vary the composition in response to changes in the economy and investment markets. They seek a mix of current income and capital appreciation.
- (g) These funds seek capital appreciation by investing in growth stocks issued by companies with large-sized market capitalization believed to possess growth potential.
- (h) This fund seeks current income to the extent consistent with maintenance of liquidity, investment quality and stability of capital.

NOTE 5 - INVESTMENTS AT CONTRACT VALUE

The Plan holds investment contracts that meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. The following represents the disaggregation of contract value between types of investment contracts held by the Plan:

With traditional investment contracts, the Plan owns only the contract itself; the underlying assets are owned by the contract issuer. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers. The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuers are contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan.

The crediting rate for the Empower Daily Interest Guarantee Fund is based on a formula established by the contract issuer but may not be less than 3.00%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The credited interest rate at December 31, 2024 and 2023 was 4.00%.

The crediting rate for the AUL Stable Value Account is based on a formula established by the contract issuer but may not be less than 0.00%. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date. The credited interest rate at December 31, 2024 and 2023 was 1.50% and 1.25%, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investments contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Such events include the following: (1) amendments to the Plan Documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the custodian to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligations under the contract, (3) a material misrepresentation or (4) a material amendment to the agreements without the consent of the issuer.

NOTE 6 - NONFULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan invests in an investment contract with Empower Annuity Insurance Company of America that is non-fully benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The credited interest rate may not be less than as stated in the Plan's contract and is based on a formula agreed upon by the issuer. Such rates are reviewed and may be reset on a quarterly basis.

Nonfully benefit-responsive investment contracts are required to be reported at fair value, and accordingly, an adjustment from contract value to fair value has been made in the accompanying financial statements.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in investment securities which are exposed to various risks, such as interest rate, credit and overall market risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

At December 31, 2024 and 2023, the Plan had a concentration of investments in three funds which represented approximately 34% and 33%, respectively, of total investments.

NOTE 8 - INCOME TAX STATUS

The Plan has adopted a volume submitter plan document (Volume Submitter). The Volume Submitter received its latest opinion letter on November 22, 2017, in which the Internal Revenue Service ("IRS") stated the Volume Submitter, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has not applied for a separate determination letter.

The Volume Submitter has been amended and restated since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan and Volume Submitter are designed and have been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been provided in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

NOTE 9 - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Plan investments are held by the Custodian, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, rather than a direct payment.

These party-in-interest transactions are exempt from the prohibited transactions provisions of ERISA and the IRC.

NOTE 10 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
