NOTE A – DESCRIPTION OF PLAN

The following description of the Wadsworth Brothers Construction Company, Inc. (“Company”) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General.* The Plan is a defined contribution plan covering all employees of the company other than those covered by a collective bargaining agreement. It is subject to the provisions of the Employee Retirement Income Act of 1974 (ERISA). Effective October 1, 2019 the plan was amended from trustee directed investing to participant directed investing. Since full transition of investments, all investments are held in individual participant accounts with a registered investment company.

*Contributions.* The Company may, in its sole discretion, make profit sharing contributions to the plan in an amount necessary to meet the Company’s requirements under an applicable prevailing wage statute. The amount that may be contributed for a participant in any year is limited to IRS regulations. Participant contributions are not permitted by the plan.

*Participant Accounts.* Each participant’s account is credited with (a) the Company’s contribution, and, (b) earnings from the participant selected investments in the individual participant account, beginning on October 1, 2019, and for periods prior to that date plan earnings (losses), and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined; allocations are no longer required under the participant directed model. The benefit to which a participant is entitled is the benefit that can be provided from the participants’ vested account.

*Vesting.* Participants are immediately 100% vested in their accounts.

*Payments of Benefits.* On termination of service due to death, disability, retirement, or termination of service due to other reasons, a participant may elect to receive an amount equal to the value of the participants accounts in either a lump-sum amount, or in annual, quarterly, or more frequent installments.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

*Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The plan's investments are stated at fair value. If available, quoted market prices are used to value investments. Many factors are considered in arriving at fair value. In general, however, corporate bonds are valued based on yields currently available on comparable securities of issuers with similar credit ratings. Investments in certain restricted common stocks are valued at the quoted market price of the issuer's unrestricted common stock less an appropriate discount. If a quoted market price for unrestricted common stock of the issuer is not available, restricted common stocks are valued at a multiple of current earnings less an appropriate discount. The multiple chosen is consistent with multiples of similar companies based on current market prices. Certificates of deposit are valued based on amortized cost or original cost, plus accrued interest.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. When certain Plan expenses are reimbursed by the Company, the Trustee allocates amounts to participant accounts and reports those amounts as negative administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses of the plan are allocated to participant accounts, whether positive or negative.

*Reclassification of Prior Year Investment Income*

Prior year amounts included in Net investment income (loss) as presented in the Statements of Changes in Net Assets Available for Benefits have been reclassified to conform to the current year presentation. No change was made to the total net investment income.

*Date of Management's Review*

Subsequent events were evaluated through September 3, 2025, which is the date the financial statements were available to be issued.

**NOTE C – FAIR VALUE MEASUREMENT**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 were not available. There are no plan assets requiring the use of Level 2, or Level 3 inputs for the periods presented.

*Level 1 Fair Value Measurements*

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 and 2023 are reported in net appreciation in fair value of investments.

**NOTE D – INVESTMENTS**

**NOTE E – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE F – TAX STATUS**

The Internal Revenue Service has determined and informed the Company effective January 1, 1992, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). On May 5, 2011 the Internal Revenue Service issued a favorable determination letter with respect to the continued qualification of the Plan. The determination letter was applicable for plan amendments executed on December 30, 2009 and December 30, 2008. A plan amendment, effective October 1, 2019, was covered under a favorable determination letter issued to the plan Trustee for a Volume Submitter Profit Sharing Plan With CODA, which letter was dated March 31, 2014. The most recent plan amendment, effective June 21, 2021, was covered under a favorable determination letter issued to the plan Trustee for a Non-Standardized Pre-Approved Profit Sharing Plan With CODA, which letter was dated June 30, 2020.

**NOTE G – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
