

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Yoke's Health & Welfare Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established by Yoke's Foods, Inc. (the Company) to provide health and other benefits to eligible employees of the Company and covered dependents. The Plan self-funds certain benefits provided and to comply with the provisions under the Affordable Care Act (ACA). Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Permanent employees of the Company who meet the eligibility requirements, including length of service and minimum hours, may participate in the benefits provided by the Plan. In general, all employees scheduled to work at least 30 hours per week on a regular basis are eligible to participate after a 60-day waiting period.

**Contributions**

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium costs. The Company pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop-loss insurance.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

**Benefits**

The Plan provides benefits after two months of employment for full-time employees. The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short- and long-term disability benefits, accidental death and dismemberment benefits, and an employee assistance program to eligible members and to their beneficiaries and dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Plan also includes a Health Savings Account (HSA) component plan. The HSA is funded through Company and employee contributions. The HSA allows eligible participants to be paid or reimbursed tax free for qualified medical expenses. It may also be used for future expenses or nonhealth purposes (on a taxable basis), or it can be withdrawn at age 65 as supplemental retirement income. Participants own their accounts and are responsible for substantiating distributions from their HSA accounts. The contributions from the Company and employees are recorded as both income and expense in the statements of changes in benefit obligations and net assets available for benefits.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Insured Benefits**

The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), long-term and short-term disability benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance programs are paid to the insurance company from the general assets of the Company. Premiums for all other insured benefits are paid from the assets of the VEBA trust.

**Stop Loss Coverage**

The Company maintains a stop-loss insurance policy with a third party that caps the Company's liability for individual claims at \$300,000 and an aggregate limit of \$1,000,000. The policy is in the Company's name and all proceeds paid under it are paid directly to the Company, thus the stop-loss insurance policy and any proceeds are not recorded in the Plan's financial statements.

**Self-Insured Benefits**

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and then are reimbursed by either the Plan's VEBA trust or the general assets of the Company. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Concentration of Credit Risk**

Cash is maintained in deposit accounts which at times may exceed federally insured limits. No losses in such accounts have been experienced or are expected.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Administrative Expenses**

The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party claims administrator. These expenses are reported on the statement of changes in benefit obligations and net assets available for benefits as Administrative Expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

**Payment of Benefits**

Claim payments are recorded when paid by the Plan. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statements of benefit obligations and net assets available for benefits.

Premiums paid either by the Company or VEBA trust are recorded as premium payments in the accompanying the statement of changes in benefit obligations and net assets available for benefits.

**Prescription Rebates**

Prescription rebates are contractually due to the Plan Sponsor. The Plan Sponsor contributes necessary funds to cover claims expenses as needed, thus prescription rebates are not recorded in the Plan's financial statements.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure as of August 28, 2025, the date the financial statements were available to be issued.

**NOTE 3 BENEFIT OBLIGATIONS**

The Plan "self funds" the majority of the benefits provided to participants but insures life, accidental death and dismemberment, and long-term disability benefits. As of December 31, there are many self-funded claims that have been incurred on which benefit payments will be made subsequent to that date. The liability for claims payable at December 31, 2024 and 2023 was estimated based on actual claims adjudicated prior to December 31 but paid after December 31. The estimated liability for claims incurred but unreported (IBNR) at December 31, 2024 and 2023 was estimated by Plan management using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan.

The Plan's deficiency of net assets over benefit obligations will be funded through future increases in employee and employer contributions.

**NOTE 4 FEDERAL TAX STATUS**

The trust is not exempt from federal income taxes and is annually required to file a Form 1041. The trust does not have activity that would generate taxable income and therefore no taxes are recorded.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE 6 PARTY-IN-INTEREST TRANSACTIONS**

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

**NOTE 7 RISKS AND UNCERTAINTIES**

The liability for claims IBNR was estimated using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
