## INDEPENDENT AUDITORS' REPORT

To the Plan Participants  
Carriage Services 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Carriage Services 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. DESCRIPTION OF PLAN**

The following description of the Carriage Services 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of Plan provisions.

**General**

The Plan was established, effective March 19, 1993, as a defined contribution plan covering all employees of Carriage Services, Inc. and its subsidiaries (the Company), with the exception of employees subject to a collective bargaining agreement, nonresident aliens and reclassified employees, as defined. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration**

The Plan is administered by the Company and, accordingly, certain administrative functions are performed by officers or employees of the Company. No officers or employees receive compensation from the Plan.

Empower Trust Company, LLC serves as trustee of the Plan and Empower Retirement, LLC serves as the recordkeeper.

**Eligibility**

An employee is eligible to participate in the Plan upon completion of 30 days of service and attainment of 18 years of age. Enrollment of eligible participants occurs on the first day of each month following the date the participant completes the eligibility requirements.

**Automatic Enrollment**

Employees who are eligible to participate in the Plan are automatically enrolled in the Plan and deemed to have elected a deferral rate of 3% of their pretax annual compensation, increased by 1% as of the first of each subsequent Plan year until a deferral rate of 10% is reached, unless the employee affirmatively elects not to participate or elects a different deferral rate.

**Contributions**

Participants may contribute up to 92% of their annual compensation as pretax contributions, Roth 401(k) contributions, or a combination thereof, not to exceed the limitation set forth in Section 402(g) of the Internal Revenue Code (IRC). Participants may make catch-up contributions, contributions that exceed the annual elective deferral limit, during any calendar year ending on or after the participant's 50th birthday. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes Qualified Automatic Contribution Arrangement (QACA) safe harbor matching contributions on behalf of each participant equal to 100% of the first 1% and 50% of the next 6% of the participant's compensation that is deferred as an elective deferral. Company QACA safe harbor matching contributions are computed for each payroll period.

The Company may also elect to make discretionary nonelective contributions for participants employed by the Company on the last day of the Plan year. Discretionary nonelective contributions are allocated to each participant's account based on the ratio of a participant's compensation to all participants' compensation. Discretionary nonelective contributions are computed annually. There were no discretionary nonelective contributions made during 2024. The Company contributions are invested directly in the various investment options, as directed by the participant.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings or losses. Earnings and losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. Upon the occurrence of a distribution event, the benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

**Vesting**

Participants are immediately vested in their elective contributions, plus or minus any earnings or losses on such contributions. A participant, or his or her beneficiary, becomes 100% vested in all Company contributions upon death, disability or attaining normal retirement age, as defined by the Plan document. For all other purposes, vesting in the Company's QACA safe harbor matching contributions and discretionary nonelective contributions made on the participant's behalf is based on the following schedule:

2 or more	100%

Participants are credited with a year of service based on the elapsed time method, as defined by the Plan document.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts any amount greater than \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance incurred by the participant during the 12-month period ending on the day before the loan is made, or 50% of the participant's vested account balance. Loan repayments are calculated on a fully amortized basis. Loans are collateralized by the vested balance in the participants' accounts and bear interest at the prime rate, as stated in the Wall Street Journal, plus 1.00%. Loan terms may not exceed five years, or 25 years if used for the purchase of a residence.

**Payment of Benefits**

In the case of a participant's retirement, death, permanent disability or termination of employment, the participant or his or her designated beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, unless a participant is required to receive lifetime required minimum distributions (RMDs), in which case participants may elect to

receive the RMDs in installments payable monthly, quarterly or annually. Distributions are subject to the applicable provisions of the Plan agreement.

Participants may elect to receive a distribution of their vested account balance as a lump-sum distribution upon attainment of 59½ years of age.

Hardship withdrawals from the participant's pretax contributions balance prior to age 59½ are also permitted under certain circumstances.

**Forfeitures**

All Company contributions credited to a participant's account, but not vested, are forfeited by the participant upon distribution of the fully vested value of his or her account. Forfeitures are applied to pay Plan expenses and reduce future Company contributions or to restore participants' accounts. During the year ended December 31, 2024, forfeitures totaling \$414,423 were used to reduce Company contributions and \$5,804 to pay Plan expenses. The balance in the forfeiture accounts as of December 31, 2024 and 2023, was \$230,128 and \$432,127, respectively.

The Plan entered into a fee agreement with Empower, from which it receives revenue sharing funds which are recorded in the non-allocated ERISA Spending Account. The purpose of this account is to pay necessary and reasonable Plan related expenses in accordance with the Department of Labor's guidance. During 2024, total additions to the ERISA Spending Account amounted to \$158,359, which is reflected as other income on the statement of changes in net assets available for benefits for the year ended December 31, 2024. During the year ended December 31, 2024, a total of \$39,577 was used to pay Plan expenses. The balance in the ERISA Spending Account as of December 31, 2024 and 2023, was \$504,367 and \$385,164, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Net appreciation in fair value of investments includes realized gains and losses on investments sold during the year as well as unrealized appreciation (depreciation) of investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**Benefit Payments**

Benefit payments to participants are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

Management has evaluated subsequent events through August 25, 2025, which is the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 855, *Subsequent Events*.

**3. FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820 (ASC 820), *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust:* Valued at the NAV of units of the collective trust fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities, as presented in the fund's audited financial statements. Were the Plan to initiate a full redemption of the fund, the investment adviser reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Self-directed brokerage account:* Valued based on the fair value of the underlying investments in the self-directed brokerage accounts. Investments held in the self-directed brokerage accounts include money market accounts, common stocks, exchange traded funds, and Carriage Services, Inc. common stock. The following is a description of the valuation methods for the individual investment types held in the self-directed brokerage accounts:

*Money market funds:* Valued based on the fair value of the underlying securities within the fund, which represents the NAV of shares held by the Plan at year end.

*Common stocks:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Exchange traded funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

The methodologies described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related in investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan's trustee.

**5. TAX STATUS**

The Plan adopted a non-standardized prototype plan, the Great-West Trust Company Defined Contribution Prototype Plan and Trust. The non-standardized prototype plan has received an opinion letter, dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, the accompanying financial statements do not include a provision for income taxes.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

**7. PARTY-IN-INTEREST TRANSACTIONS**

The Plan paid expenses related to the Plan's operations and investment management to various service providers and affiliates of the trustee. Therefore, these transactions with these entities qualify as exempt party-in-interest transactions.

The Plan also allows for continued investment in the Company's common stock and issues notes receivable from participants. These transactions also qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. The investments in the Company common stock held in self-directed brokerage accounts totaled \$405,011 and \$801,229 as of December 31, 2024 and 2023, respectively.
