Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Air Treatment Corporation Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Air Treatment Corporation Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

Notes to Financial Statements

Note 1 – Plan Description and Basis of Presentation

The following description of the Air Treatment Corporation Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of plan provisions.

General – The Plan operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (the Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Air Treatment Corporation (the Company) is the Plan’s sponsor and serves as Plan administrator. The Board of Directors (the Board) means the Board appointed by the employer to govern the Plan. Participants should refer to the Plan agreement, as amended, for a more complete description of plan provisions.

The Plan purchased company common stock (stock) using the proceeds of borrowings from the Company (see Note 5). The borrowings are to be repaid through 2050 subject to accelerated payments.

The borrowings are collateralized by the unallocated shares of stock. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the Code. The lender has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements for the Plan present assets and liabilities separately therein pertaining to:

- (a) The accounts of participants with rights in allocated stock (Allocated), and
- (b) Stock not yet allocated to participants (Unallocated).

At December 31, 2024 and 2023, these total share amounts constituted 100% of the issued and outstanding shares of the common stock of the Company.

Eligibility – Employees of the Company are eligible to participate in the Plan after completing one year of service. A year of service is defined as a 12-month period in which the employee has 1 hour of service. Participants will enter the Plan on the first day of the month in which they become eligible. Excluded employees include collective bargaining and employees on approved absences.

Contributions – The Board of the Company annually determines the amount, if any, to contribute to the Plan. The contribution is to be payable in shares of Company stock or other property. For the year ended December 31, 2024, cash contributions totaled \$2,907,114 to the Plan with \$1,189,323 to be used for loan repayments.

Allocation of contributions, forfeitures, and earnings – Each participant’s account is credited with allocations of (a) the Company’s contributions, (b) forfeitures, (c) net appreciation or depreciation of Company common stock, (d) Company dividends, and (e) other investment earnings net of plan expenses, if any.

The Company’s contributions may consist of acquisition indebtedness contributions and cash or common stock contributions and are allocated to active participants based on the percentage that their eligible compensation is representative to total eligible compensation. In order to be eligible for the Company’s contributions, a participant must be employed by the Company on the last day of the Plan year.

Forfeitures of terminated participant’s nonvested account balances are allocated to active participants based on the percentage that their eligible compensation is representative to total eligible compensation. For the year ended December 31, 2024, forfeitures of \$384,597 were allocated to active participants. Net appreciation or depreciation of Company common stock, as determined by an independent appraiser, is allocated based on the number of shares held by the participants at year-end multiplied by the change in the per share value.

Stock or cash dividends received by the Plan on previously allocated shares are allocated based on the number of shares held by the participants. Stock or cash dividends received by the Plan on unallocated shares are allocated based on the percentage that their eligible compensation is representative to total eligible compensation.

Other investment earnings, net of plan expenses (if any) are allocated to participants based on the percentage that their other investment account balance as of the first day of the Plan year adjusted for distributions made is representative to the total other investment account balance.

Vesting – Participants vest in the Company’s contributions based on the following schedule:

The employee account becomes 100% vested in the event of a participant’s death, disability, or normal retirement.

Payment of benefits – Distribution of plan benefits due to termination for retirement, disability, death, or other reasons will be made in shares of Company common stock (see put option below), lump-sum, or annual installments. Annual installments are paid after a one- to six-year waiting period in annual installments over no more than five years, unless the participant's vested account balance exceeds the amount as defined under the Code, in which case installments could exceed five years.

Put option – Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market value. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification – Diversification will be offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least 55 years of age with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of his or her account balance, less any amounts previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. During the year ended December 31, 2024, there were no diversification amounts in the Plan.

Voting rights – With respect to employer securities held in a participant's employer securities account, a participant has the right to direct the trustee regarding the voting of such employer securities that are allocated to his employer securities account with respect to any corporate matter which involves the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sales of substantially all assets of a trade or business, or such similar transaction. On other corporate matters requiring a vote of the shareholders, the trustee shall properly vote employer securities allocated to participants' employer securities account in its sole discretion. The trustee shall properly vote employer securities held in the unallocated employer securities account at its sole discretion.

Right of first refusal – The right of first refusal shall provide that prior to any subsequent transfer, the shares must first be offered for purchase in writing to the Company, then to the trustee, on behalf of the Plan, at the fair market value. The fair market value for these shares of Company common stock shall be the greater of the price offered to the participant by the prospective purchaser or the most recent preceding valuation date of the Plan. The Company and the trustee have 14 days to exercise this right of first refusal.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition – The shares of Company common stock are reported at fair value. See Note 4 for a discussion of the fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – The Board may direct the trustee to pay from the trust all fees and expenses reasonably incurred by the Plan, to the extent such fees and expenses are for the ordinary and necessary administration and operation of the Plan, unless the Company pays the fees and expenses.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through August 7, 2025, which is the date the financial statements were available to be issued.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value.

Company common stock – The fair value of the Company's common stock held by the Plan is valued at an estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of income and cash generating capability of the Company. The value of the common stock has been developed primarily on the income approach and the market approach. The Company's common stock is classified within Level 3 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Notes Payable

On August 31, 2016, the Plan entered into a \$30,582,680 promissory note with the Company. The proceeds of the note were used to purchase 828,699 shares of the Company's outstanding common stock. Unallocated shares are collateral for the note. The agreement provides for the note to be repaid over 35 years, with varying annual installments ending in 2050. However, because of accelerated payments in previous years, the note is targeted to be fully repaid in 2032. The note bears interest at 1.9% per annum. The balance due under the promissory note at December 31, 2024 and 2023, is \$8,004,329 and \$9,022,230, respectively.

The shares purchased are unallocated to secure the notes. Shares are available for allocation to the accounts of the participants as principal and interest payments on the notes are made and the shares are released by the Company to the Plan. As of December 31, 2024 and 2023, 221,818 and 252,324 common shares remain unallocated, respectively.

Note 6 – Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market volatility, and credit risks as well as valuation assumption based on earnings, cash flows, and other such techniques. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the common stock in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits. The Company common stock future value is subject to decisions of management and future conditions within the construction industry.

Note 7 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated December 27, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes (Accounting Standards Codification 740-10), management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Party-in-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Such parties are parties-in-interest under ERISA. The Plan invests in Company common stock and has indebtedness to the Company. The Company paid certain administrative expenses of the Plan. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

Note 9 – Plan Termination

Although the Company has expressed no intent to do so, it reserves the right to terminate the Plan at any time, subject to the plan provisions. Upon termination of the Plan, the entire interest of each of the affected participants shall become 100% vested. The trustees shall distribute the interest of each participant in the trust fund to such participant or his or her beneficiary at the time prescribed by the plan terms and the Code. Upon termination of the Plan, the Board shall also direct the trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loans.
