INDEPENDENT AUDITORS' REPORT

To the Board of Trustees of the

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

#### NOTE A - DESCRIPTION OF PLAN

The following description of Advanced Molecular Diagnostics 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan was established on January 1, 2023. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) covering substantially all employees of Advanced Molecular Diagnostics (the Company) who are age 18 and are not union employees, nonresident aliens, or leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 10, 2024, the Plan was amended as follows:

- A service requirement of three months of service was added to the eligibility provisions.
- The distribution provisions were amended to allow involuntary cash-outs.
- The discretionary nonelective contribution allocation conditions were amended to no longer require participants to be employed on the last day of the Plan year to receive an allocation of any discretionary nonelective contribution made.

##### Contributions

Participants are automatically enrolled in the Plan on the first payroll that is administratively feasible to implement deferrals after the eligibility requirements are met but no later than the later of two pay periods or two weeks after the requirements are met. Unless a participant makes an affirmative election, participants are automatically enrolled to contribute 1% of compensation each pay period on a pre-tax basis. Participants may elect to contribute on a pre-tax basis or post-tax (Roth) basis to the Plan up to the maximums allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary nonelective contributions to the Plan. Effective through March 9, 2024, participants had to be employed on the last day of the Plan year to receive an allocation of any discretionary nonelective contributions made to the Plan. Effective March 10, 2024, the allocation condition was removed so that all participants share in the allocation regardless of service completed or employment status on the last day of the Plan year. For the year ended December 31, 2024, the Company did not make any discretionary nonelective contributions to the Plan. Participants direct the investment of the Company's contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company discretionary nonelective contributions, if any, and an allocation of Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as

defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and actual earnings thereon.

Vesting in the Company's discretionary nonelective contribution portion of their account, if any, plus earnings thereon is based on years of service as follows:

If a participant dies or becomes disabled prior to attaining normal retirement age, the participant becomes 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Hardship withdrawals are permitted by the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 ½. Benefit payments are made in the form of lump sum distributions. Effective March 10, 2024, participants who terminate employment with a balance of less than \$7,000, but more than \$1,000, may receive an automatic direct rollover of their account balance into an individual retirement account. Participants who terminate with a balance of less than \$1,000 may receive an automatic lump sum distribution of their balance.

#### NOTE A - DESCRIPTION OF PLAN (CONTINUED)

##### Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated participants or adjustments, if any. Forfeitures are used to pay administrative expenses or reduce employer contributions. There was a forfeiture balance of \$338 and \$831 as of December 31, 2024 and 2023, respectively. Forfeitures of \$1,458 were used to fund an employer contribution during the year ended December 31, 2024.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Cash

The Plan considers cash to be highly liquid non-interest-bearing funds held in the Plan with an original maturity date of three months or less.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective contributions, if any, are recorded in the year in which the participant compensation is earned.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

As of December 31, 2023, \$815 was allocated to a participant who had elected to withdraw from the Plan but had not been paid. There were no amounts allocated to participants who had elected to withdraw from the Plan but had not been paid as of December 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for recordkeeping services, custodian services, investment advisory services and third-party administration services are included in administrative expenses and allocated to participant accounts based on a pro rata formula. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds (and money market fund):* Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

#### NOTE F - TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan which obtained its latest opinion letter on September 26, 2024, in which the IRS stated that the Plan is designed in accordance with the applicable requirements of the IRC. The Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Guideline, Inc. ("Guideline") is the third-party administrator, recordkeeper, and investment advisor for the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid to Guideline have been included in administrative expenses.

Notes receivable from participants and related interest income also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

#### NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE I – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2024, the Company inadvertently failed to remit participant contributions within the time period required by Department of Labor (DOL) regulations. The late remittance of participant contributions is considered a prohibited transaction. The Company funded lost earnings of \$1,120 during the year ended December 31, 2024 to correct the delinquent participant contributions from the year ended December 31, 2023 and certain delinquent participant contributions for the year ended December 31, 2024. The lost earnings are included in other employer contributions on the statement of changes in net assets available for benefits. The Company is in the process of correcting all late remittances that were uncorrected as of December 31, 2024.

NOTE J – PLAN CORRECTIONS DUE TO OPERATIONAL FAILURES

Operational failures were identified during the years ended December 31, 2024 and 2023. The Company calculated the amounts owed to participants to correct the failures in accordance with regulations. The corrective contributions owed as of December 31, 2024 and December 31, 2023 are presented as other employer contributions receivable on the statements of net assets available for benefits.

#### NOTE L – SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to change the automatic enrollment deferral rate from 1% of compensation on a pre-tax basis to 3% of compensation on a pre-tax basis and to implement automatic escalation. The automatic deferral rate increases by 1% of compensation on the first day of each Plan year subject to a maximum of 10% of compensation.

The Plan has evaluated subsequent events for recognition and disclosure through September 2, 2025, the date the financial statements were available to be issued.

INDEPENDENT AUDITORS' REPORT

To the Board of Trustees of the

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

#### NOTE A - DESCRIPTION OF PLAN

The following description of Advanced Molecular Diagnostics 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan was established on January 1, 2023. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) covering substantially all employees of Advanced Molecular Diagnostics (the Company) who are age 18 and are not union employees, nonresident aliens, or leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 10, 2024, the Plan was amended as follows:

- A service requirement of three months of service was added to the eligibility provisions.
- The distribution provisions were amended to allow involuntary cash-outs.
- The discretionary nonelective contribution allocation conditions were amended to no longer require participants to be employed on the last day of the Plan year to receive an allocation of any discretionary nonelective contribution made.

##### Contributions

Participants are automatically enrolled in the Plan on the first payroll that is administratively feasible to implement deferrals after the eligibility requirements are met but no later than the later of two pay periods or two weeks after the requirements are met. Unless a participant makes an affirmative election, participants are automatically enrolled to contribute 1% of compensation each pay period on a pre-tax basis. Participants may elect to contribute on a pre-tax basis or post-tax (Roth) basis to the Plan up to the maximums allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary nonelective contributions to the Plan. Effective through March 9, 2024, participants had to be employed on the last day of the Plan year to receive an allocation of any discretionary nonelective contributions made to the Plan. Effective March 10, 2024, the allocation condition was removed so that all participants share in the allocation regardless of service completed or employment status on the last day of the Plan year. For the year ended December 31, 2024, the Company did not make any discretionary nonelective contributions to the Plan. Participants direct the investment of the Company's contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company discretionary nonelective contributions, if any, and an allocation of Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as

defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and actual earnings thereon.

Vesting in the Company's discretionary nonelective contribution portion of their account, if any, plus earnings thereon is based on years of service as follows:

If a participant dies or becomes disabled prior to attaining normal retirement age, the participant becomes 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Hardship withdrawals are permitted by the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 ½. Benefit payments are made in the form of lump sum distributions. Effective March 10, 2024, participants who terminate employment with a balance of less than \$7,000, but more than \$1,000, may receive an automatic direct rollover of their account balance into an individual retirement account. Participants who terminate with a balance of less than \$1,000 may receive an automatic lump sum distribution of their balance.

#### NOTE A - DESCRIPTION OF PLAN (CONTINUED)

##### Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated participants or adjustments, if any. Forfeitures are used to pay administrative expenses or reduce employer contributions. There was a forfeiture balance of \$338 and \$831 as of December 31, 2024 and 2023, respectively. Forfeitures of \$1,458 were used to fund an employer contribution during the year ended December 31, 2024.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Cash

The Plan considers cash to be highly liquid non-interest-bearing funds held in the Plan with an original maturity date of three months or less.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective contributions, if any, are recorded in the year in which the participant compensation is earned.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

As of December 31, 2023, \$815 was allocated to a participant who had elected to withdraw from the Plan but had not been paid. There were no amounts allocated to participants who had elected to withdraw from the Plan but had not been paid as of December 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for recordkeeping services, custodian services, investment advisory services and third-party administration services are included in administrative expenses and allocated to participant accounts based on a pro rata formula. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds (and money market fund):* Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

#### NOTE F - TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan which obtained its latest opinion letter on September 26, 2024, in which the IRS stated that the Plan is designed in accordance with the applicable requirements of the IRC. The Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Guideline, Inc. ("Guideline") is the third-party administrator, recordkeeper, and investment advisor for the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid to Guideline have been included in administrative expenses.

Notes receivable from participants and related interest income also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

#### NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE I – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2024, the Company inadvertently failed to remit participant contributions within the time period required by Department of Labor (DOL) regulations. The late remittance of participant contributions is considered a prohibited transaction. The Company funded lost earnings of \$1,120 during the year ended December 31, 2024 to correct the delinquent participant contributions from the year ended December 31, 2023 and certain delinquent participant contributions for the year ended December 31, 2024. The lost earnings are included in other employer contributions on the statement of changes in net assets available for benefits. The Company is in the process of correcting all late remittances that were uncorrected as of December 31, 2024.

NOTE J – PLAN CORRECTIONS DUE TO OPERATIONAL FAILURES

Operational failures were identified during the years ended December 31, 2024 and 2023. The Company calculated the amounts owed to participants to correct the failures in accordance with regulations. The corrective contributions owed as of December 31, 2024 and December 31, 2023 are presented as other employer contributions receivable on the statements of net assets available for benefits.

#### NOTE L – SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to change the automatic enrollment deferral rate from 1% of compensation on a pre-tax basis to 3% of compensation on a pre-tax basis and to implement automatic escalation. The automatic deferral rate increases by 1% of compensation on the first day of each Plan year subject to a maximum of 10% of compensation.

The Plan has evaluated subsequent events for recognition and disclosure through September 2, 2025, the date the financial statements were available to be issued.
