Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule included in the accompanying table of contents is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by the qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

Hines Services Inc (the Company and Employer) established the Hines Services Inc (the Plan) on January 1, 2021, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and administrator. Reliance Trust Company (Reliance) serves as the Plan's trustee, and ADP Retirement Services serves as the Plan's record keeper. Reliance holds, invests, and reinvests the Plan assets in the interest and direction of the participants and their beneficiaries.

Eligible Participants:

Eligible employees, as defined by the Plan agreement, may participate in the Plan on the first day of the month following the completion of three months of service.

Contributions:

Participants may make contributions to the Plan through pre-tax salary reductions and Roth post-tax deductions of up to 90% of their annual eligible compensation, as defined by the Plan agreement. Participants who have reached the age of 50 may also elect to contribute additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. The automatic pre-tax salary deferral contribution is set at 1% of eligible compensation, as defined by the Plan agreement, unless the participants requested a different amount to be contributed or formally declined participation.

1. Description of the Plan (continued)

Contributions: (continued)

The Company matches 100% on the first 3% of participants' eligible compensation which is deferred to the Plan. The Company made matching contributions of \$142,844 to the Plan in 2024.

The Company may also make discretionary non-elective contributions to the Plan at the option of the Company's Board of Directors. The Company has not made any discretionary contributions to the Plan through December 31, 2024.

Contributions are subject to certain limitations under the Code.

Participant Accounts:

Participant accounts are credited with participant contributions, Company contributions, and an allocation of Plan net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Vesting and Forfeitures:

Participants are immediately vested in their contributions plus actual earnings (less any losses) thereon. For any Company contributions, participants become 100% vested after three years of service, or upon retirement, disability, Plan termination, or death.

Forfeited non-vested accounts may be used to reduce Plan expenses and to reduce Employer contributions. As of December 31, 2024 and 2023, there were \$23 and \$4,272 of forfeited non-vested accounts available for future use, respectively. During 2024, forfeitures of \$28,654 were used to reduce employer contributions and \$4,302 were used to pay Plan expenses.

Notes Receivable from Participants:

Participants may borrow up to one-half of their account balance up to \$50,000, with a minimum of \$500, for a period not to exceed five years, except for notes used to purchase a primary residence for which terms of up to 30 years are permitted. Participants may have one note outstanding at any time. Participant notes are evidenced by a written note, secured by the balance in the participant account, and bear a reasonable rate of interest determined by the Plan administrator. The interest rates on the notes outstanding at December 31, 2024 ranged from 9.50% to 10.50%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Notes receivable transactions with participants qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

Payment of Benefits:

On termination of service for any reason, participants can elect benefits to be paid in a lump-sum cash distribution equal to the value of the participant account, partial withdrawals with a minimum of \$500, or in regular cash installment payments of their choice. Terminated participant accounts below \$5,000 may be distributed directly to participants without participant approval. Participants who have reached age 59.5 may take in-service withdrawals of their account balances, with a minimum of \$500. Participants may also take in-service withdrawals for specific hardships, as defined by the Plan agreement. Benefits are recorded when paid.

Administrative Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain account maintenance and note fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would remain fully vested in their accounts and distributions will be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments:

The Plan's investments consist of mutual funds and a common collective trust, and are accounted for as follows:

- **Mutual Funds:** These funds are valued at the net asset value of shares held by the Plan at year end based on quoted prices in active markets.

Investments: (continued)

- Common Collective Trust (CCT): The Plan invests in a fully benefit-responsive investment contract through the Invesco Stable Asset Fund (the CCT) offered by Invesco Trust Company (Invesco). The CCT is valued using the NAV practical expedient for the CCT as reported by Invesco. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of the CCT is calculated based on a compilation of primarily observable market information. The NAV practical expedient would not be used if it is determined to be probable the Plan will sell an investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the trust, Invesco reserves the right to temporarily delay withdrawal from the trust in order to ensure the investments liquidated will be carried out in an orderly business manner. The fund will continue in existence until terminated in accordance with the operating agreement. Redemption of units is permitted, but the units may not otherwise be transferred without the consent of Invesco. The Plan has no unfunded commitments with the CCT.

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

- Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

Fair Value Measurement: (continued)

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds are recorded at fair value and classified as Level I within the fair value hierarchy as of December 31, 2024 and 2023.

The Plan's CCT is recorded at fair value using the NAV practical expedient and is excluded from the fair value hierarchy as of December 31, 2024 and 2023.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net income on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is subject to income tax examinations since Plan inception.

5. Subsequent Events

Subsequent events have been evaluated through August 26, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
