## **Independent Auditors' Report**

To the Plan Administrator of the  
Healing Hands Healthcare 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Healing Hands Healthcare 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

## Other Matter – Supplemental Schedule Required by ERISA

### 1. Description of Plan

#### *General*

Healing Hands Healthcare 401(k) Plan (Plan) was established on March 1, 2021 for eligible employees of Healing Hands Healthcare (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a defined contribution plan established by the Company under the provisions of section 401(a) of the Internal Revenue Code (IRC). The following descriptions provide only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is administered by the Company. Reliance Trust Company (Custodian) serves as the Plan's Custodian and ADP Retirement Trust Services, LLC serves as the trustee pursuant to agreements with the Plan.

#### *Contributions*

Participants of the Plan may contribute pretax annual compensation, as defined by the Plan, limited to the maximum amount permitted under the applicable Internal Revenue Service (IRS) limitations. Rollover contributions from other qualified plans are also allowed. Participants direct all contributions to their account into various options offered by the Plan. The Company may make discretionary matching contributions. No discretionary matching contributions were made for the period ending December 31, 2024 and 2023.

#### *Eligibility and Participant Accounts*

Qualified employees age 21 years of age or older are eligible to become participants in the Plan after completing two months of service with the Company. Separate accounts are established for each participant. Participants' accounts are credited with the participants' contributions and allocations of (a) the Company's contribution, (b) Plan earnings, (c) forfeitures of terminated participants' nonvested accounts and (d) charged with an allocation of administrative expenses.

#### *Benefits Paid to Participants*

A participant's account balance is paid to the participant or the participant's beneficiary in a lump sum payment, periodic payments or an annuity upon the participant's retirement, death or disability. The vested portion of a participant's account can be withdrawn by the participant upon termination of employment with the Company or upon withdrawal from the Plan. In-service withdrawals of after-tax accounts and hardship withdrawals of pre-tax accounts are also available.

#### ***Vesting***

Participant contributions plus earnings thereon are fully vested. Participants are immediately vested in Company matching contributions. Discretionary profit sharing contributions vest based on the years of continuous service at the following rates:

2 years	20%
3 years	40%
4 years	60%

#### ***Notes Receivable from Participants***

Under the Plan, participants may obtain loans in amounts up to 50% of their vested account balance not to exceed \$50,000. The repayment terms of loans may not exceed five years except for loans used to acquire a principal residence. Each loan bears interest at a reasonable rate as determined by the Plan administrator. Principal and interest are paid ratably through automatic payroll deductions. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be a distribution, notes receivable from participants is reduced and a benefit payment is recorded.

#### ***Plan Termination***

The Company has not expressed any intent to terminate the Plan. However, in the event the Plan is ever terminated, all participants would become 100% vested and the Company would authorize the Custodian to continue the Plan until all benefits have been distributed, or liquidate the Plan and distribute all assets to the participants.

#### ***Forfeitures***

Forfeitures from the Company's discretionary contributions are used to pay administrative expenses of the Plan and reduce future Company contributions. No forfeitures were used during the period ended December 31, 2024. At December 31, 2024 and 2023, no forfeiture balances were available for future use.

### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are presented on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Estimates and Assumptions***

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could vary from the estimates used in preparing the accompanying financial statements.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan presents the net change in fair value of investments, which consists of realized gains or losses, unrealized appreciation (depreciation), and any income or capital gain distributions from such investments, in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefits to participants are recorded when paid.

### ***Risks and Uncertainties***

The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

### **3. Fair Value Measurements**

Under the Fair Value Measurements and Disclosures topic of the Codification, ASC 820, disclosures are required about how fair value is determined for assets and liabilities and a hierarchy for which these assets and liabilities must be grouped is established, based on significant levels of inputs as follows:

- Level 1 quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; and model-derived valuations in which all significant inputs are observable in active markets.
- Level 3 valuations derived from valuation techniques in which one or more significant inputs are unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

### ***Mutual Funds***

These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying asset owned by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Tax Status

The prototype plan administrator has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the IRC and that any employer adopting this form of the prototype plan will be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Annual Return/Report of Employee Benefit Plan is subject to examination by the IRS for three years from the date of filing.

#### **6. Related Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are managed by the Custodian. Transactions with the Custodian qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

#### **7. Subsequent Events**

Plan management has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued, and concluded that no additional disclosures are required.
