INDEPENDENT AUDITORS' REPORT

To the Plan Committee of
Carlson Capital L.P. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Carlson Capital L.P. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Plan management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that plan management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect plan management's responsibility for the financial statements.

In preparing the financial statements, plan management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Plan management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental Information Required by ERISA

The supplemental information as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of plan management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

1. DESCRIPTION OF PLAN

The following description of the Carlson Capital, L.P. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees of Carlson Capital, L.P. (the “Employer,” “Company,” or “Plan Administrator”), a Delaware limited partnership. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The purpose of the Plan is to provide employees with the opportunity to save for retirement on a tax-deferred basis. The Plan Committee is responsible for the oversight of the Plan.

The Plan’s custodial responsibilities and investments are held by Reliance Trust Company (the “Custodian”).

Automatic Data Processing, Inc. Retirement Services Operations (the “recordkeeper” or “ADP”) maintained participant account records and performed other services for the Plan. The Plan also receives Co-Fiduciary Investment Advisory services from ADP and ADP Strategic Plan Services LLC (“SPS”). This allows the Plan Committee to receive advice, guidance, and assistance with the selection and monitoring of the Plan’s investment options from ADP and SPS. An ERISA Budget Account has been set up to fund the Co-Fiduciary service.

Eligibility and Contributions

The Plan is qualified under Section 401(a) of the Internal Revenue Code (the “Code” or “IRC”) and permits elective contributions in accordance with Section 401(k) of the Code. Newly hired full-time employees are automatically enrolled in the Plan on the first day of the month after their hire date, with two percent of eligible compensation deferred from each paycheck. The maximum salary deferral contribution per year is 90 percent of eligible compensation including bonuses paid for the year, subject to Code limitation of \$23,000 for plan year 2024. Participants who reach the age of fifty by the end of the Plan year are eligible to contribute up to an additional \$7,500 as a “catch-up” contribution. In addition to traditional pre-tax salary deferrals, participants may elect to make Roth 401(k) deferrals, which are subject to current income tax rates in the year of deferral, however, such deferrals and, subject to qualifications, earnings thereon are not subject to federal income taxes when distributed to the participant.

The Company may make discretionary profit-sharing contributions. Participants are eligible to share in the discretionary profit-sharing contributions. To be eligible for the profit-sharing contributions, participants must have been employed by the Company (in the U.S. only) for one full year as of December 31 of the profit-sharing year. Therefore, for 2024, the participant must have been continuously employed from January 1, 2024, to December 31, 2024. For part-time employees (U.S. only), participants must meet the employment requirement above and have one thousand hours of service in the calendar year. No employer profit sharing contributions were made for the 2024 plan year.

For the purposes of profit sharing, eligible compensation for participants that receive W-2 income is base salary paid in plan year plus plan year bonuses accrued at year end and paid in the following year, subject to a total cap of \$200,000.

Participant Accounts

Participants can elect to have their contributions invested in a number of investment fund options. Participants can change elections and can also reallocate existing funds between available investment fund options daily, subject to certain restrictions and fees on a fund-by-fund basis. Each participant's account is credited with the participant's contributions and Company profit sharing contributions and investment fund earnings. Participant accounts are charged an allocation of administrative expenses, as applicable. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in salary deferral and rollover contributions is 100 percent. Vesting in matching and profit-sharing contributions is 20 percent per year of vesting service. An employee is credited with a year of vesting service for each calendar year in which the participant completes at least 1,000 hours of service. Participants are fully vested after five years of service.

Notes Receivable from Participants

Loans are available to all participants at the current prime lending rate plus one percent with required repayments through payroll deductions over no more than five years. Loans are processed by ADP. The prime rate is determined based upon the prime rate of interest that is published in the Wall Street journal on the 14th day of each month. In the event that loans are used to acquire the participant's principal residence, the repayment period may be extended beyond five years. A participant may pay off any remaining loan balance at any time directly to the Trustee. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Loan issuances must be at least \$500 and are limited to the lesser of \$50,000 or 50 percent of the participant's vested account balance, and participants may only have one loan outstanding at any given time. The Plan Administrator exercises discretion, as necessary, in approving hardship loans to participants. Loan balances for active participants that have not had payments credited when they are due are considered in default and are recorded as deemed distributions taxable to the participant. There was no allowance at December 31, 2024 and 2023, as the note receivables are fully collateralized by the participants' accounts.

Principal and interest is paid ratably through payroll deductions over a period not to exceed five years from the date of the loan, unless used to acquire a principal residence, in which case the repayment period may not exceed thirty years. As of December 31, 2024, there were no participant loans outstanding. As of December 31, 2023, interest rates on outstanding loans ranged from 4.25 percent to 8.75 percent.

Payment of Benefits

Distributions of vested benefits may be made to a participant upon retirement, disability, death, or termination of employment. Prior to the age of 59½, a participant, while still employed, may make a withdrawal from vested accounts to the extent necessary to satisfy an immediate and substantial financial need, as defined in Section 401(k) of the Code, subject to certain conditions contained in the Plan document. Subsequent to age 59½, the participant may withdraw all or any portion of vested accounts at any time.

Any withdrawals from the Plan will be subject to federal income tax at a minimum withholding rate of 20 percent. An additional 10 percent excise tax will be imposed on the withdrawn amount if the distribution is made prior to the age of 59½, except that the additional 10 percent tax is not imposed on distributions made by reason of death, disability, termination of employment after age 55, a qualified domestic order, and other reasons enumerated in the Code.

A participant may transfer distributable amounts to an individual retirement account, to an annuity described in Section 403(b) of the Code, to a plan described in Section 457(b) of the Code maintained by certain governmental entities, or to another qualified plan within 60 days, without being subject to taxation.

Forfeited Accounts

Upon termination of employment, participants forfeit their non-vested balance. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,224 and \$1,543, respectively. The Company has discretion in the allocation of forfeitures to reduce administrative expenses and/or reduce the Company match or additional discretionary contributions. During 2024, forfeited non-vested accounts were not used to reduce administrative expenses or reduce the Company match or additional discretionary contributions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors and custodian. See Note 3 for discussion of fair value measurements.

Shares of registered investment companies (“mutual funds”) are valued at quoted market prices which represent the net asset value (“NAV”) of shares held by the Plan at each year end. The fair value of investments in the common collective trust is measured by using NAV as a practical expedient to estimate fair value and is determined by each fund custodian at year end based on the fair value of the underlying securities within that trust.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s realized gains and losses on investments bought and sold as well as unrealized appreciation on assets held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded on the Statement of Changes in Net Assets Available for Benefits when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefits paid to participants and notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Concentrations

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV provided by the custodian. The NAV is based on market value of the underlying assets held by the trust less its liabilities. This practical expedient would not be used if it is determined to be probable that the trust will sell the investment for an amount different from the reported NAV. The fair market value has been established using the NAV under the practical expedient approach and, therefore, is not assigned to a level in the fair value hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan's fair value measurements as of December 31, 2024 and 2023, with the exception of common collective trust which are measured at fair value using the NAV practical expedient. The fair value for the common collective trust is provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits.

5. PARTY IN INTEREST TRANSACTIONS

Certain plan investments are managed by Reliance Trust Company. Reliance Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as a party in interest transactions. Fees paid by the Plan are included in net appreciation in fair value of investments.

ADP is the Plan's recordkeeper and broker, therefore, these transactions qualify as party in interest transactions, which are exempt from prohibited transaction rules. Fees incurred by the Plan are included in administrative expenses and are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payment.

The Plan is subject to an annual audit in order to remain in compliance with ERISA regulations. HM&M Group, LLC is the plan auditor and, therefore, this transaction qualifies as a party-in-interest transaction. For the year ended December 31, 2024, audit fees were paid by the Company. For the year ended December 31, 2023, a portion of the audit fees were paid by the Plan and are included in administrative expenses.

6. PLAN TERMINATION

The Company has reserved the right to amend, modify, or terminate the Plan at any time, subject to the Plan document and applicable laws and regulations. The Company has no intentions of terminating the Plan and is not aware of any occurrences that could reasonably result in the termination of the Plan. In the event of Plan termination, participants will become 100 percent vested in their entire account balance, including employer contributions, if any, regardless of years of service.

7. TAX STATUS

Plan management adopted an amended and restated prototype plan document, on which the Internal Revenue Service issued a determination letter dated June 30, 2020, stating that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the plan document has been amended since receiving the determination letter, plan management and the Plan's tax counsel believe the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan, disclose within the footnotes to the financial statements any potential impact to the Plan, and recognize a tax liability at the Company level if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
