## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Century Rehabilitation 401(k) Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Century Rehabilitation 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits as of December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. **December 31, 2024 and 2023**

**1. DESCRIPTION OF PLAN**

Effective as of April 1, 2006, Century Rehabilitation (the “Sponsor”), adopted the Century Rehabilitation 401(k) Plan and Trust (“Plan”).

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Sponsor established the Plan to provide employees with a systematic means of savings and investing for the future. Regular full-time employees of the Sponsor, as defined by the Plan document, are eligible to enroll. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Employee and Employer Contributions***

Each year, participants may contribute from 1 percent to 90 percent of their gross compensation by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor may decide to make matching contributions to the Plan but are not required to do so. The Plan currently offers various mutual funds as investment options for participants.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of (a) Sponsor’s matching contribution and (b) Plan earnings. Allocations of earnings and losses for each fund are based on the ratio of weighted average participant account balances per fund to the total weighted average of all participant account balances. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

***Vesting***

Participants are immediately vested in their voluntary contributions, Sponsor matching contributions, and actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service, as follows:

25%	vesting after	1 year of service
50%	vesting after	2 years of service
75%	vesting after	3 years of service
100%	vesting after	4 years of service

***Participant Notes Receivable***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from 1 to 5 years or within a reasonable time period for the purchase of a primary residence. The loans are secured by the balances in the participant's account and bear interest at prime plus one percent. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's account or may elect to receive substantially equal installments over a period of time. For termination of service for other reasons, a participant becomes eligible to receive the current value of the participant's vested account in a lump-sum or as substantially equal installments over a period of time. Lump-sum distributions can be paid out as either a check to the participant or as a rollover into another qualified plan of IRA. The Plan also allows for in-service hardship withdrawals in a lump sum up to 100 percent of participant's vested interest in their elective deferral account.

***Investment Options***

Upon enrollment in the Plan, a participant may direct participant contributions as well as the Sponsor's matching contribution, if made, in either a specified dollar amount per payroll period or in whole percentage increments of earnings in any of the funds offered by the Plan. Participants should reference prospectus information supplied by the Plan for detailed fund information.

*Participant Investment Rollovers*

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America, and present the assets available for Plan benefits and changes in those Plan assets.

*Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of certain amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Contributions*

Participant contributions were recorded in the period in which the Sponsor made payroll deductions from participant earnings. Employer contributions were recorded in the period in which they were earned.

Contributions are limited by federal tax legislation. The statutory limit for 2024 401(k) elective employee deferrals was \$23,000, per participant. Participants who have attained age 50 by the end of the Plan year are eligible to contribute an additional \$7,500 as catch-up contributions.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan’s interest in collective trust is valued based on

information reported by the trustee using the audited financial statements of the collective trust as of year-end. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Fair Value Measurements***

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosure*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The plan uses the practical expedient to measure the fair value of collective trusts at NAV as permitted by ASC 820-10-35-54b.

There have been no changes in the methodology used at December 31, 2024 and 2023.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

***Payment of Benefits***

Distributions to participants are recorded when paid.

***Administrative Expenses***

Except for loan origination fees associated with notes receivable from participants, all significant expenses of maintaining the Plan are paid by the Company.

***Date of Management's Review***

The Plan has evaluated subsequent events through August 18, 2025, the date the financial statements were available to be issued.

**3. *INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)***

Reliance Trust, the trustee, maintains all records of investment transactions and determines the valuation of the investment portfolio. As required by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, Reliance Trust has provided certification to the Plan administrator regarding the accuracy and completeness of certain information. The following information was included in the information certified by Reliance Trust for the years ended December 31, 2024 and 2023, and was used in the preparation of the financial statements and supplemental schedule in compliance with ERISA.

The Plan's investments were held in trust and administered by the trustee. All investment information presented in the accompanying financial statements and supplemental schedule, including investments held and net appreciation/depreciation in fair value of investments and interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

**5. *PLAN TERMINATION***

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

**6. *TAX STATUS***

The IRS has determined and informed the Sponsor by a letter dated October 6, 2020, that the Plan and related trust, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2017.

**7. *PARTIES-IN-INTEREST***

The record keeper for the period under audit was Reliance Trust. Therefore, transactions with Reliance Trust qualify as party-in-interest transactions. During 2024 and 2023, the Plan paid Reliance Trust \$4,646 and \$2,501, respectively, in administrative fees. In addition, during 2024 and 2023, audit fees of \$7,500 and \$7,500 were paid by the Sponsor.

**8. *RISKS AND UNCERTAINTIES***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
