Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules listed in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The following description of Primary Health Care, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Primary Health Care, Inc. (Company) for the benefit of its employees who have at least three months of service and are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Automatic Data Processing, Inc.'s Retirement Services (ADP) serves as the Plan's recordkeeper and Reliance Trust Company (Reliance) serves as trustee.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, up to 75%, of eligible compensation contributed as pre-tax 401(k). Effective November 7, 2023, eligible participants are also permitted to elect Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

The Company makes safe harbor matching contributions of 100% of employees' salary deferral amounts on the first 3% of participants' eligible compensation, and 50% of employee salary deferral amounts that exceed 3% of participants' eligible compensation up to 5% of compensation. Contributions are subject to certain limitations.

Participant Investment Account Options

Participants have the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer 5% of eligible compensation unless the participant made an affirmative election otherwise.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 (reduced by the excess of the highest outstanding balance of loans during the prior year over current outstanding balance of loans as of the date of the new loan) or 50% of the participant's vested account balance. A participant may have a maximum of one loan outstanding at one time. All loans are covered by demand notes and are repayable over a period not to exceed five years (or 30 years in the case of a loan used to purchase the participant's principal residence) through payroll withholdings unless the participant chooses to pay off the loan balance prior to maturity. The loan interest rate is set at 1% above the current prime rate, as defined.

Vesting

Participants are immediately vested in their voluntary contributions, rollover, and safe harbor matching contributions plus earnings thereon.

Payment of Benefits

Participants may request to make a withdrawal of their contributions to the Plan due to financial hardship, as defined. Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount or installment payments equal to the value of the vested interest in their account. Upon termination of service, a participant whose account balance exceeds \$5,000 may elect to either remain in the Plan or receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account. A lump-sum distribution will automatically be made for those terminated participants with an account balance of \$1,000 or less. Upon termination of service, a participant's account with a balance greater than \$1,000 but not exceeding \$5,000 will be transferred to an IRA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The Plan's interest in the collective trust fund is valued based on information reported by the investment advisor using the audited financial statement of the stable value fund at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Individual direct expenses paid to parties-in-interest were \$141,440 and \$98,200 for 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions.

The Company provides certain additional administrative services at no cost to the Plan.

Note 5. Plan Amendment

Effective November 7, 2023, the Plan was amended to allow for Roth contributions.

Note 6. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Level 1 securities include mutual funds and are valued at the net asset value (NAV) of shares held by the Plan at period-end. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 8. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 9. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$1,929 were not remitted within the required time period for the year ended December 31, 2022. For the years ended December 31, 2024 and 2023, the Plan had no reportable delinquent remittances. The Company calculated and remitted in 2024 lost earnings and interest following the DOL guidelines for the 2022 contributions.

Note 10. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a pre-approved retirement plan and trust document sponsored by ADP, LLC. This pre-approved plan document has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service stating that the form of the pre-approved plan document is acceptable under Section 401 of the Internal Revenue Code. The Plan has not requested or obtained a determination letter. However, the plan administrator believes that the Plan is qualified and related trust was tax exempt as of the financial statement date.

Note 11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 12. Subsequent Events

Subsequent events have been evaluated through August 19, 2025, which is the date the financial statements were available to be issued.

Change in Trustee

Effective January 1, 2025, ADP Retirement Trust Services became the Plan's Trustee.

Plan Amendment

Effective January 1, 2025, the Plan was amended to suspend 401(k) ADP test safe harbor contributions and to allow for Qualified Automatic Contribution Arrangement (QACA) ADP test safe harbor contributions. The matching formula for QACA ADP test safe harbor contributions is unchanged from the previously elected 401(k) ADP test safe harbor contributions.

Further effective with the plan amendment the automatic deferral feature will increase by 1% as soon as administratively feasible on or after the first day of each July following the commencement of automatic deferrals. These scheduled increases will increase up to a maximum of 6%.

Additionally, the Plan was amended to allow withdrawals within 90 days of the first automatic deferral, and to adopt a 2-year cliff vesting schedule for QACA safe harbor contributions.
