Years ended December 31, 2024 and 2023

### **1. Description of Plan**

The following description of the Safepoint MGA, LLC 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, established January 1, 2014, and restated as of January 1, 2021, for the benefit of the employees of Safepoint MGA, LLC (the Company). The Plan is intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan's sponsor and administrator. The Plan's Recordkeeper is ADP Retirement Services (ADP) and its Trustee is Reliance Trust Company. The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors.

During the year ended December 31, 2024 the Plan was amended to implement automatic enrollment and to require participants to be employed as of the last day of the plan year in order to be eligible for employer nonelective contributions. The Plan was also amended to change vesting requirements and update hardship distribution request procedures.

#### **Eligibility**

The Plan covers all full-time and part-time employees of the Company with the exception of union employees and non-resident aliens. Eligible employees may become a participant and defer a portion of their compensation on the first day of the following plan quarter which the employee completes one month of service.

#### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Each year, participants may contribute up to 90% of pretax or after-tax annual compensation, as defined in the Plan, subject to annual limitations as defined by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2024, the Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with a deferral rate of 3% of annual compensation unless they affirmatively elect not to participate in the Plan.

## Notes to Financial Statements

### 1. Description of Plan (continued)

#### Contributions (continued)

The Company contributes safe harbor nonelective contributions, which are allocated to each eligible participant in an amount equal to 3% of the participant's eligible compensation. The Company may also make discretionary nonelective and matching contributions. Effective January 1, 2024, there is no service requirement to be eligible for safe harbor nonelective contributions, but participant's must be employed as of the last day of the Plan year to be eligible. The Company made a discretionary profit sharing contribution equal to 3% of compensation for eligible employees. The Company's contribution is invested directly into the investment options selected by the participant. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately fully vested in their contributions, as well as the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions and earnings thereon is based on years of continuous service. Participants become 25% vested for each year of service and are 100% vested after four years of eligible service. Effective January 1, 2024, participants are immediately vested in discretionary nonelective contributions.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of a participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest rates of 5.25% to 9.50%. Loan terms range from one to five years or longer for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

## Notes to Financial Statements

### 1. Description of Plan (continued)

#### Payment of Benefits

On termination of service due to retirement, death, or disability, a participant may elect to receive a lump-sum cash payment, installment payments (only if the participant is subject to lifetime Required Minimum Distributions), or have assets rolled to another retirement plan, if applicable. If the total vested account balance is \$1,000 or less, the entire vested benefit will be distributed to the participant in a lump sum. If the participant's total vested account balance under the Plan is between \$1,000 and \$7,000 as of the termination date and instructions to make a distribution are not made, the vested account balance will be rolled over to an Individual Retirement Account (IRA) selected by the plan administrator. If the total vested account balance exceeds \$7,000, distribution is not required until the age when required minimum distribution rules apply.

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10. These accounts may be used to reduce employer contributions or pay Plan expenses. In 2024, no forfeitures were used to reduce employer contributions or to pay Plan expenses.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Payment of Benefits

Benefits are recorded when paid.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments, other than the fully benefit-responsive stable value fund discussed in Note 3, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors, trustee, and insurance company. See Note 4 for additional discussion of fair value measurements.

### **2. Summary of Significant Accounting Policies (continued)**

#### **Investment Valuation and Income Recognition (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 to August 19, 2025, the Plan did not have any material recognizable subsequent events.

### **3. Stable Value Fund Investment Contract with PGITC**

The Plan is invested in a Stable Value Fund (SVF) provided through an investment contract with Principal Global Investors Trust Company (PGITC). Under the terms of the contract, a crediting rate is established for amounts invested in the SVF and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. Contract value is also often referred to as "book value". This investment option is considered to be fully benefit-responsive notwithstanding the contract provisions that limit the ability of the plan to transact at contract value when a market value event occurs.

### 3. Stable Value Fund Investment Contract with PGITC (continued)

Because the SVF is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the SVF. The SVF is presented on the face of the statements of net assets available for benefits at contract value.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from plan coverage as a result of a temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or sale or discontinuance of all or any part of the Plan sponsor's business. Such events also include: (1) removal from the plan of one or more groups or classifications of participants; (2) partial or complete plan termination; or (3) plan disqualification. Consult your Plan's contract for further information. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

### **6. Tax Status**

The Plan has adopted a non-standardized pre-approved profit sharing plan sponsored by Southern Pension Services. The pre-approved profit sharing plan provider has received an opinion letter from the Internal Revenue Service as to the pre-approved profit sharing plan's qualified status. The pre-approved profit sharing plan opinion letter has been relied upon by this Plan. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

### **7. Accounting for Uncertainty in Income**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Information Certified by Trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate to the best of its knowledge and belief by Reliance Trust Company (the Trustee of the Plan), a qualified institution.

### 10. Related Party Transactions and Party In Interest Transactions

Certain Plan investments are funds managed by Reliance Trust Company. Reliance Trust Company is the trustee of the Plan, therefore these transactions qualify as party in interest transactions. Total fees paid by the Plan for administration and investment services amounted to \$34,441 for the year ended December 31, 2024.
