## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Tudi Mechanical Systems 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Tudi Mechanical Systems 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Tudi Mechanical Systems 401(k) Plan ("Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Tudi Mechanical Systems, Inc., Tudi Mechanical Systems of Tampa, Inc., and OST Services, LLC (collectively "the Company"). The Plan excludes leased employees, union employees, temporary employees, seasonal employees, and independent contractors. The Plan is subject to the provisions of ERISA. The Plan administrator is responsible for the oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan administrator.

Effective August 1, 2023, OST Services, LLC executed a participation agreement and became a participating employer in the Tudi Mechanical Systems 401(k) Plan.

#### Eligibility

Employees of the Company are eligible to participate in the Plan once they have reached 60 days of employment where 83.33 hours are worked each of these two months.

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed annuity contract as investment options for participants.

The Plan was previously amended to automatically enroll participants in the Plan, after eligibility requirements are met, at a deferral rate of 2%, with increases of 1% annually on the first day of each Plan year, not to exceed 8% unless affirmed otherwise by the participant, for all new hires of the Company.

The Company may make discretionary matching contributions at a percentage determined at management's discretion, but not to exceed 2% of a participant's compensation. For the years ended December 31, 2024 and 2023, the Company elected to make matching contributions of 100% up to 2% of a participant's eligible compensation contributed to the Plan. Discretionary matching contributions totaled \$292,742 and \$264,441 for the years ended December 31, 2024 and 2023, respectively. The Company may also make a discretionary profit sharing contribution, as determined by management. Discretionary profit sharing contributions totaled \$418,519 and \$374,135 for the years ended December 31, 2024 and 2023, respectively.

#### Contributions (Continued)

The following allocations, by group, are used to calculate the discretionary profit sharing contributions (if any):

- Group One: Allocation group one consisted of residential installers and received an allocation of \$0.50 for each qualifying hour of service.
- Group Two: Allocation group two consisted of office administrative employees, office clerical employees, and office managerial employees. Members of group two received an allocation of \$0.60 for each qualifying hour of service.
- Group Three: Allocation group three consisted of design build helpers and commercial entry-level employees. Members of group three received an allocation of \$0.75 for each qualifying hour of service.
- Group Four: Allocation group four consisted of residential installation installers and residential service technicians. Members of group four received an allocation of \$1.00 for each qualifying hour of service.
- Group Five: Allocation group five consisted of residential installation crew leaders and residential service systems analysts. Members of group five received an allocation of \$1.50 for each qualifying hour of service.
- Group Six: Allocation group six consisted of commercial technicians and design build installers. Members of group six received an allocation of \$1.65 for each qualifying hour of service.
- Group Seven: Allocation group seven consisted of commercial systems analysts and design build crew leaders. Members of group seven received an allocation of \$2.00 per qualifying hour of service.

Qualifying hours of service for the discretionary profit sharing contribution exclude vacation, holiday, and personal hours. Qualifying hours of service for the purpose of calculating the additional profit sharing contribution are limited to 2,080 per Plan year for managerial, administrative, and office support personnel. There is no limit on qualifying hours of service for field personnel. In order to share in the allocation of the discretionary profit sharing contribution for a Plan year, participants must be employed on the last day of the Plan year, unless termination is result of death, disability, retirement, including early retirement.

The Company makes prevailing wage contributions to the Plan for services performed during the Plan year under the prevailing wage law. The contribution for each employee considered a prevailing wage employee is based on the hourly contribution rate required under the applicable prevailing wage law for the respective employee's classification on each contract at which prevailing wage services are being performed. Prevailing wage contributions totaled \$89,273 during the year ended December 31, 2024, as required. There were no prevailing wage contributions for the year ended December 31, 2023.

Contributions are subject to certain Internal Revenue Service limitations.

### NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

#### Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions and prevailing wage contributions plus actual earnings thereon. Vesting in the discretionary matching and profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on qualifying years of service, at 20% per year beginning after two years of service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death or permanent disability.

#### Notes Receivable from Participants

The Plan does not permit notes receivable from participants.

#### Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, the Plan allows for hardship distributions if certain criteria are met.

#### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,269 and \$11,308, respectively. The Plan may use these accounts to pay Plan expenses and to reduce employer contributions. Also, in 2024, employer contributions were reduced by \$64,978 from forfeited nonvested accounts.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation and participant compensation is paid, respectively.

#### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction reported as corrective distributions. The Plan distributed the 2024 excess contributions to the applicable participants before March 15, 2025.

#### Payment of Benefits

Benefit payments are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

### NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan offers a fully benefit-responsive guaranteed annuity contract with Empower Annuity Insurance Company of America that comprises a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without consent of the issuer.

### NOTE 5 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

Certain information related to the investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan.

### NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower Annuity Insurance Company of America and/or Empower Trust Company, LLC (collectively "Empower") in connection with an insurance product utilized by the plan and custodial and recordkeeping services provided to the Plan. These transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services were netted against the net appreciation in fair value of investments for the year ended December 31, 2024. Fees incurred by the Plan for the custodial and record keeping services amounted to \$86,602 and are included in administrative expenses for the year ended December 31, 2024.

Investment income from investments sponsored and/or managed by Empower included in changes in net assets available for benefits for the year ended December 31, 2024 amounted to \$3,354,475. These transactions are exempt from the prohibited transaction rules of ERISA.

The Plan's service providers receive revenue from mutual fund service providers for services provided to the funds. This revenue may be used to offset certain amounts owed to these providers for administrative services provided to the Plan. If the revenue received by the service providers from such mutual fund service providers exceeds the amount owed as agreed to by the service providers and the Plan for administrative services, the service providers or their affiliates are to remit the excess to the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants.

During the year ended December 31, 2024, approximately \$47,000 was deposited into the Plan. The Plan or the Company may make a payment to service providers or their affiliates for administrative expenses not covered by revenue sharing. As of December 31, 2024, there were no amounts representing unallocated revenue sharing accounts available to pay Plan expenses and/or to allocate to participants.

### NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all employer contributions.

### NOTE 8 - TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### NOTE 10 - CONCENTRATIONS

Approximately 39% and 40% of the Plan's investments were concentrated between two investment options under the trust arrangement established by the Plan at December 31, 2024 and 2023, respectively.

### NOTE 11 - SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. During 2024, various mandatory provisions became effective. The Plan has complied with such provisions with no significant impact to the Plan. Additionally, during 2024, various optional provisions became effective, however, the Plan did not elect to adopt the optional provisions. Certain additional provisions become effective in 2025 and thereafter. Accordingly, there is no material impact to the Plan's 2024 and 2023 financial statements.

### NOTE 12 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 29, 2025, the date the financial statements were available to be issued.
