**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of Killbuck Savings Bank Company 401(k) (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering the employees of The Killbuck Savings Bank Company (the “Company”). The Plan includes a 401(k), before-tax savings feature, which permits all employees to defer compensation under Section 401(k) of the Internal Revenue Code. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Employees are eligible to participate in the Plan and make elective deferral contributions upon completion of 60 days of service and the attainment of age 21. Employees become eligible to receive employer matching and nonelective contributions after completing one year of service. Participants will actually participate once they have reached the entry date. The entry date will be the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Contributions

Employees may elect to contribute, through the 401(k) feature, a percentage or dollar amount of their compensation and have that amount contributed to the Plan on a pre-tax basis. Employees may elect to have their contributions invested in a variety of mutual funds and investment vehicles held in the trust. In addition, the employer may make a discretionary matching contribution equal to a uniform percentage or dollar amount of the employee’s elective deferrals each Plan year. Matching contributions begin on the first of the month after completing (1) year of service. Each year, the employer will determine the formula for the discretionary matching contribution.

Vesting

Employees are always 100 percent vested in their accounts attributable to the following contributions: elective deferrals, including catch-up contributions and rollover contributions. An employee’s “vested percentage” of employer contributions is based on vesting years of service. This means at the time the employee stops working, the account balance attributable to contributions subject to a vesting schedule is multiplied by the employee’s vested percentage. Employees become vested as follows: 0 percent for/at less than 2 years; 20 percent after 2 years; 40 percent after 3 years; 60 percent after 4 years; 80 percent after 5 years; and 100 percent after 6 years.

Administrative Expenses

Administrative expenses of the Plan relating to investment management, recordkeeping, accounting fees and miscellaneous expenses are paid by the Plan sponsor and/or the Plan.

Payments of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account or a rollover distribution. Benefit payments to participants are recorded upon distribution.

Forfeitures

If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures will be allocated as follows: forfeitures attributable to nonelective contributions will be allocated as an additional discretionary nonelective contribution, and forfeitures attributable to matching contributions will be allocated as an additional discretionary contribution. At December 31, 2024 and 2023, forfeited accounts totaled \$33,251 and \$64,304, respectively. Amounts totaling \$62,690 were reallocated in the current year.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accounting principles followed by the Plan and the methods of applying these principles conform to U.S. generally accepted accounting principles.

A summary of the significant accounting and reporting policies applied in the presentation of the accompanying financial statements follows:

Accounting Estimates

In preparing the financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ significantly from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices are used to value investments. Investments for which there are no quoted market prices are reported at their estimated fair value. The net appreciation (depreciation) in fair value of investments includes investments purchased, sold, and held during the year. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investments in insurance company contracts are reported at contract value as determined by the insurance company if the contract is fully benefit responsive or otherwise at fair value. The insurance product, Key Guaranteed Portfolio Fund, is not fully benefit responsive since the investment contract contains a provision that prevents the immediate and full payout of the contract value for Plan initiated transactions.

**NOTE 3 – INVESTMENTS**

The Plan investments are administered by both Empower Annuity Insurance Company of America and Empower Trust Company, LLC (“Custodians”). The following is a summary of the investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information provided by the Custodians and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Custodians stating that information provided to the Plan Administrator by the Custodians related to the following investments is complete and accurate. Accordingly, as permitted by CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator elected to have an ERISA Section 103(a)(3)(c) audit and instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule, related to investments:

**NOTE 4 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100 percent vested in their accounts.

**NOTE 5 – TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Custodians by letter dated November 14, 2022, that the Plan, a prototype non standardized profit-sharing plan and related trust is designed in accordance with applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Management of the Plan is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

The Company absorbs certain costs incurred in relation to the administration of the Plan. Such costs may pertain to legal and accounting issues. These expenses totaled \$8,000. In addition, some of the investment products are mutual funds and a fixed annuity contract that are offered by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

**NOTE 7 – FAIR VALUE OF FINANCIAL INSTRUMENTS**

The Plan discloses the estimated fair value of its financial instruments in accordance with FASB ASC Topic 825, *Financial Instruments*. Financial instruments are defined as cash, evidence of ownership in an entity, or a contract that creates an obligation or right to receive or deliver cash or another financial instrument from/to a second entity on potentially favorable or unfavorable terms. Fair value is defined as the amount at which a financial instrument could be exchanged in a current transaction between willing parties other than in a forced liquidation or sale. If a quoted market price is available for a financial instrument, the estimated fair value would be calculated based upon the market price per trading unit of the instrument. Investments would be considered financial instruments. At December 31, 2024, the carrying amount of these financial instruments approximates fair values.

**NOTE 8 – FAIR VALUE MEASUREMENTS**

The Plan utilizes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and lowest priority to unobservable inputs. The three levels of the fair value hierarchy under ASC 820 are described below:

- \* *Level I:* Inputs to the valuation methodology are unadjusted quoted prices for assets or liabilities in active markets that the Plan has the ability to access.
- \* *Level II:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.
- \* *Level III:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Annuity contracts:* The reported values for fixed and variable annuity options are reported daily based on the valuation method disclosed in the insurance contract, as calculated by the annuity provider.

*Collective Trust Funds:* The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund or accounts will sell the investment for an amount different than the reported NAV.

**NOTE 10 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024, the Plan had investments of \$3,392,128 that were concentrated in Fidelity 500 Index Fund and \$1,691,761 that were concentrated in Fidelity International Index Fund. As of December 31, 2023, the Plan had investments of \$2,544,543 that were concentrated in Empower S&P 500 Index Fund.
