- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Bodensteiner Implement Company Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedule Required by ERISA

The supplemental schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 PLAN DESCRIPTION

The following description of the Bodensteiner Implement Company Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Bodensteiner Implement Company (the Employer), who meet the eligibility requirements. It is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees who are 20 years of age or older are eligible to participate in the plan and contribute elective deferrals on the first day of the month following 30 days of service. Participants become eligible for employer contributions on March 1st or September 1st following 6 months of service.

Contributions

Participants may elect to contribute a portion of their pre-tax compensation up to the maximum percentage allowable, with special elections for participants aged 50 and older, not to exceed the limitations of IRS Code Section 401(k). Participants also have the option to contribute post-tax compensation through Roth 401(k) contributions. In addition, participants may also contribute amounts representing distributions from other qualified plans. Based upon a formula outlined in the Plan document, the employer may match a percentage of the participant's contribution equal to a discretionary percentage determined by the employer, which was 50% of contributions up to the first 4% of pay for the year ended December 31, 2023 and 50% of contributions up to the first 6% of pay for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's contribution and an allocation of Plan earnings or losses, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately 100% vested in all contributions plus actual earnings thereon.

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and common/collective trust funds. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance in accordance with Plan document restrictions. Principal and interest is paid ratably through payroll deductions. Loan terms will not exceed five years unless the loan is used to purchase a primary residence. The term for a home loan will be established by the Plan Administrator at the time of the loan. The loans are secured by the vested portion of the participant's account and bear interest at Prime + 1.0% at the time of the loan, which range from 6.25% to 9.50%.

Notes Receivable from Participants (continued)

In accordance with the Plan Document, loans are considered to be in default if any scheduled loan repayment is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. Defaulted loans will be reported as taxable deemed distributions in the year in which default occurs. During the years ended December 31, 2024 and 2023, there were \$-0- and \$1,379, respectively, in deemed distributions.

Distribution of Benefits

Upon retirement, death, or termination of service, a participant may receive the value of the vested interest in his or her account as a lump sum in the form of a non-rollover or direct rollover distribution.

The Plan allows for hardship withdrawals to participants who meet an immediate and severe financial need, and are limited to a participant's vested account balance.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES (continued)

Payment of Benefits

Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

Administrative Expenses

Certain administrative functions are performed by employees of the Plan Administrator. No such employee receives compensation from the Plan. Certain other administrative expenses, including the trustee fees and audit fees, are paid directly by the Plan Administrator. Fees to the Plan's Third Party Administrator are paid directly by the Plan and totaled \$91,444 and \$76,525 for the years ended December 31, 2024 and 2023, respectively.

Uncertain Tax Positions

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 PLAN TERMINATION

Although it has not expressed the intent to do so, the employer has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to the accounts of each participant will be distributed in accordance with the terms of the Plan.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2—Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds—Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds—The common/collective trust funds are composed primarily of fully benefit-responsive investment contracts and are valued at the net asset value of units of the issuer's collective trust. The net asset value is used as the practical expedient to estimate the fair value.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

NOTE 6 INCOME TAX STATUS

The Plan has adopted a prototype plan document and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan itself has not received a determination letter from the IRS, and the prototype plan has been amended since receiving the opinion letter, the prototype sponsor and plan administrator believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of accounts managed by Bankers Trust Company. Under an agreement between Bankers Trust Company and the Plan, Bankers Trust Company has been designated as the trustee over the Plan's investments. Therefore, investment transactions between the Plan and Bankers Trust Company-managed accounts qualify as party-in-interest transactions.

The Plan's administrator participates in the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 RISKS AND UNCERTAINTIES

Participants invest their account balances in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through July 24, 2025, the date which the financial statements were available to be issued. There were no subsequent events required to be accrued or disclosed.
