Scope And Nature Of The ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Metro East Industries Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Metro East Industries Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis For Opinion

Responsibilities Of Management For The Financial Statements

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of the Metro East Industries Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan, which has been adopted by Metro East Industries, Inc. (the Company), is a defined contribution profit sharing plan that includes a 401(k) provision. The Plan covers all employees of the Company who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may defer between 1% and 50% of eligible compensation, subject to Internal Revenue Code (IRC) limitations. Participants age 50 or older are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provides for Company discretionary matching contributions, which are made at the discretion of the Board of Directors. The Company matched 36% of participants' contributions to the Plan in 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of the Plan's earnings. The allocation of earnings is determined by the earnings of the participant's investment selection based on each participant's account balance, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivable From Participants

Participants may borrow from their accounts. Notes are issued in any amount of \$1,000 or more, but less than 50% of the participant's vested account balance. In no event can the participant borrow more than \$50,000. Notes are for a period not exceeding five years unless used to acquire a principal residence. The length of repayment for a loan related to a principal residence shall coincide with the commercial residence lending agreement. Notes bear interest at an agreed-upon percentage based on prevailing market rates. Participants may only have one loan outstanding at any time. Principal and interest are paid ratably through payroll deductions.

METRO EAST INDUSTRIES RETIREMENT SAVINGS PLAN

Notes To Financial Statements (*Continued*)

The participant notes receivable are secured by participants' vested account balances. The notes bear interest between 5% and 8% per year and are due at various dates through October 2029.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is partially vested after two years of credited service and 100% vested after five years of credited service.

Forfeitures

Forfeitures may be used to offset administrative expenses or to reduce matching contributions after the forfeiture is determined. Forfeitures used to offset administrative expenses amounted to \$5,762 and \$3,710 for the years ended December 31, 2024 and 2023, respectively. There were no forfeitures available at December 31, 2024 or 2023.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any of several investment options offered by Principal Life Insurance Company (Principal).

Administrative Expenses

Significant administrative expenses are paid by the Company.

Payment Of Benefits

Upon termination of service, death, disability, or attaining age 59-1/2, a participant may make withdrawals from his or her salary deferral account. A participant may withdraw part of his or her salary deferral contributions for financial hardship reasons.

The normal form of retirement benefit is a lump sum rollover or cash distribution. Qualified optional forms of benefit include various annuities.

In the event that the vested portion of a terminated participant's account has never exceeded \$5,000, the balance shall be distributed in a lump sum as soon as administratively feasible.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation And Income Recognition

Investments in the flexible investment group annuity contract with Principal are reported at fair value. Fair value is the price that would be received to sell an asset or to pay a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment custodians and insurance company. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment contracts held by a defined contribution plan are generally reported at contract value except for those contracts that are non-fully benefit-responsive. In that instance, these contracts are required to be reported at fair value.

The Plan's investment in Principal's guaranteed interest accounts are not fully benefit-responsive investment contracts and are reported at fair value in the statement of net assets available for benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at the unpaid principal balance plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan Agreement.

Payment Of Benefits

Benefits are recorded when paid.

Contribution Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Subsequent Events

Management has evaluated subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Financial Information

Certain information related to investments and investment income (loss) disclosed in the accompanying financial statements and supplemental schedule, as of and for the years then ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal.

4. Fair Value Measurements

The Plan utilizes a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value:

Pooled Separate Accounts

Valued at net asset value (NAV) of units held by the Plan at year end. The NAV, as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are comprised, primarily, of shares of mutual funds that are traded on an active market. There are no unfunded commitments related to these investments and the investments are redeemable daily at the adjusted NAV under agreements with the insurance company. However, it is possible that the redemption rights may be restricted or eliminated in the future. All of the pooled separate accounts held by the Plan file an annual report on Form 5500 as a direct filing entity.

Guaranteed Interest Account

The Principal Guaranteed Interest Account (GIA) cannot be sold to a third-party, thus, the only option to exit the GIA is to withdraw the funds prior to maturity. The fair value is the discontinuance value, which is the amount the participant would receive if they transfer or surrender their funds out of the guaranteed interest account prior to maturity. The fair value of the GIA is computed using a combination of the current interest rates based on remaining investment terms at the reporting date, as well as the interest rate on account. If the applicable interest rate is greater than the interest rate on the account, the fair value is the contract value reduced by a percentage. This percentage is equal to the difference between the applicable interest rate and the interest rate on the account, multiplied by the years (including fractional years) until the maturity date. If the applicable interest rate is equal to or less than the interest rate on the account, the fair value is equal to the contract value.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Tax Status

Effective February 18, 2022, the Plan was restated with a pre-approved defined contribution plan document sponsored by Principal Financial Group. Principal Financial Group received an updated opinion letter from the IRS dated June 30, 2020.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Transactions With Parties In Interest

Certain Plan investments are managed by Principal or an affiliate of Principal. In addition, at December 31, 2024 and 2023, the Plan had notes receivables from participants. Certain fees for administration of the Plan are paid by the Plan through agreements with various service providers. These fees are based on customary and reasonable fees.

These transactions qualify as exempt parties in interest transactions under ERISA.
