Opinion

Note 1 PLAN DESCRIPTION AND BASIS OF PRESENTATION

The following brief description of the Foldcraft Co. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete information.

Plymold Inc. (the Company) established the Foldcraft Co. Employee Stock Ownership Plan (Plan) effective as of January 1, 1985. As of January 1, 2015, the Plan was amended and restated and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Security Act of 1974 (ERISA). The Plan is administered by the Plan sponsor. The Plan Trustees are responsible for the oversight of the Plan and report to the Company's Board of Directors.

ELIGIBILITY

Employees of the Company are generally eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours during such plan year. The Plan excludes leased employees, employees covered by collective bargaining agreements, and certain nonresident aliens.

CONTRIBUTIONS

Each year, the Company may contribute a discretionary contribution to the Plan as determined annually by the Company's Board of Directors. Contributions may be in the form of shares of common stock or cash. Contributions for each year are never less than the amount required to enable the Plan to discharge its current obligations as defined in the Plan, without regard to whether some or all of such contribution may fail to qualify for an income tax deduction by the Company. In order to receive an allocation of Company contributions, a participant must complete 1,000 hours of service and be employed on the last day of the Plan year unless termination is due to death, disability or retirement. Contributions by Plan participants are not permitted by the Plan. Contributions are subject to limitations as defined under the Internal Revenue Code (IRC).

PAYMENT OF BENEFITS

Distributions on account of death, disability, or retirement may be made in a lump sum, partial lump sum, or installments in the Plan year following the event. Distributions for other separations of service commence in the fifth Plan year following the separation from service and are made in twenty quarterly installments. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash, or if the participant elects, in the form of Company common stock plus cash for any fractional share of common stock. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

ADMINISTRATIVE EXPENSES

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company.

VOTING RIGHTS

The Plan Trustees will vote all Company stock held by it as a part of the Plan assets at the direction of the Administrator, provided that participants and or beneficiaries will be entitled to direct the Trustees as to the manner in which voting rights on shares of Company stock which are allocated to their accounts are to be exercised (a) with respect to any corporate matter which involves the voting of such shares with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transaction, and (b) with respect to all corporate matters if, at the time of the vote thereon, the Company stock is a “registration-type” class of securities. If a participant is eligible to vote on a matter and does not timely exercise the right to vote, the Trustees, at the direction of the Administrator, will vote such Company stock.

PARTICIPANT ACCOUNTS

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited as of the last day of each Plan year with an allocation of the Company’s contribution, plan earnings or losses, and forfeitures of terminated participants’ nonvested accounts. Allocations of contributions and forfeitures are based on a participant’s eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant’s account based on the ratio of the participant’s account balance.

VESTING

If a participant’s employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants vest after two years of service at a rate of 20 percent per year and are 100 percent vested after 6 years of service.

PUT OPTION

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

DIVERSIFICATION

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent, less any shares previously diversified.

FORFEITURES

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures are allocated to participants who have completed a year of service and are employed on the last day of the Plan year. Forfeitures allocated to participants during December 31, 2024 totaled 195 shares and \$16,068. There were no unallocated forfeited non-vested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023.

Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in accordance with generally accepted accounting principles require management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The shares of company common stock are valued at fair value. See Note 4 for discussion of fair value measurements.

Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

DISTRIBUTIONS PAYABLE

The Plan has recorded a liability representing amounts payable to participants for eligible distributions as of the year ended December 31, 2024 and 2023.

SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued.

Note 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The appraiser took into account historical and projected cash flow, net income and market comparable (public company and private comparable transactions). Plan management has concluded that a market participant would also recognize a discount for lack of marketability and premium for control. As illustrated in the following table:

The valuation process involves the Trustees’ selection of an independent appraiser. Management accumulates the data for the appraiser from the historical and projected financial information of the Company. The appraiser prepares a preliminary report which the Trustees review in detail, discusses and makes a formal recommendation to the Board of Directors to approve the final valuation. The results of this process are documented in the Plymold Inc. Board of Director’s minutes.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock. This is a related-party and party-in-interest transaction. As described in Note 1, the Company pays most plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

Note 6 RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 7 PLAN TERMINATION

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Plan Administrator directs the Trustees to pay all liabilities and expenses of the ESOP. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

Note 8 TAX STATUS

The Plan has received a determination letter from the IRS dated December 31, 2015, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
