### Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

In preparing the financial statements, Plan management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Turn 5, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Plan management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Turn 5, Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by Plan management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Turn 5, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of Plan management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that Plan management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. Description of Plan**

The following description of the Turn 5, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that was established January 1, 2007, for the exclusive benefit of the employees of Turn 5, Inc. (the "Plan Sponsor" or the "Company") and affiliated adopting employers. Collectively bargained employees, non-resident aliens, and leased employees are excluded from the Plan. Management of the Plan Sponsor controls and manages the operation and administration of the Plan. Ascensus Trust Company serves as the trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

During March 2023, the Eckler Industries, Inc. 401(k) Profit Sharing Plan & Trust was merged with and into the Plan. As a result, total plan assets of \$4,086,741, inclusive of participant loans of \$25,951 were transferred into the Plan (see Note 9).

**Contributions**

Eligible employees ("participants"), those employees who are at least 18 years of age and have obtained three months of service, may contribute a portion of their compensation, as defined, subject to certain Internal Revenue Code ("IRC") limitations. In addition, participants who have attained age 50 before the close of the Plan year are eligible to make "catch-up" contributions up to the amount allowable under the IRC. Participants may also make deferrals to the Plan on an after-tax basis in accordance with the Roth 401(k) provisions of the Economic Growth and Tax Reconciliation Act of 2001.

The Company provides a 401(k) safe harbor employer matching contribution. The safe harbor matching contribution is 100% of the first 3% of an active participant's eligible compensation contributed to the Plan and 50% of the next 2% of an active participant's eligible compensation contributed to the Plan. The Company may also contribute an employer profit sharing contribution. No employer profit sharing contributions were made during 2024 or 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

**Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Plan Sponsor's contributions, Plan earnings, as well as allocations of employer profit sharing contributions, if any. Participant accounts are charged with withdrawals and an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments**

Participants direct the investment of their contributions, the Plan Sponsor's contributions, and profit sharing contributions, if any, into various investment options offered by the Plan. The Plan currently offers various mutual funds (registered investment companies) as investment options to the Plan.

**Vesting**

Participants are vested immediately in their contributions, safe harbor matching contributions plus actual earnings thereon. Vesting in the discretionary matching contributions and employer profit sharing contributions portion of their accounts is based on years of continuous service. A participant vests in the employer profit sharing contributions and previously available discretionary matching contributions at the rate of 20% for each year of service.

Notwithstanding the above vesting for the discretionary matching contributions and employer profit sharing contributions portion of their accounts, a participant will become 100% vested in these accounts upon their attainment of normal retirement age (65) while an employee, death while an employee, or becoming disabled while an employee.

**Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,695 and \$1,969, respectively. These accounts may be used to pay expenses or to reduce future employer contributions. During the years ended December 31, 2024 and 2023, \$4,228 and \$2,609, respectively, were used to pay expenses. During the years ended December 31, 2024 and 2023, \$0 and \$38,126, respectively, were used to reduce employer contributions.

**Notes Receivable from Participants**

Loans to participants are permitted under the Plan and are treated as a participant directed investment. The minimum loan is \$1,000. The maximum loan available is the lesser of \$50,000 or 50 percent of the participant's vested account balance. A participant may only have one loan outstanding at any time. All outstanding loans become due and payable in their entirety upon the occurrence of a distributable event (other than satisfaction of the conditions for an in-service distribution). Participant loans bear interest at a fixed rate, commensurate with local prevailing rates as of the date of the loan, which approximates the prime interest rate plus 1%. The interest rate on loans as of December 31, 2024 was 4.25% through 9.50%.

Loans are repayable within five years unless the loan was taken for the purpose of acquiring the participant's principal residence, in which case the term of the loan may be for a period longer than five years. Principal and interest are paid ratably through payroll deductions. The loans are secured by the balance in the participant's account.

**Benefit Payments**

Plan participants may elect to receive a distribution of vested benefits following termination of employment or the attainment of normal retirement age under the Plan. If a participant's vested account in the Plan is below \$1,000 at the time of termination or retirement, the Plan may distribute the entire balance to the participant following termination, or if no election is made by the participant, to an individual retirement account established on the participant's behalf. If a participant's vested account in the Plan is between \$1,000 and \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022) at the time of termination or retirement, the Plan may distribute the entire balance to an individual retirement account established on the participant's behalf. In addition, minimum payments must begin subject to Internal Revenue Service ("IRS") guidelines. Hardship, disability and in-service distributions are also permitted from participant accounts.

**2. Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's oversight committee determines the Plan's valuation policies utilizing information provided by the trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions**

Contributions from Plan participants and 401(k) safe harbor employer matching contribution from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

All reasonable administrative expenses, including trustee and third party administration fees necessary to operate and administer the Plan, are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses of maintaining the Plan that are paid directly by the Plan Sponsor are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Management fees and operating expenses associated with investments in the mutual funds are deducted from income earned by these funds on a daily basis and are not separately reflected. Consequently, management fees and operating expenses associated with investments are included in the net appreciation in fair value of investments.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants as reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The information for all mutual funds and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024 as shown in the ERISA-required supplemental schedule.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

**5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts, and all remaining assets in the Plan are to be distributed to the participants by the trustee in accordance with the accrued benefits of such participants as of the date of termination.

**7. Tax Status**

Effective January 1, 2023, through the adoption of an Ascensus, LLC Pre-Approved Defined Contribution Plan, the Plan was amended and restated. The IRS issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable IRC requirements. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. Related-Party and Party-in-Interest Transactions**

For the years ended December 31, 2024 and 2023, the Plan paid fees to the Vanguard Group, Inc. ("Vanguard") of \$44,774 and \$48,634, respectively. Vanguard provides recordkeeping services and the Plan invests in mutual funds managed by Vanguard. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance. Therefore, those transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

**9. Plan Amendments**

Effective January 1, 2023, the Plan was amended and restated to clarify the protected benefit provisions of the Plan related to former participants in the Eckler Industries, Inc. 401(k) Profit Sharing Plan & Trust and to make other administrative changes to the Plan.

**10. Subsequent Events**

Management evaluated subsequent events for the Plan through August 19, 2025, the date the financial statements were available to be issued.
