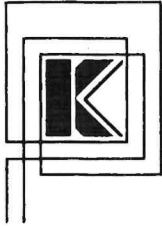

INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TrueScripts Management Services, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefit for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of TrueScripts Management Services, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We are required to be independent of TrueScripts Management Services, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about TrueScripts Management Services, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

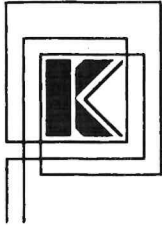

INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TrueScripts Management Services, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). NOTE 1-PLAN DESCRIPTIONThe following brief description of the TrueScripts Management Services, LLC 401 (K) Plan, retirement Plan provides only general information. Participants should refer to the Plan agreement for more a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan which covers all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income and Security Act of 1974 (ERISA).

CONTRIBUTIONS

Participants may contribute any percentage up to the IRS annual maximum limit. The maximum contribution allowed for each participant for the calendar year 2024 and 2023 is \$23,000 and \$22,500, respectively. For age 50 and over, the IRS limits participant contributions up to a maximum of \$30,500 and \$30,000 in 2024 and 2023, respectively. The Company may contribute additional amounts at the option of the Company's Board of Directors.

PARTICIPANT ACCOUNTS

Each Plan participant has three separate accounts within the Plan:

DEFERRAL ACCOUNT

Consists of both pre-tax elective deferral contributions and Roth elective deferral contributions made by employees and the corresponding earnings on these contributions. Profit sharing can be contributed at the option of the owners annually.

PROFIT-SHARING ACCOUNT

Consists of employer's discretionary contributions and the corresponding earnings on these contributions. Profit sharing can be contributed at the option of the owners annually.

ROLLOVER ACCOUNT

Consists of new participant's vested fund balances rolled over from a prior retirement plan as well as the corresponding earnings on these balances.

NOTE 1-PLAN DESCRIPTION (CONTINUED)

INVESTMENT OPTIONS

Participants may direct the investment of their account balances in any of the investment options. Participants may change their investment options at anytime.

PAYMENT OF BENEFITS

On termination of service for any reason, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in the form of an installment.

VESTING

Employees are immediately vested in their voluntary contributions and Company contributions plus actual earnings thereon. There is a vesting schedule per the plan document for profit sharing.

FORFEITURES

Forfeitures are allocated to participants at the end of the fiscal year as calculated. Forfeitures are netted against the employer match contributions as available.

ADMINISTRATIVE EXPENSES

All trustee expenses incurred by the Plan are the responsibility of the Plan. However, at the discretion of the Plan Sponsor, some expenses may be paid by the Plan Sponsor.

RISKS AND UNCERTAINTIES

The Plan holds various investment instruments, including but not limited to, mutual funds and money market funds. Investment securities, in general are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and such changes can materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 2-SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual method of accounting.

VALUATION OF INVESTMENTS

The Plan's investments are stated at fair value. Quoted market prices are used to value investments.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

DATE OF MANAGEMENT'S REVIEW

Management has evaluated subsequent events through August 12, 2025, the date on which the financial statements were available to be issued.

NOTE 3-TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

Note 6 - FAIR VALUE MEASUREMENTS:

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Common stocks, corporate bonds and U. S. Government securities: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the plan at year end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
