### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of East Texas Financial Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the East Texas Financial Corporation 401(k) (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**GENERAL**

East Texas Financial Corporation (Company) established a defined contribution 401(k) plan effective January 1, 1992, that covers employees of the Company who have completed three months or more of service and are age twenty-one or older. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). Participants may enter the Plan on the first day of the calendar month coincident with or following the satisfaction of the eligibility requirements.

**PLAN ADMINISTRATION**

All plan assets and record keeping services are performed by Fidelity Management Trust Company (Fidelity). Employees of the Company perform certain other administrative functions; however, such employees receive no compensation from the Plan. The Plan Administrator oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**CONTRIBUTIONS**

A participant may elect to defer a percentage of his or her pre-tax or post-tax compensation, subject to certain maximum limitations imposed by the Internal Revenue Code (IRC). Participants that reach age fifty before the close of the Plan year can make catch-up contributions. Participants may also make eligible rollover contributions. The Plan also includes an automatic enrollment provision that requires an automatic contribution of 4% of compensation upon the participant's entry date unless the eligible employee affirmatively elects otherwise.

The Company has an option to provide matching contributions equal to a matching percentage which the Company, from time to time, deems advisable. To receive the matching contribution for a Plan year, the employee must have made match-eligible contributions during the Plan year. The Company will not match elective contributions in excess of 6% of a participant's compensation each Plan year. For the year ended December 31, 2024, the Company provided a 50% match for eligible contributions up to 6% of eligible compensation.

In addition, the Company may make a discretionary profit sharing contribution as determined by the Company's Board of Directors. Allocations are based upon a participant's classification as either a member of one of three management classes or all other employees. For the year ended December 31, 2024, members of Management Class 1, Management Class 2, Management Class 4 and all other employees received a profit sharing contribution of 6%, 5%, and 2% of eligible compensation, respectively.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution and an allocation of (1) the Company's matching and profit sharing contributions and (2) Plan earnings (losses) and is charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**PAYMENT OF BENEFITS**

Participants are entitled to the benefits that can be provided from their vested individual account balances upon death, disability, termination of service or normal retirement, as defined by the Plan agreement. Terminated employees with participant vested balances of \$1,000 or less are distributed directly to the participant by the Plan Administrator. Balances in excess of \$1,000, but not greater than \$7,000, will be rolled over into an individual retirement account by the Plan Administrator. Hardship withdrawals are allowed at any time under the Plan from participant salary deferrals for qualified expenses, subject to self-certification of financial hardship by the participant in connection with SECURE 2.0 Act. The minimum hardship distribution is \$500.

**VESTING**

Participants are immediately vested in their voluntary contributions and rollover contributions, plus actual earnings thereon. Vesting is based on the elapsed time method from the date of hire. Vesting percentages in employer contributions and match are as follows :

Full vesting also occurs at retirement, death or disability.

**PARTICIPANT LOANS**

Participants may borrow, from their own account a minimum of \$1,000, up to the lesser of \$50,000 or fifty percent of their vested account balance. Loans are charged at a rate of interest equal to the current prime lending rate plus two percent. These loans must generally be repaid through payroll deductions within five years, are pre-approved and processed and administrated automatically by Fidelity. Loans used for the purchase of a participant's principal residence require the approval of the Plan Administrator and provide for extended amortization up to ten years. Only one loan is permitted at a time, and participant charges are assessed for loan initiation and administration.

**PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**FORFEITED ACCOUNTS**

Under the provisions of the Plan, a participant who terminates employment before becoming vested in the employer's matching or profit sharing contribution forfeits these amounts when any vested amounts are distributed. Forfeitures of matching and profit sharing contributions are first used to pay administrative expenses and then are used to reduce employer matching and profit sharing contributions. The Plan utilized \$12,086 to reduce administrative expenses for the year ended December 31, 2024. The Plan utilized \$10,000 to reduce employer contributions for the year ended December 31, 2024. The unallocated forfeitures balance was \$17,911 and \$21,964 as of December 31, 2024 and 2023, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared using the accrual method of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded based on the terms of the Plan document.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**ADMINISTRATIVE EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 - INCOME TAX STATUS**

The Plan has adopted a volume submitter plan which received a favorable opinion letter from the Internal Revenue Service (IRS) that the form of the plan is acceptable under Section 401(a) of the Internal Revenue Code (IRC). The Plan had been amended and restated. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan administrator and Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds:*

Valued at the per unit price as quoted by the financial institution.

*Money market and mutual funds:*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

*Self-directed brokerage accounts:*

Accounts consist of interest bearing cash equivalent funds and common stocks, which are valued on the basis of readily determinable market prices.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Professional fees related to custodial services for the Plan's assets paid by the Plan to Fidelity totaled \$6,076. Certain investments of the Plan are managed by Fidelity Management & Research Company, a related party to Fidelity. Additionally, Fidelity administers notes receivable from participants, who are also parties-in-interest. Fidelity is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Administrative expenses not paid by forfeited funds are paid by the Company and certain employees of the Company provide administrative services to the Plan without compensation.

All of these transactions are exempt from the prohibited transactions rules under ERISA.
