Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Anniversary Holding Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

Notes To Financial Statements

(1) Plan Description

The Anniversary Holding Company 401(k) Plan (the "Plan") is a defined contribution plan originally established January 6, 2022. The Plan covers all eligible employees of Anniversary Holding Company (the "Company"), as defined in the Plan document. The Plan complies with the applicable provisions of the Employee Retirement Income Security Act of 1974.

The Plan allows eligible participants to elect to defer a portion of their compensation as a contribution to the Plan. Employer matching contributions are made at management's discretion, as elected on an annual basis. Participants are vested immediately in their contributions. Employer contributions are vested in accordance with a 2-6 year graded schedule.

The Plan allows participants to direct employee and employer contributions into various investment options offered by the Plan. Participants may change their investment options in accordance with the Plan document.

Each participant's account is credited with the participant's contribution, the employer's contribution, and allocations of plan earnings and administrative expenses, which are based on participant earnings or account balances, as defined.

Participants are eligible to receive a distribution from the Plan of their total vested account balance when any of the following events occur: termination of employment, retirement, permanent disability, financial hardship, or death.

Forfeitures may be used to pay administrative expenses incurred by the Plan. There were no forfeitures and none were applied as of and for the years ended December 31, 2024 and 2023.

Information regarding the Plan's provisions is available to participants through the Plan administrator.

(2) Summary of Significant Accounting Policies

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

The Plan utilizes various investment instruments, (currently, separate accounts (subaccounts) held in an insurance company contract).

Investments are carried at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The difference between fair value and cost represents unrealized appreciation or depreciation of investments.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Benefit payments are recorded when paid.

(3) Plan Administration

Anniversary Holding Company, LLC serves as Plan administrator and has the responsibility for the administration of the Plan. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses for the Plan are paid directly by the Plan Sponsor.

(4) Tax Status

The Volume Submitter used by the third party administrator received its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The prototype plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC and is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has undertaken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, respectively, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Investment Contract with Insurance Company

The Plan participates in an unallocated non-participating group annuity contract with The Manufacturers Life Insurance Company and its subsidiaries, operating in the United States under the trade name John Hancock Life Insurance Company (“John Hancock”). John Hancock maintains contributions in sub-accounts (separate accounts). The contract is included in the financial statements at fair value as reported to the Plan by John Hancock. Termination of the contract can only be initiated by the Plan sponsor or trustee. The contract termination value includes a provision for a market value adjustment and a surrender charge; however, John Hancock does not believe termination value is an appropriate measure of fair value. Management has evaluated the benefit-responsiveness of the contract and has determined it is not fully benefit-responsive.

(7) Fair Value Measurements

Professional standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under professional standards are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

A description of the valuation methodologies used for assets measured at fair value follows. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Separate accounts are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value.

(8) Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of any termination of the Plan, or upon complete or partial discontinuance of contributions, the accounts of each affected participant will become fully vested.

(9) Party-in-Interest Transactions

Investments in the Plan are managed by the insurance company, the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions rules. Administrative fees paid by the Plan to parties-in-interest amounted to \$17,401 and \$17,466 for the years ended December 31, 2024 and 2023, respectively.

(10) Risks and Uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

(11) Subsequent Review

The Plan's management has evaluated subsequent events through September 2, 2025, the date which the financial statements were available to be issued.
