Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of William Grant & Sons, Inc. Savings and Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of Financial Statements section—

Basis for Opinion

Note 1 – Description of plan

The following description of the William Grant & Sons, Inc. Savings and Investment Plan (the "Plan") provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is an employee elective deferral 401(k) and defined contribution plan covering eligible employees of William Grant & Sons, Inc. (the "Company" or "employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility: All employees are eligible on the date they become an employee of the Company.

Contributions: Employee contributions are made on a pre-tax or post-tax basis. Participants may elect to contribute up to 100% of their compensation through any combination of pre-tax and/or after tax contributions, subject to plan limits and the dollar deferred and non-discrimination limitations as prescribed by the Internal Revenue Code. Participants direct the investment of their contributions into various investment options offered by the Plan. The employer matches 100% of employees' contributions up to 5% of compensation. Additional discretionary contributions may be contributed at the option of the Company's Board of Directors. Bargaining unit employees are excluded from all employer contributions.

Participant Accounts: Each participant's account is credited with their contributions and Company matching contributions, which are invested based on the percent allocation elected by the participant into one or more of the investment options available to the Plan (participant directed). Each participant's account is also credited with earnings on their investments and charged with certain allocable administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: A participant is always 100% vested in their contributions plus actual earnings thereon. A participant becomes 100% vested in matching and discretionary Company contributions after two years of credited service.

Payment of Benefits: Distributions of plan benefits, equal to the vested balance in the participant's account, are permitted upon the earlier of retirement, death or separation of service from the Company. Withdrawals are also available in certain financial hardship situations. Effective April 2020, the Plan adopted the distribution provision of the Coronavirus Aid, Relief, and Economic Security ("CARES") Act that was signed into law on March 27, 2020. A CARES Act distribution allowed the Plan's participants to take a COVID-19 related distribution up to \$100,000 from the Plan beginning on or after January 1, 2020 and before December 31, 2020.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Notes receivable from participants: The Plan permits participants to borrow from their vested account balances in the Plan. A participant is permitted to borrow up to 50% of their vested account balance, not to exceed \$50,000. The interest rates are based on the rates available for similar loans from commercial lending institutions.

Note 1 – Description of plan (continued)

Notes receivable from participants (continued):

As of December 31, 2024, the interest rates on the outstanding loans range from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balances plus any accrued, but unpaid interest. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as benefit payments based upon the terms of the Plan document. In addition, no allowance for credit losses has been recorded as of December 31, 2024 or 2023. Effective April 2020, the Plan adopted the temporary loan repayment deferral provision of the CARES Act. The deferral provision adopted by the Plan allowed qualified Plan participants who had Plan loan repayments to defer such repayments until December 31, 2020. The provisions also increased the loan limit to the lesser of \$100,000 or 100% of a participant's vested balance.

Forfeited Accounts: The Plan provides that forfeitures attributable to matching and discretionary Company contributions will be used to offset any future employer contributions and administrative expenses. Forfeitures for the year ended December 31, 2024 amounted to \$217,891.

Note 2 – Summary of significant accounting policies

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments in Registered investment companies, pooled separate accounts and the collective investment trust are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note 3 for a discussion of fair value measurements.

Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

The Plan's interest in the collective investment trust is valued at the net asset value (NAV) of the units in the Principal Stable Value Trust Fund, which is used as a practical expedient to estimate fair value.

Payment of Benefits: Benefits are recorded when paid.

Corrective Contributions: The Company records excess contributions as a reduction in the current year contributions.

Note 3 – Fair value measurements (continued)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs to the methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. The Plan's investment in the collective investment trust is not categorized within the fair value hierarchy as the Plan has elected to measure fair value for this investment using the net asset value per share practical expedient.

Registered investment companies – Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end Registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Registered investment companies held by the Plan are deemed to be actively traded.

Pooled Separate Accounts - The fair value of the pooled separate accounts is determined by each fund's insurance carrier based on the fair value of the underlying securities within the fund, which represent the net asset value of shares held by the Plan at year end. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.

Collective Investment Trust - Valued at the net asset value (NAV) of the units in the Principal Stable Value Fund (the "Fund"). The NAV, as certified by Principal Life Insurance Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the Fund less its liabilities, net of an adjustment from fair value to contract value for Fund investments in fully benefit-responsive contracts. The practical expedient is not used when it is determined to be probable that the Fund will sell the investment for an amount different than the reported NAV.

Note 4 – Financial information certified by the Plan’s custodian

Investments aggregating \$104,568,799 and \$96,935,193 as of December 31, 2024 and 2023, respectively, and total investment income of \$12,525,264 for the year ended December 31, 2024, included in the accompanying financial statements and supplemental schedule, were obtained from information for which the Plan administrator has obtained a certification from the custodian that such information is complete and accurate in accordance with Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Note 5 – Tax status

The Plan obtained its latest determination letter dated May 1, 2022, in which the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the relevant taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 – Related party transactions and Party in interest transactions

Principal Life Insurance Company (“Principal”), the custodian of the Plan, manages certain plan investments, therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the services of Principal amounted to \$50,172 for the year ended December 31, 2024.

Note 8 – Plan termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer matching and discretionary contributions.

Note 9 – Subsequent events

Management of the Plan has evaluated subsequent events through August 18, 2025, the date the financial statements were available to be issued. No significant subsequent events were identified by management.
