### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Comau LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Comau LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Comau LLC (the Company) on the later of their date of employment or upon turning 18 years of age. Part-time employees are also required to complete one year of eligibility service, which consists of working 1,000 or more hours in a 12-month period. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Company amended the Plan to provide for default elective contributions of 2% for all newly hired Comau Employees Association ("CEA") union employees; to provide matching contributions equal to 75% of the first 2% of compensation deferred and an annual 3% Company contribution for CEA union employees who were not eligible for the Comau Employees' Retirement Income Plan ("Pension").

Effective January 1, 2024, the Company amended the Plan to increase the mandatory cash out limit to \$7,000 and to delay the age at which required distributions must commence as permitted by the Setting Every Community Up for Retirement Enhancement ("SECURE") 2.0 Act.

Effective April 1, 2024, the Company amended the Plan to provide matching contributions equal to 75% of the first 2% of compensation deferred and an annual 3% Company contribution for CEA union employees who elected to cease future accumulations of credited service in the Pension.

Effective January 1, 2023, the Company amended the Plan to exclude retention bonus payments subject to forfeiture from the definition of compensation under the Plan and to remove the requirement participants be employed on the last day of the plan year to receive an allocation of any employer contribution.

Effective January 1, 2023, the Company amended the Plan to allow Novi Industries Employee Association ("NIEA") union employees who were participants of the Pension to make a one-time, irrevocable election to cease future accumulation of credited service effective after June 30, 2023 in the Pension in exchange for eligibility for Company matching and nonelective contributions in the Comau LLC 401(k) Plan.

Effective April 1, 2023, the Company amended the Plan to clarify the administration of default elective contributions and automatic increases; to provide for default elective contributions of 2% for all newly hired NIEA union employees; and to provide matching contributions equal to 75% of the first 2% of compensation deferred and an annual 3% Company contribution for NIEA union employees who were not eligible for the Pension.

**General (Continued)**

Effective July 1, 2023, the Company amended the Plan to reduce the age for eligibility to participate from 21 to 18 years of age and to provide matching contributions equal to 75% of the first 2% of compensation deferred and an annual 3% Company contribution for NIEA union employees who elected to cease future accumulations of credited service in the Pension.

Effective December 1, 2023, the Company amended the Plan to allow CEA union employees who were participants of the Comau LLC Employees' Retirement Income Plan ("Pension") to make a one-time, irrevocable election to cease future accumulation of credited service effective after March 31, 2024 in the Pension in exchange for eligibility for Company matching and nonelective contributions in the Comau LLC 401(k) Plan.

**Contributions**

Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pretax 401(k) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible nonunion employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled nonunion participants have their deferral rate set at 3% of eligible compensation and their contributions invested in the designated default fund until changed by the participant. The Plan also has an auto-increase provision whereby all nonunion participants who were auto-enrolled will have their pre-tax deferral rates increased by 1% each year, up to a maximum of 6% of eligible compensation, or until another election is made by the participant. The auto-increases occur each year on the participant's auto-enrollment anniversary.

Effective April 1, 2023, all newly eligible NIEA union employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled NIEA union participants have their deferral rate set at 2% of eligible compensation and their contributions invested in the designated default fund until changed by the participant. The Plan also has an auto-increase provision whereby all NIEA union participants who were auto-enrolled and did not make an affirmative election will have their pre-tax deferral rates increased by 1% each year, up to a maximum of 6% of eligible compensation, or until another election is made by the participant. The auto-increases occur each year on the participant's auto-enrollment anniversary.

Effective January 1, 2024, all newly eligible EEA union employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled CEA union participants have their deferral rate set at 2% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. All CEA union participants who were auto-enrolled and did not make an affirmative election will have their pre-tax deferral rates increase by 1% each year, up to a maximum of 6% of eligible compensation, or until another election is made by the participant. The auto-increases occur each year on the participant's auto-enrollment anniversary.

**Contributions (Continued)**

With the exception of NIEA and CEA union participants as noted above, union employees are not eligible for automatic enrollment and automatic increase provisions.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may, at its discretion, elect to make a matching or profit sharing contribution to the Plan. For the year ended December 31, 2024, the Company matching contribution for nonunion employees was 75% of the first 6% of eligible compensation that a participant contributed to the Plan. As of the effective dates of the amendments disclosed above, matching contributions for NIEA and CEA union employees was 75% of the first 2% of eligible compensation that a participant contributed to the Plan. There was no Company profit sharing contribution for the year ended December 31, 2024. Participants are eligible for the profit sharing contribution if they meet the eligibility requirements above. Company nonelective contributions made to NIEA and CEA union employees totaled \$313,795 for the year ended December 31, 2024. Participants are eligible for the nonelective contribution if they meet the eligibility requirements above, are a member of the NIEA or CEA collective bargaining unit, and were either hired on or after January 1, 2012 or made a one-time, irrevocable election to cease accumulation of credited service in the Pension effective June 30, 2023 (NIEA) or effective March 31, 2024 (CEA).

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit sharing contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company matching and profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. Participants with an hour of service last completed prior to April 1, 2013 vest on a six-year graded schedule. Participants with an hour of service completed on or after April 1, 2013 vest on a three-year cliff schedule. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Accounts**

Forfeited nonvested accounts can be used to pay administrative expenses and to reduce future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$35,499 and \$6,922, respectively. There were \$58,199 of forfeitures used to pay administrative expenses for the year ended December 31, 2024. There were \$1,993 forfeitures used to reduce Company contributions for the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value investments.

**Subsequent Events**

The Plan has evaluated subsequent events through August 26, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Company amended the Plan to provide for in-service distributions in the event of a qualified birth or adoption, to provide eligibility in the elective and catch-up contribution components of the Plan for long-term part-time employees who completed 500 or more hours of service during two consecutive 12-month periods, and to provide for additional catch-up contribution amounts for participants who have attained age 60 but will not attain age 64 prior to the end of the plan year, as permitted by the SECURE 2.0 Act.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Fidelity Management Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

*Self-Directed Brokerage Account* – Consists of mutual funds and a money market fund valued as disclosed in this note.

*Money Market Fund* – Valued at cost, which approximates fair market value.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter from the IRS indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity Management Trust Company, the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
