Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements -as a whole- are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

NOTE A - DESCRIPTION OF THE PLAN AND ACCOUNTING POLICIES

Organization

The Grupo Carmelo Savings and Investment Plan, as amended (hereinafter referred to as the Plan) was organized on January 1, 1999 with an adoption agreement amendment dated November 28, 2016.

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan Sponsor is Canarico Quarries, Inc. and additional adopting employers are Ecológica Carmelo, Inc., Productora de Agregados Inc. and Cantera Carmelo, Inc. BPAS – Benefit Plans Administrative Services, Inc. is the trust, recordkeeper and third-party administrator of the Plan.

Accounting policies

Participant loans

The Plan does not make loans to participants or beneficiaries.

Administration expenses

All expenses of maintaining the Plan are accounted for as they are incurred by the Plan Sponsor.

Plan termination

In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

General

The following description of the Grupo Carmelo Savings and Investment Plan (hereinafter referred to as the Plan) provides only general information. Participants should refer to the Plan Adoption Agreement for a complete description of the Plan's provisions.

The plan is a defined contribution plan covering all employees of the Sponsor who have reached 21 years of age and have completed a year of service (1,000 hours of service), excluding self-employed, unionized employees and non-resident alien individuals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

NOTE A - DESCRIPTION OF THE PLAN AND ACCOUNTING POLICIES - CONTINUED

Contributions

For the years ended December 31, 2024 and 2023, participants may contribute up to \$15,000 if the participants have less than 50 years old, as defined in the Plan, and up to \$16,500 if the participants have 50 years old or older, limited to 10% of compensation for the plan year.

The Sponsor's matching contributions will be discretionary. Since April 1, 2010, the Sponsor is no longer contributing the employer discretionary nor the matching contributions to the Plan.

Participant's accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) Plan earnings and (b) forfeitures of terminated participants' non-vested accounts. Except for forfeitures, allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are vested according to the following schedule:

- 20% after two years of service
- 40% after three years of service
- 60% after four years of service
- 80% after five years of service
- 100% after six years of service

Investment Option

Upon enrollment in the Plan, a participant directs the investment of his or her contributions into Mutual Funds. The participants may change their investment options quarterly.

Distribution of benefits

Distribution of benefits to participants that are less than \$5,000 shall be made in a single lump sum payment. If the amount exceeds \$5,000, the participant shall have the option to decide how to receive the distribution.

The Plan shall permit distributions attributable to Sponsor contributions only upon the occurrence of one of the following events:

- a. retirement of the employee or attainment of normal retirement age.
- b. separation from service (for any reason, including death).
- c. permanent disability of the employee.
- d. termination of the plan.

Payment of benefits

The Plan does not permit participants to receive payment of benefits unless a participant terminates employment. Benefits are recorded when paid.

There were no hardship distributions during 2024 and 2023.

NOTE B - INVESTMENTS VALUATION AND USE OF ESTIMATES

Investments valuation and income recognition

The Plan's investments are participant-directed and are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly (not forced) transaction between market participants at the measurement date. See note E for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold during the year as well as an increase or decrease in fair value at year end.

NOTE B - INVESTMENTS VALUATION AND USE OF ESTIMATES- CONTINUED

Fair value measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The fair value measurement accounting literature (ASC 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value and describes inputs as either observable or unobservable. Observable inputs can be seen in the market whereas unobservable inputs are assumptions made by the valuer based upon the best available information. ASC 820 requires the observable inputs to be used wherever possible, resulting in the classification of the hierarchy.

The Plan categorizes its fair value measurements into a three broad levels hierarchy based on the priority of the inputs to the valuation technique. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure fair value fall within different levels of the hierarchy, the category level is based on the lowest priority level input that is significant to the fair value measurement of the instrument in its entirety.

- Level 1 - Unadjusted quoted prices accessible in active markets for identical assets or liabilities at the measurement date and mutual funds where the value per share (unit) is determined and published daily and is the basis for current transactions. Level 1 inputs are considered "observable" inputs.
- Level 2 - Unadjusted quoted prices for similar assets or liabilities in active markets or inputs (other than quoted prices) that are observable or that are derived principally from or corroborated by observable market data through correlation or other means. Primary inputs to this valuation technique may include comparative trades, bid/asks, interest rate movements, U.S. Treasury rates, Secured Overnight Financing Rate ("SOFR"), prime rates, cash flows, maturity dates, call ability, estimated prepayments, and/or underlying collateral values.
- Level 3 - Prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. Inputs reflect management's best estimate about the assumptions market participants would use at the measurement date in pricing the asset or liability. Consideration is given to the risk inherent in both the method of valuation and the valuation inputs. Primary inputs to this valuation technique include broker quotes and comparative trades.

Changes in observability of significant valuation inputs identified during these reviews may trigger reclassifications. Reclassifications are reported as transfers at the beginning of the period in which the change occurs.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE E - FAIR VALUE MEASUREMENTS

The Plan’s investments are reported at fair value in the accompanying statements of assets available for benefits. Accounting Standard Codification (ASC) 820 establishes a fair value hierarchy. This hierarchy consists of three broad levels, which were described in Note B, that prioritizes the inputs to valuation techniques used to measure fair value. The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. The Plan measures fair value using level 1 inputs because they provide the most reliable evidence of fair value.

NOTE F - INCOME TAX STATUS

The Department of the Treasury of the Commonwealth of Puerto Rico has ruled that the Plan qualifies under Section 1081.01 (e) of the Income Tax Act of 2011 (the Act) and is, therefore, not subject to income tax under the present income tax law. The Plan is required to operate in conformity with the Act to maintain its qualification. The Plan’s Retirement Committee is not aware of any course of action or series of events that have occurred that might affect the Plan’s qualified status.

NOTE G – FINANCIAL INSTRUMENTS RISKS AND UNCERTAINTIES

The Plan invests in various investment securities (mutual funds) which are exposed to various risks such as interest rates, market, and credit risks. Due to the level associated with certain investment securities, it is at least reasonable possible that change in the values of investment securities will occur in the near term and that such a change could materially affect participant’s account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE H - TRANSACTIONS WITH PARTIES-IN-INTEREST

The trustee of the assets and the auditor of the Plan are considered parties-in-interest to the Plan. The Plan sponsor has represented that it is not aware of any prohibited transactions with parties-in-interest. Auditing fees paid by the sponsor on behalf of the Plan were \$13,000 for the years ended December 31, 2024 and 2023. Fees paid to the trustee and the auditor for the years ended December 31, 2024 and 2023, are considered reasonable based on the Plan sponsor's evaluation.
