***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Bank Hapoalim B.M. Employee Savings and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bank Hapoalim B.M. Employee Savings and Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

***Opinion***

### **Note 1. Description of the Plan**

The following description of the Bank Hapoalim B.M. Employee Savings and Investment Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering eligible employees directly employed by the United States branches of Bank Hapoalim B.M. (the "Bank"). The Plan is a prototype plan sponsored by Principal Life Insurance Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate upon attainment of age 18.

#### Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Bank matches employees' pre-tax contributions in an amount equal to 50% of those contributions. However, those pre-tax contributions are not matched to the extent they exceed 6% of eligible compensation.

For employees with employment commencement date on or after January 1, 2019, the Bank makes additional contribution in an amount equal to 2% of annual compensation for persons who meet certain requirements.

The Plan gives the Bank the discretion to decide whether to make additional contributions to the Plan and to determine the amount of any such contribution by the Bank.

#### Participant Accounts

Each participant's account is credited with (a) participant's contributions; (b) employer's matching contributions; (c) allocations of Plan earnings; and (d) 2% additional contribution for eligible employees. Allocations are based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balances.

Vesting

Participants are immediately vested in their salary deferral contribution and rollover accounts, plus earnings thereon. A participant is 100% vested in the Bank's matching and any discretionary contributions after three years and at least 1,000 hours of service during each year.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their non-forfeitable account balance. Notes receivable from participants are secured by the balance in the participant's account and bear an interest rate equivalent to that charged by major financial institutions in the community for comparable loans at the time the loan is made as determined by the Plan Administrator. Notes receivable from participants as of December 31, 2024 and 2023 bear interest at rates ranging from 4.25% to 9.50%.

Generally, the term of loans may not exceed five years. However, if the purpose of the loan is to acquire a principal residence, then the maximum term is ten years but not beyond normal retirement age.

Payment of Benefits

Vested account balances are payable upon retirement, death or disability, or termination of service. In-service distributions are permitted upon meeting certain requirements as defined by the Plan.

Forfeited Accounts

Forfeited balances of terminated participants' non-vested accounts are used to reduce future employer contributions. In 2024, employer contributions were reduced by \$32,297 from forfeited non-vested accounts. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts balances pending application.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, which is determined using various methods described more fully in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Bank, as provided in the Plan document and governing contract. Expenses that are paid by the Bank are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Revenue Sharing

In 2021, the Plan and Principal Life Insurance Company initiated a revenue sharing arrangement whereby the Plan receives revenue sharing earned in connection with Plan investments. During 2024, revenue sharing in the amount of \$24,724 is included as other income in the statement of changes in net assets available for benefits. The funds can be used to pay certain administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds*

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the US Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts*

Pooled separate accounts are accounts maintained by Principal Life Insurance Company that are used for the collective investment of plan funds from more than one employee benefit plan. Pooled separate accounts are valued at NAV which is calculated in a manner consistent with generally accepted accounting principles (GAAP) for investment companies. Because it is valued similarly to mutual funds, pooled separate accounts are assigned input level 1 by Principal Life Insurance Company.

*Common Collective Trust*

The Plan holds an investment in Principal Stable Value Z Fund, which is a common collective trust fund. The fund is valued at NAV which is calculated in a manner consistent with GAAP for investment companies. Because it is valued similarly to mutual funds, the fund is assigned level 1 input by Principal Life Insurance Company.

**Note 4. Related-Party Transactions and Party in Interest Transactions**

Separate accounts are available through a group annuity contract with Principal Life Insurance Company. Investment products and certain administrative services are provided by Principal Life Insurance Company.

Delaware Charter Guarantee and Trust Company (d/b/a Principal Trust Company) is the Plan trustee.

Principal Stable Value Z Fund is a common collective trust held by Principal Global Investors Trust Company, as trustee.

Principal Life Insurance Company, Delaware Charter Guarantee and Trust Company, and Principal Global Investors Trust Company are members of the Principal Financial Group.

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Bank has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 6. Tax Status**

The Plan adopted a prototype plan document sponsored by Principal Life Insurance Company. The prototype plan received an updated opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the prototype document satisfies the applicable provision of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
