Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Levata 401(k) Plan (formerly known as the Barcodes, LLC 401(k) Plan) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - PLAN DESCRIPTION

The following brief description of the Levata 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a salary deferral plan covering substantially all employees of Barcodes, LLC ("Plan Sponsor" or "Company"). It is a qualified plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective January 1, 2024, the Plan Sponsor changed the name of the Plan from Barcodes, LLC 401(k) Plan to the Levata 401(k) Plan. In addition, the Plan Sponsor name was changed to Barcodes LLC d/b/a Levata.

Participation and Contributions

An employee is eligible to participate in the Plan following 60 days of service and having attained 21 years of age. Eligible part-time, temporary, seasonal or similar employees who have attained a year of service or 1,000 hours are eligible to participate in the Plan.

Participants may elect to defer up to 100% of their pretax or post-tax eligible compensation, not to exceed the maximum amount allowed under the Internal Revenue Code ("IRC"). Effective January 1, 2022, all participating employees are auto enrolled into the Plan at an initial rate of 3%.

The Company has a discretionary matching contribution equal to 50% of the first 5% of compensation contributed as elective deferral contributions under the Plan. Discretionary matching contributions for the period from January 1, 2024 to December 31, 2024 were remitted to the Plan in 2025.

The Plan currently offers a variety of investment options for participants. Participants may change their investment options daily.

Participant and Accounts

Each participant's account is credited with the participant's contributions, if any, and an allocation of the Company's contributions and Plan earnings (losses) and trust fees. Allocations are based on participant compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting of Benefits

Participants are immediately vested in their rollover and employee contributions plus actual earnings thereon. Vesting in the Company's discretionary and matching contributions and earnings thereon vest under a three-year schedule determined on the Participant's number of years of service. Participants are 33.33% vested after one year of service; 66.67% after two years of continuous service; and 100% vested after three years of continuous service.

The Plan's vesting does not apply to account balances of partially vested or non-vested participants of other qualified plans that merged into this Plan. Instead, the pre-merger vesting schedules under such plans continue to apply to those Participants.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and may only have two outstanding loans at a time unless grandfathered in from a merger. Loan terms range from one to five years unless the loan is for the purchase of a participant's primary residence which has a maximum term of 15 years. The loans are secured by the vested balance in the participant's account and bear interest at a rate of 1% above the prime rate when loans are issued. Principal and interest are paid ratably through payroll deductions. Interest rates on loans outstanding as of December 31, 2024 and 2023 ranged from 4.25% to 9.50%.

Benefits

Participants, upon retirement or disability, shall be entitled to receive, as benefits, the entire amount credited to their accounts as of that date. Upon death, a participant's designated beneficiary shall receive the balance in the account. Participants may also be eligible for hardship or in-service distributions in accordance with the Plan document.

Participants whose employment terminates for reasons other than retirement, disability or death shall be entitled to receive the vested portion of their account balances in a lump sum in accordance with Plan provisions.

Forfeiture

Forfeitures may be used to pay administrative expenses and reduce Company discretionary matching contributions under the Plan.

As of December 31, 2024 and 2023, the available forfeiture balances were \$7,349 and \$12,697, respectively. For the years ended December 31, 2024 and 2023, there were \$31,030 and \$32,789 of forfeitures utilized to pay administrative expenses or reduce discretionary matching contributions, respectively

NOTE B - SIGNIFICANT ACCOUNTING POLICIES

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement

date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and investment trustees. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan pays certain administrative costs and are expensed when incurred. Other expenses are paid by the Plan Sponsor.

NOTE C - FAIR VALUE MEASUREMENTS

There is a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Money market fund - Valued based on quoted market prices of the fund in active markets.

Mutual funds - Valued based on quoted prices of the fund in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to the participants' accounts shall become 100% vested and all unallocated amounts shall be allocated to the accounts of all participants.

NOTE E - INCOME TAX STATUS

The Plan has on file a favorable opinion letter from the Internal Revenue Service (“IRS”) dated November 5, 2018, for the prototype standardized profit-sharing plan with a cash or deferral arrangement that the Company has adopted. The Plan has since been amended and restated, but the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, that the Plan is qualified and tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the trustee and, therefore, qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. Certain officers of the Company are also administrators of the Plan.

NOTE G - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The Plan administrator determined that the certification received from the Charles Schwab Trust Bank (“the Trustee”) meets the requirements of ERISA Section 103(a)(3)(c). The Trustee certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, cash, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan’s independent accountants did not perform auditing procedures with respect to this information except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

NOTE I - EXCESS PARTICIPANT CONTRIBUTIONS PAYABLE

Excess contributions and earnings therein amounting to \$35,838 and \$34,936 are recorded as liabilities as of December 31, 2024 and 2023, respectively, in the accompanying statements of net assets available for benefits and as a reduction of participant-directed contributions for each of the years then ended. The Plan reimbursed the 2023 excess contributions and earnings to its participants during 2024.

NOTE J - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE K - SUBSEQUENT EVENTS

In preparing these financial statements, the Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued. Except for the matters noted below, the Company is not aware of any subsequent events, which would require recognition or disclosure in the financial statements.

On January 1, 2025, the Delta-One Software Inc 401(k) Profit Sharing Plan and the POSDATA Group, Inc. 401(k) Plan merged into the Levata 401(k) Plan.
