1. DESCRIPTION OF THE PLAN:

The following brief description of Our Daily Bread Ministries 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering substantially all eligible employees of Our Daily Bread Ministries (the Organization) who are age 21 or older. Eligible employees are subject to a 6% auto-enrollment provision at the next plan entry date after hire and an automatic annual increase of 1%, up to a maximum of 12% of compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Committee is responsible for oversight of the Plan and the appropriateness of the Plan's investment offerings and monitors investment performance.

CONTRIBUTIONS

Participants may contribute up to 75% of compensation, as defined by the Plan. Participants are permitted to designate a portion or all of their deferral contributions as Roth contributions. Participants who have attained age 50 prior to the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover). All participant contributions are voluntary.

Employees become eligible for employer contributions following the completion of one year of service and attainment of age 21. The Organization makes Safe Harbor matching contributions of up to four percent of each participant's compensation to eligible participants. Additionally, the Organization may choose to make discretionary employer profit sharing contributions. No discretionary employer contributions were made in 2024.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and (b) Plan earnings, and charged with an allocation of Plan expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Contributions are subject to certain limitations prescribed by law. Participants may direct all their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provision.

1. DESCRIPTION OF THE PLAN, continued:

VESTING

Participants are immediately vested in their employee contributions, employer Safe Harbor matching contributions, and related earnings. Discretionary employer profit sharing contributions are vested on a tiered schedule as seen below:

FORFEITURES

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$43 and \$0, respectively. These amounts are used to allocate to active participant accounts, offset administrative expenses or reduce employer contributions. During the year ended December 31, 2024, employer contributions were reduced by \$0 from forfeited nonvested accounts and \$0 was allocated to participant accounts.

PAYMENT OF BENEFITS

Upon termination of service, disability, retirement, death, early retirement at age 55 with one year of vesting service, or attaining age 59 1/2, participants may receive a lump sum amount or purchase an annuity contract equal to the value of the participant's interest in his or her account. Hardship withdrawals are permissible from employee contributions upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need.

ADMINISTRATIVE EXPENSES

Custodial and investment fees, along with other maintenance expenses, are paid from Plan assets. For the year ended December 31, 2024, \$95,643 was paid from Plan assets for administrative expenses. Any other administrative expenses are paid by the Organization.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. SIGNIFICANT ACCOUNTING POLICIES, continued:

USE OF ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded based on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company (Principal), a qualified institution, has certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023; the supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024; and the related investment income reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS:

The *Fair Value Measurements and Disclosure* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Mutual funds are valued using Level 1 inputs, and are valued at the daily closing price as reported by the fund. Collective investment trusts and pooled separate accounts are valued using Level 2 inputs and are principally derived from the market value of the underlying mutual fund holdings. There were no changes to valuation methodologies during the year.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS WITH INSURANCE COMPANY:

The Plan has a fully benefit-responsive investment contract with Principal as of December 31, 2024 and 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The total contract value as of December 31, 2024 and 2023, was \$3,692,199 and \$3,810,586, respectively.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, which was 4.85% and 5.05% as of December 31, 2024 and 2023, respectively. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer discretionary profit sharing contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Organization may determine.

7. TAX STATUS:

The IRS has determined and informed the Organization by a letter dated August 10, 2022, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. PARTIES-IN-INTEREST:

During the Plan year, the Plan investments were held by Principal; therefore, certain transactions with these parties qualify as party-in-interest transactions. As of December 31, 2024 and 2023, the Plan is invested in a fixed annuity contract issued by Principal and collective investment trusts and pooled separate accounts managed by Principal, which provides recordkeeping services for the Plan. During the year ended December 31, 2024, the Plan paid fees to Principal of \$95,643.

10. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through August 28, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
