## Independent Auditor's Report

To the Administrative Committee of  
Western North Carolina Community Health Services  
403(b) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Western North Carolina Community Health Services 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Western North Carolina Community Health Services 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

## **Basis for Opinion**

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The following description of the Western North Carolina Community Health Services 403(b) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan established by Western North Carolina Community Health Services (“Company”) effective January 1, 1998 for the benefit of its employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended effective January 1, 2020 to make all employees immediately eligible for employer matching and non-elective contributions upon entering the Plan. The Plan was also amended effective May 8, 2020, to permit Coronavirus-Related loans that allow impacted participants to borrow up to the lesser of \$100,000 or 100% of their vested account balance in the Plan.

The plan was restated January 1, 2023, to be a traditional safe harbor plan with 100% match up to 3% of pay, 50% match on the next 2% of pay, to total up to 4% match if an employee contributes 5% of pay. The plan was restated January 1, 2024, to exclude fringe benefits and sign on bonuses from eligible compensation.

**Contributions**

Participants may contribute to the Plan via salary deferrals and may change their contribution percentage at their discretion. The maximum annual contribution allowed in a calendar year for each participant is prescribed by federal statutes (\$23,000 in 2024 and \$22,500 in 2023). Additional catch-up contributions are permitted for participants who are age 50 or older by the end of the calendar year in which the catch-up contributions are made.

**Participant Account**

Each participant’s account is credited with the participant’s contribution and investment earnings. Allocations of contributions are based on participant compensation, and allocations of earnings are based on each participant’s account balance. Upon retirement or termination, a participant is entitled to the vested balance in his/her account. A participant may elect to direct the investment allocation of his/her account or to allow an investment manager to direct the investments.

Vesting

Participants are immediately vested in their voluntary contributions, including rollovers, plus actual earnings thereon. Vesting in the remainder of the account balance is 100% vested after three years of service. In order to qualify for a year of vesting service, participants must work at least 1,000 hours in any given Plan year.

Participants are 100% vested in the event of death, total and permanent disability, or on the later of the date the participant attains age 65 or the fifth anniversary of the first day of the Plan Year in which the participant commenced participation in the Plan.

Forfeited Nonvested Account Balances

Forfeitures of nonvested account balances may be used by the Company towards administrative expenses and future contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts were not material. During the Plan years ended December 31, 2024 and 2023, forfeitures of \$29,247 and \$2,534 were used to offset employer contributions to the Plan. Subsequent to the year ended December 31, 2024, the Company determined that certain forfeitures used to offset employer contributions during prior years were not eligible forfeitures for use by the Company. As a result, the accompanying statement of net assets available for plan benefits for the year ended December 31, 2024 includes \$31,781 of employer contributions receivable.

Administrative Expenses

Certain expenses incurred in the administration of the Plan are paid directly by the Company.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in installments. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Contributions receivable

Contributions receivable are recorded when determined contributions of the employer and employees are not received by the investment custodian until a subsequent reporting period. An allowance is provided when necessary to recognize potentially uncollectible receivables, and amounts deemed worthless are written off. Management of the Plan has determined that no allowance for uncollectible receivables was necessary at December 31, 2024 and 2023.

Notes receivable from participants

Participants may borrow from their accounts. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser value of \$50,000 or 50% of their account balance. The loans are to be secured only by the balance in the participant's account up to a limit of 50% of the participant's vested interest. The term of the loan must not exceed five years, unless it is being used to purchase the participant's primary residence, and it will bear interest at a rate of prime plus 2% as published in the Wall Street Journal at the date of the loan. Principal and interest on these loans are required to be paid ratably via payroll deductions. As of December 31, 2024 and 2023, the Plan had loans receivable from participants totaling \$123,444 and \$96,940, respectively.

**Note 2 – Summary of Significant Accounting Policies**

Basis of accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") using the accrual method of accounting. U.S. GAAP is embodied in the Financial Accounting Standards Board *Accounting Standards Codification* ("FASB ASC"), which is the authoritative source of U.S. accounting and reporting standards for nongovernmental entities.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates, and such differences could be material. Significant estimates used in preparing these financial statements include those used to establish the fair values of investments.

Valuation of investments

The investments in the funds are presented at fair value. Shares of registered investment companies are valued based on quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

The Plan provides fixed income accounts as investment options available to Plan participants. These investments are fixed income options (i.e., guaranteed interest contracts) that provide a more stable asset value with a guaranteed rate of return. These investments are valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Unrealized gains and losses are recorded for changes in the fair value of mutual fund investments during the year. Realized gains and losses are recorded when investments are sold. Realized and unrealized gains and losses for each reporting period are combined and presented as net appreciation (depreciation) in fair value of investments in the accompanying statement of changes in net assets available for benefits.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Reclassifications

Certain prior year amounts have been reclassified to conform to the current year presentation.

**Note 3 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participant accounts would continue to be held by the Plan's trustee until all benefits are distributed to the participants.

**Note 4- Benefits payable to Former Participants**

The portion of net assets which had been processed for payment to persons who requested withdrawals but had not yet been paid by the Plan was \$0 at both December 31, 2024 and 2023.

**Note 6 – Guaranteed Interest Funds**

The Plan has guaranteed interest contracts with The Variable Annuity Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. The custodians are contractually obligated to pay principal and specified interest rates that are guaranteed to the Plan, less any amounts distributed, including applicable charges and fees. The crediting interest rates are based on formulas agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the contract will track current market yields on a trailing basis.

It is possible that certain types of events could permit the insurance companies to terminate the contracts and limit the Plan’s ability to process transactions at contract value, including an amendment to the Plan document to terminate the Plan. The Plan administrator does not believe these events are probable of occurring.

**Note 7 – Fair Value Measurements**

The Plan adopted the Fair Value Measurement and Disclosure topic of the FASB ASC, which establishes a framework for measuring value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1        Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2        Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The investments in registered investment companies are based on quoted market prices. There have been no changes in the methodologies used during the year ended December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 9 – Deemed Distributions**

Loans are deemed to be distributions on the Plan's Form 5500 when payments cease, or if a participant with an outstanding loan balance transfers out of the plan. The related participant receives a Form 1099-R, which reports the deemed amount as taxable to the participant. When a participant transfers all of his or her funds out of the Plan, the Plan's financial statements also report a distribution of the outstanding loan amount. When a participant does not transfer all of his or her funds out of the Plan, the Plan's financial statements do not report a distribution of the outstanding loan amount as the participant is permitted to pay the outstanding loan balance to the Plan. At December 31, 2024 and 2023, the amount of deemed loans outstanding was determined to be immaterial to the Plan.

**Note 10 – Income Tax Status**

The Plan is a prototype plan that qualifies for tax-exempt status; however, it has not received a favorable determination letter issued by the Internal Revenue Service. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated March 31, 2017, that the prototype plan agreement was designed in accordance with the applicable sections of the IRC. Therefore, the plan administrator believes that the Plan was qualified and was tax-exempt as of the financial statement date.

The Plan adheres to guidance issued by the Codification with respect to accounting for uncertainty in income taxes. This guidance clarifies the accounting for uncertainty in income taxes recognized in an enterprise's financial statements and prescribes a comprehensive model for recognizing, measuring, presenting, and disclosing in the financial statements tax positions taken or expected to be taken on a tax return including positions that the organization is exempt from income taxes or not subject to income taxes or unrelated business income. As of the date of this report the current and two most recent prior years are available for IRS audit.

**Note 11 – Related Party Transactions**

Certain plan investments are shares of mutual funds and annuities managed by The Variable Annuity Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, who are the trustees/custodians as defined by the Plan. These transactions qualify as exempt party-in-interest transactions.

**Note 12– Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and that amounts reported in the statement of net assets available for benefits.

**Note 13 – Subsequent Events**

The Company has evaluated subsequent events for the Plan through August 1, 2025, the date these financial statements were issued. Management has not identified any additional items requiring recognition or disclosure.
