### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Stein Industries, Inc. 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

#### Note 1. Plan Description

The following description of Stein Industries, Inc. 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Stein Industries, Inc. (the Plan Sponsor and Plan Administrator) and its subsidiaries (collectively, the Company and Employer) who are at least 18 years old. Eligible new employees are automatically enrolled in the 401(k) portion of the Plan at a contribution rate of 5%, unless the employee elects otherwise. Employees are eligible for nondiscretionary employer matching contributions on the first day of the month following their start date. Eligible employees who are employed at December 31 and have completed 1,000 qualifying hours of service during a 12-month period are also eligible to receive discretionary profit sharing contributions. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Company's Board of Directors is responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance and reports to the owners of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor has appointed Fidelity Management Trust Company as trustee of the Plan. The trustee is responsible for maintaining custody of the Plan's assets, processing contributions, notes receivable from participants and distributions and executing transactions to appropriate investment options.

**Contributions:** Participants may elect to defer and contribute up to 60% of pretax annual eligible compensation, as defined in the Plan, subject to the maximum permitted by the IRC. Participants may also make Roth post-tax salary reduction contributions, in addition to pretax salary reduction contributions. Participants in the Plan over the age of 50 years are allowed to make additional contributions due to the catch-up provision. Participants may change their contribution percentage or may elect to cease making deferrals at any time. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company may make a matching contribution and/or profit sharing contribution to the Plan. The Company matches 50% of participant contributions up to a maximum of 5% of the participant's eligible wages as defined in the Plan. The Company made matching contributions totaling \$233,262 for the year ended December 31, 2024. The Company did not make any discretionary profit sharing contribution for the year ended December 31, 2024. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's elective contributions, an allocation of the Company's matching and discretionary profit sharing contributions, if any, and Plan investment earnings. Participant accounts are charged with an allocation of Plan investment losses and administrative expenses that are paid by the Plan. Allocations are based on participants' eligible compensation, account balances or specific transactions, as defined in the Plan. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions including actual investment earnings thereon. Vesting in the Company's nondiscretionary matching and discretionary profit sharing contributions including actual investment earnings thereon is based on each participant's years of service. A participant vests ratably at 20% per year and is 100% vested after five years of credited service. A participant also becomes fully vested in their entire account upon the earliest occurrence of death, disability, age 60 or Plan termination.

#### Note 1. Plan Description (Continued)

**Participant investment options:** A participant may direct contributions to various investment options, as more fully described in the Plan's literature. Participants may change their investment options daily. Participants may elect to have all or part of their account balances transferred from one investment option to another in any combination.

**Notes receivable from participants:** Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note repayment terms may not exceed five years, unless the purpose of the note is to acquire a principal residence. Participants are only allowed to have one note outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. At December 31, 2024, the interest rates on outstanding notes ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions and are due in various amounts through May 2029.

**Payment of benefits:** On termination of service due to death, disability, retirement or termination for other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or continue participating in the Plan. Participant vested balances that are less than \$7,000 at the time of termination may be paid out in a lump sum without the need for participant consent. Balances between \$1,000 and \$7,000, which are paid out in a lump sum without participant consent, are rolled over into an individual retirement account for the benefit of the participant. During employment, participants may also withdraw account balances upon the attainment of age 59½ or financial hardship, as defined by the Plan.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$6,000 and \$8,000, respectively. These accounts will be used to fund future employer contributions or pay Plan expenses. Forfeitures of approximately \$28,000 were used to fund employer contributions and approximately \$200 were used to pay Plan expenses for the year ended December 31, 2024.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on the investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments, and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Notes receivable from participants are classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

**Contributions:** Contributions from Plan participants and the related matching contributions from the Company are recorded in the year in which participant compensation is earned.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included as a component of net appreciation in fair value of investments.

**Subsequent events:** In preparing the financial statements, the Plan Administrator has evaluated subsequent events and transactions for potential recognition or disclosure through September 3, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified or Provided by the Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Fidelity Management Trust Company, the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

#### **Note 3. Information Certified or Provided by the Trustee (Continued)**

The Plan provides for investments in a variety of investment securities. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of the investment securities have occurred since December 31, 2024, or will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the December 31, 2024, statement of net assets available for benefits.

#### **Note 4. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies:** Shares of registered investment companies are valued at the unadjusted quoted market prices, as determined in active markets, of shares held by the Plan at year-end.

**Collective investment trust:** The collective investment trust is valued based on the net asset value (NAV) of the underlying pool of securities that are composed of fully benefit-responsive investment contracts, security-backed contracts and investments in one or more underlying collective investment funds. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less liabilities. The practical expedient is not used when it is determined to be probable that the Plan will sell its investment in the collective investment trust for an amount different than the reported NAV.

**Money market fund:** The money market fund is valued at cost plus accrued income, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 6. Plan Tax Status

The Plan has adopted the FMR LLC non-standardized pre-approved profit sharing plan. The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020, stating that the pre-approved plan is acceptable under section 401 of the IRC. The Plan has been amended since the pre-approved plan received the opinion letter; however, the Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments held are shares of registered investment companies and shares of a money market fund managed by affiliates of Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the trustee and other service providers are included in administrative expenses in the statement of changes in net assets available for benefits. Certain administrative functions are performed by employees of the Company. No such employees receive direct compensation from the Plan. Notes receivable from participants are also considered exempt party-in-interest transactions.
