Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2008. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Notes to the Financial Statements

1. Description of the Plan

The following description of the Hospice & Palliative CareCenter 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan sponsored by Hospice & Palliative CareCenter d/b/a Trellis Supportive Care (the Employer and Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective January 1, 1990. The Plan was restated effective May 1, 2021.

Under Secure Act 2.0 provisions, the Plan elected to increase the force-out threshold from \$5,000 to \$7,000, effective January 1, 2024.

Eligibility

Employees are eligible to participate in the Plan on their hire date. At that time, participants can begin deferring compensation into the Plan. Participants become eligible for the employer matching contributions upon completion of one year of service.

Contributions

Participants may contribute to the Plan by deferring their compensation on a pre-tax basis in whole percentage increments from 1% to 100% or a certain dollar amount per pay period. Participants are also permitted to contribute Roth after-tax deferrals to the Plan. Participants who are over the age of 50 are eligible to make catch-up contributions. Participants may also make direct transfers or direct rollovers into the Plan. The Employer may, at its discretion, make a matching contribution each Plan year on behalf of eligible participants equal to a discretionary percentage of the participant's elective deferrals (50 cents on every dollar up to 10% of the participant's compensation contributed to the Plan for the year ended December 31, 2024). Contributions are subjected to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and the Employer's contributions, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan adoption agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service. A participant's vesting percentage will be 100 percent once retirement age is reached or the date the participant dies or becomes totally disabled. Before that date, employees are 0 percent vested.

1. Description of the Plan, continued

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may be eligible to take a loan against their funds invested in certain accounts. Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested balance, reduced by the highest outstanding loan balance in the preceding 12 months. Loan terms range from one to five years unless the loan is for the purchase of a participant's primary residence in which case the term is up to 15 years. The loans are secured by the vested balance in the participant's account and bear interest at a rate of 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, a participant may receive one or more payments within one year, installment payments over a period selected by the participant or purchase an annuity contract providing payments over the participant's lifetime equal to the vested value of his or her account. On termination of service, a participant whose vested account balance is not greater than \$7,000 will receive his or her benefits as a single lump sum payment. In-service withdrawals are also permitted for certain financial hardships, disability or when a participant attains age 59 1/2.

Forfeited Accounts

All forfeitures are used to reduce future employer contributions or pay Plan expenses. As of December 31, 2024 and 2023, forfeited accounts totaled \$30,074 and \$4,345, respectively. During the year ended December 31, 2024, \$4,330 in forfeitures were used to reduce employer contributions. Forfeited participant balances during 2024 totaled \$29,343.

Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance Committee determines the Plan's valuation policies utilizing information provided by the trustee. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Investment and Administrative Expenses

Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Administrator. Expenses that are paid by the Plan Administrator are excluded from these financial statements. Fees related to the administration of distributions and notes receivables from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan Administrator has evaluated subsequent events for accounting and disclosure requirements through August 28, 2025, the date that the financial statements were available to be issued.

3. Information Certified and Provided by Trustee

The Plan's asset information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information certified by Ascensus Trust Company (Ascensus), the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Ascensus that such information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedule.

Ascensus also certified to the completeness and accuracy of \$2,060,533 of net realized and unrealized appreciation in the fair value of investments, \$380,856 of interest and dividends related to the investments and \$17,039 of interest on notes receivable from participants for the year ended December 31, 2024.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Fair Value Measurements, continued

Money market funds: Valued at cost which approximates fair value.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

5. Exempt Party-in-Interest Transactions

Ascensus is the trustee as defined by the Plan and therefore, transactions with Ascensus qualify as party-in-interest. Fees paid by the Plan to Ascensus totaled \$52,602 for the year ended December 31, 2024.

Additionally, indirect fees are paid to Ascensus based on investment account values. These fees range from 0.04% to 0.91% of the investment account value. The fees are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

6. Tax Status

The Plan uses a volume submitter plan sponsored by Ascensus. An opinion letter was received from the IRS, dated June 30, 2020, which states that the volume submitter plan document satisfies the provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

7. Plan Termination

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
