### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mercersburg Academy 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## NOTES TO FINANCIAL STATEMENTS

### 1. DESCRIPTION OF PLAN

The following description of the Mercersburg Academy 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan originally established by The Regents of Mercersburg College dba Mercersburg Academy (Academy) on July 1, 2007. The Plan provides retirement benefits to eligible employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Regents 401(k) Investment Committee (Investment Committee) is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Regents.

The Plan is in operational compliance with the requirements of current laws and regulations. Formal amendments will be adopted by the prescribed deadlines.

#### ***Eligibility***

There is no age or service requirement to participate in the Plan. Generally, all employees are eligible, with the exception of leased employees, collectively bargained employees, non-resident aliens, and part-time, seasonal, and temporary employees scheduled to work less than 1,000 hours per year. Effective January 1, 2024, under the Setting Every Community Up for Retirement Enhancement (SECURE) Act of 2019, the eligibility requirements for part-time, seasonal, and temporary employees will be satisfied for any employee who alternatively completes three consecutive years of service in which they complete at least 500 hours of service.

Eligible participants may enter the Plan on their date of hire.

#### ***Contributions***

Each year, participants may contribute up to the maximum limit established by the Internal Revenue Code (IRC). Participant deferrals are based on a percent of compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may choose between two types of deferral options: traditional (pre-tax) 401(k) deferrals and Roth (after-tax) 401(k) deferrals. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate.

### NOTES TO FINANCIAL STATEMENTS

Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. The Plan includes an automatic escalation provision whereby participants enrolled in the Plan will have their deferral rate increased by 1% each year until a maximum rate of 10% is reached.

The Plan is a safe harbor plan, which makes the Plan exempt from certain compliance testing requirements. During 2024, the Academy matched 220% of the participant's elective deferrals that do not exceed 5% of eligible compensation. In addition to the Academy's match of elective contributions, the Academy may also make a discretionary nonelective contribution. No discretionary nonelective contributions were made during 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Academy safe harbor match contributions, as well as allocations of the Academy's discretionary nonelective contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are vested immediately in all contributions, plus actual earnings thereon.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. Interest rates ranged from 3.25% to 8.50% as of December 31, 2024. The loan interest rate is set at the prime rate, on the date of distribution, as defined in the Plan agreement. Principal and interest are paid ratably through payroll deductions.

#### ***Payment of Benefits***

Upon termination of employment, distributions may be made as soon as administratively feasible at the participant's election. Withdrawals from the Plan may be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Withdrawals are also made upon the death of a participant pursuant to the election of the beneficiary. In-service distributions are allowed for participants that have reached the age of 59 ½. All distributions from the Plan are made in lump-sum payments, in substantially equal installments, or as partial withdrawals.

### ***Forfeited Accounts***

There are no forfeitures under the current Plan structure, since all amounts vest immediately.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management and the Investment Committee determine the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year, and indirect investment expenses.

### ***Contributions***

Contributions from Plan participants and the safe harbor match contributions from the Academy are recorded in the year in which the employee contributions are withheld from compensation. The Academy discretionary nonelective contributions are recorded when the related participant compensation is paid.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and

the Plan Administrator deems the participant loan to be in default, and a distributable event has occurred, the participant loan balance is reduced, and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Audit expenses are paid by the Plan. Fees related to the administration of notes receivable and distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### ***Subsequent Events***

The Plan has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued. See Note 10.

### **3. INVESTMENTS**

T. Rowe Price Trust Company (the trustee) holds the funds for the Plan and T. Rowe Price Retirement Plan Services, Inc. (the recordkeeper) maintains an individual account for each participant. Contributions made on a participant's behalf under the Plan are directly allocated to that participant's account and are invested, based on the participant's direction, in a money market fund, mutual funds, and/or common collective trusts.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets.
  - Quoted prices for identical or similar assets or liabilities in inactive markets.
  - Inputs other than quoted prices that are observable for the asset or liability.
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market fund:* Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end money market fund that is registered with the U.S. Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the NAV of units of the collective trust. The NAV is based on the fair value of the underlying investments held by the trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of a collective trust, the issuer reserves the right to require 12- or 30- months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Although it has not expressed any intent to do so, the Academy has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### 7. TAX STATUS

The Academy has adopted a pre-approved plan provided by T. Rowe Price Retirement Plan Services, Inc. The pre-approved plan received an opinion letter dated August 19, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. In addition, the opinion letter stated that an employer who adopts this pre-approved plan may rely on the opinion letter with respect to the qualification of its own plan under the IRC. Although the Plan has been amended since the pre-approved plan received the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

A related party is any party who can control or significantly influence Plan management or operating policies. Parties in interest are defined under Department of Labor regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investments advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$52,069 to certain parties in interest for trust, recordkeeping, and other administrative services, as allowed by ERISA. The Plan Sponsor pays directly any other fees related to the operation of the Plan.

The Plan issues loans to participants, which are secured by the participant's account balance. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by employees of the Academy. No such employee receives compensation from the Plan.

#### **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **10. SUBSEQUENT EVENT**

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2025 and later. Plan management is evaluating these provisions and will update the Plan's governance and operations.
