For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following brief description of the KITCH ATTORNEYS & COUNSELORS, PC PROFIT SHARING PLAN provides only general information. Reference should be made to the plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan was established to provide retirement benefits for eligible employees. The Plan is a qualified defined contribution plan and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code. Plan assets are participant-directed. The Plan is intended to constitute a plan described in ERISA Section 404(c) and regulations issued thereunder.

2. Contributions

Under Section 401(k) of the Internal Revenue Code, all employees who are 21 years of age may elect to contribute compensation to the Plan, subject to the limitation under the Internal Revenue Code and the Plan (deferral contribution). The Firm, at its option, may contribute a percentage amount of the compensation paid to participants during the plan year (Firm contribution). The Firm may also make a discretionary matching contribution allocated based on the amount by which each participant's compensation was reduced pursuant to the participant's deferral contribution (Firm matching contribution). The Firm did not make any matching contributions for the 2024 and 2023 plan years. The Firm did, however, make a Firm contribution of \$1,038,600 and \$1,089,500 in 2024 and 2023, respectively.

3. Participant Accounts

Each participant's account is credited with the participant's deferral contribution, the Firm's matching contribution and an allocation of the Firm's contribution, plan earnings and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Vesting

Participants are immediately vested in their deferral contributions plus actual earnings thereon. The vesting of the remainder of their account balance is based on years of credited service. A participant is 100% vested after six years of credited service.

5. Forfeitures

Amounts which are not vested from the accounts of terminated participants are forfeited and allocated to the remaining participant accounts. During 2024 and 2023, the amounts forfeited and allocated were \$96,932 and \$74,491, respectively.

6. Payment of Benefits

Upon termination of service, participants or their beneficiaries may elect to receive a single lump-sum payment. Participants or their beneficiaries, should they retire, become disabled or die, are entitled to the fully vested balance of their account.

7. Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance. The minimum and maximum note amounts are \$1,000 and \$50,000, respectively. Notes are required to be repaid within five years, except those notes used in the purchase of a principal residence. Principal residence notes are required to be repaid within a reasonable time period. All notes bear interest at a reasonable rate, as of the inception date of the note. The notes are stated at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions under the terms of the Plan.

8. Administration

The Plan is administered by a committee established by the Firm. The committee has appointed a third-party service provider to provide certain administrative and record keeping services for the Plan. The committee has also appointed a paying agent to serve as trustee and custodian for the assets of the Plan. All funds in the Plan are held in trust, and are invested as directed by each participant in various funds selected by the Plan.

9. Administrative Expenses

Administrative expenses are paid by the Plan unless the Firm elects to pay them. For 2024, service provider fees, investment fees, ERISA insurance coverage costs and audit fees were paid by the Firm. These expenses were approximately \$13,000. The note fees related to specific participant accounts were paid by the Plan and allocated to those accounts. In addition, the Firm provided other administrative services to the Plan without charge, such as Plan administration by Firm employees.

10. Party in Interest Transactions

Eighteen of the funds selected by the Plan are funds offered by Fidelity Management Trust Company, a party in interest. Administrative expenses refunded to the Plan from these funds were \$4,374 and \$4,729 for 2024 and 2023, respectively. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies applied in the preparation of the accompanying financial statements follows.

1. Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual method of accounting.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

2. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

3. Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

4. Investments

The Plan's mutual fund investments are stated at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

The Plan's common/collective trust fund investment is stated at fair value. This value is the net asset value per share of the fund, which is based on the fair value of the funds underlying assets at year end.

The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on investments.

Purchases and sales of investments are recorded on a trade-date basis.

5. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 or 2023.

6. Payment of Benefits

Benefits are recorded when paid.

7. Subsequent Events

The Plan has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued.

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE E - FEDERAL INCOME TAX

The Plan obtained a favorable opinion letter issued by the Internal Revenue Service on June 30, 2020. The opinion letter stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code.

Effective April 6, 2021, the Plan was amended in its entirety and restated to reflect law changes.

Effective March 25, 2024, the Plan was amended to change the name to Kitch Attorneys & Counselors, PC Profit Sharing Plan from Kitch Drutchas Wagner Valitutti & Sherbrook, P.C. Profit Sharing Plan.

Plan management believes that the plan, as designed and as operated through December 31, 2024, is in compliance with the applicable requirements of the Internal Revenue Code. Plan management believes that the Plan was qualified and the related trust is tax-exempt through that date.

The Plan administrator believes the Plan is no longer subject to income tax examination for years prior to 2021.

NOTE G – COMMON/ COLLECTIVE TRUST FUND VALUE

The value of the common/collective trust fund is stated at fair value. This investment uses Net Asset Value (NAV) for fair value and files a Form 5500 as a Direct Filing Entity with the Department of Labor. The contract value of the investment is \$5,005,776 and \$5,508,274 as of December 31, 2024 and 2023, respectively. There were no unfunded commitments for this investment. The redemption frequency for: a Participant level transaction takes place daily; and a Plan level transaction requires notice and could result in the Plan's investment being held for up to twelve months.

NOTE H - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobserved inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the assets or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other meansIf the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1

Mutual funds. Each fund's Net Asset Value (NAV) is calculated as of the close of business of the NYSE. For funds with readily available market quotations, they are generally valued at their market value. When funds do not have readily available market quotations, they are valued based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
