Note 1 - Description of Plan:

On April 1, 2020, Wheeling-Nisshin, Inc., changed its name to Wheeling-Nippon Steel, Inc., (the Company). Accordingly, the plan name was changed to the Wheeling-Nippon Steel Defined Contribution Profit-Sharing Plan for Union Employees, (the Plan). The Company is also the plan sponsor for their non-union plan as well (Wheeling-Nippon Defined Contribution Profit-Sharing Plan for Non-Union Employees). When participants designations change from “union” to “non-union” employees, they are allowed to transfer their balance to the plan meeting their designation. The Plan has been amended and restated effective January 1, 2022 to conform the Plan to new tax laws and some provisions may be retroactively effective.

The following description of the Plan provides only general information. Participants should refer to the plan document for more complete information.

General

The Plan is a defined contribution plan covering essentially all full-time union employees of the Company on the date of employment. Participants are eligible for elective deferrals, Roth contributions, and an allocation of the Company’s matching contribution upon reaching the age of 18. The Plan entry date will be the first day of the month coinciding with the date of hire. For an allocation of the Company’s pension contribution, the participant must work 1,000 hours of service in the calendar year. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the Company oversees governance of the Plan. The Plan’s investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investments performance, and reports to the Plan’s Board of Directors.

Contributions

Each year, participants may elect to contribute a specific percentage or dollar amount of annual compensation. Participant contributions to the Plan are subject to the limitations under Section 402(g) of the Internal Revenue Code, \$23,000 for 2024 and \$22,500 for 2023. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into the various investment options offered by the Plan.

The Company contributes 50% of participant contributions to the Plan, up to a maximum of \$1,600 for the 2024 and 2023 Plan years. This matching contribution is invested in the same manner as the participant contributions. Total Company matching contributions were \$184,981 for the year ended December 31, 2024.

The Company makes additional contributions to the individual participants at the end of each Plan year, considered a pension contribution, and these contributions are determined as follows:

For the year ended December 31, 2024 total pension contributions approved for the Plan were \$655,745. The total net employer contributions were \$840,726 for the year ended December 31, 2024. For additional information, see the Forfeited Accounts footnote below.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a monthly payout.

Note 1 - Description of Plan (continued):

Distributions

Effective January 1, 2016, a participant may request a minimum Ad-Hoc distribution of \$5,000, once per calendar year quarter.

Forfeited Accounts

At December 31, 2024 and 2023, the forfeited nonvested accounts were \$247 and \$22, respectively. These accounts can be used towards Company nonelective contributions or to restore participant accounts. For the year ended December 31, 2024, \$1,408 were used to restore participant accounts.

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments of the Plan are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation and for which participant compensation is earned.

Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Payments of Benefits

Benefits are recorded when paid.

Consideration of Subsequent Events

For the year ended December 31, 2024, the Plan has evaluated the subsequent events for potential recognition and disclosure through August 21, 2025 the date the financial statements were available to be issued.

Note 3 – Certified Investments:

Certified information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Retirement, an agent for Empower Trust Company, LLC, the trustee of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 - Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC), Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Note 4 - Fair Value Measurements (continued):

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the Company contribution portion of their account.

Note 6 – Fully Benefit-Responsive Investment Contract:

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Retirement, the agent for Empower Trust Company, LLC. (Empower) totaling \$2,437,264 and \$2,844,822 for the years ended December 31, 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 4 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6 – Fully Benefit-Responsive Investment Contract (Continued):

The contract meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity with provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemptions under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact and contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligations under the contract, (3) a material misrepresentation or, (4) a material amendment to the agreement without the consent of the issuer.

Note 7 - Tax Status:

Effective January 1, 2014, the Plan documents were converted to pre-approved Volume Submitter Plan and Trust documents sponsored by Empower Trust Company, LLC. The Internal Revenue Service (IRS) has determined and informed Empower Trust Company, LLC by a letter dated June 30, 2020 that the form of the volume submitter plan and trust documents being utilized by the Plan are acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Note 7 - Tax Status (Continued):

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan has not been examined by the Internal Revenue Service for open years under the Statute of Limitations.

Note 8 – Related-Party Transactions and Party-in-Interest Transactions:

Certain Plan investments are managed by Empower Retirement (Empower). Empower is the agent for the trustee, Empower Trust Company, LLC. as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan, and paid to Empower are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Note 9 – Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
