## **INDEPENDENT AUDITOR'S REPORT**

To the Board of Trustees of the  
Best Labor 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### **NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Best Labor 401(k) Plan (the Plan) provides only general information. For more complete information, participants should refer to the Plan instrument, a copy of which is on file in the office of the Plan sponsor.

#### ***General***

The Plan is a defined contribution 401(k) profit sharing retirement plan covering all eligible employees from Best Labor Contractors, LLC (the Company) and any affiliate that has adopted the Plan. The Company is the Plan sponsor, with the following participating employers: 3M Builders Inc., 4D Construction LLC, Apartment Rental Services Inc., International General Contractors, Legacy Cabinets FL, LLC and Pated LLC. The Plan commenced on January 1, 2020 and was restated effective January 1, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Eligibility***

Employees of the Company and its participating affiliates are eligible to participate in the Plan on the first day of each Plan quarter, coincident with or next following the date of attaining age 21 and completing one year of service with at least 1,000 of service. Leased employees and non-resident aliens are excluded as well as employees covered by a collective bargaining agreement if retirement benefits were the subject of good faith bargaining, and if the collective bargaining agreement does not provide for participation in this Plan.

#### ***Funding***

Each year participants may contribute up to 90% of pretax annual compensation as defined in the Plan. According to Internal Revenue Service (IRS) rules, the deferral may not exceed \$23,000 in 2024 and \$22,500 in 2023. Participants who have reached at least age 50 may contribute an additional catch-up yearly contribution of \$7,500 during 2024 and 2023. Eligible participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

The employer matches 100% of the participant contribution not to exceed 4% of compensation. The safe harbor match contribution for highly compensated employees is capped at \$6,000. Contributions are subject to certain limitations.

The employer may also make, at its sole discretion, profit-sharing contributions to the Plan. The profit-sharing contributions would be allocated to each eligible participant in pro rata shares.

Additionally, the employer may make qualified non-elective contributions for the benefit of such participants determined at the discretion of the Company. In order to share in the allocation of any non-elective contributions, participants are required to be employed by the employer on the last day of the Plan year.

### NOTE 1. DESCRIPTION OF THE PLAN (Continued)

#### *Participant Accounts*

Each participant's account is credited with 1) participant contributions; 2) the employers' matching contribution; and 3) a ratable portion of investment gain or loss, net of Plan expenses. Each participant's account is charged with any distributions made to that participant.

#### *Vesting*

Participants are immediately vested in their elective contributions, rollover contributions, and any qualified non-elective contribution plus actual earnings thereon.

Effective on January 1, 2022, in accordance with Safe Harbor Rules, participants are immediately vested in all contributions, including employer matching contributions plus actual earnings thereon.

#### *Investment Options*

Upon enrollment in the Plan, a participant may direct contributions to be allocated among a selection of securities provided by the Plan (see Note 3).

#### *Payment of Benefits*

The Plan provides for mandatory distributions to participants no longer employed by the Plan sponsor with vested account balances of less than \$5,000 excluding any rollovers. If the terminated participant's vested balance does not exceed \$1,000, it will be distributed directly to the participant in cash. If the terminated participant's vested balance is \$1,000 or higher, but does not exceed \$5,000, the balance will automatically be transferred to an IRA under the participant's name unless the participant completes an election form providing other instructions for this mandatory distribution.

Upon termination of service due to disability or retirement, participants may withdraw from the account a lump-sum cash distribution of the vested value of their account.

For participants who die before their account balance distribution, their entire balance must be distributed by December 31 of the calendar year containing the fifth anniversary of their death.

#### *Forfeitures*

Forfeitures may be used to restore other forfeitures, reduce future employer contributions, reallocate as employer contributions, or to pay Plan expenses. The forfeiture balances available for use were \$10,419 and \$10,420 as of December 31, 2024 and 2023, respectively.

### NOTE 1. DESCRIPTION OF THE PLAN (Continued)

#### *Notes Receivable from Participants*

Participants may borrow from their accounts from \$1,000 up to a maximum of 50% of their vested account balance or \$50,000 minus the highest outstanding balance of loans in the past 12 months, whichever is less. Loan terms would not exceed 5 years unless the loan was for the purchase of a primary residence. The maximum loan term for a primary residence is 10 years. The loans would be secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates provided by local lending institutions. Loans are only available to Plan participants who are active employees of the Plan sponsor or participating employers, therefore, they become payable in full upon termination of employment. Participant loans had an outstanding balance for the years ended December 31, 2024 and 2023 of \$88,321 and \$44,819, respectively, with interest rates ranging between 8.75% and 12.72% and various maturities through 2029.

#### *Termination*

Although there is no intent to do so, the Plan document provides for termination of the Plan subject to the provisions of the agreement and ERISA. If the Plan were to be terminated, all account balances would become immediately vested.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *Basis of Accounting and Use of Estimates*

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 4 for discussion of fair value measurements).

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Concentration of Credit Risk*

Financial instruments, which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consist primarily of contributions receivable and investments. The Plan invests in mutual funds and collective investment trust, which, inherent in the fair market value determination, include the risk factor of credit worthiness for each individual debt security.

### NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

John Hancock Life Insurance Company, the custodian, held the Plan's investments as of December 31, 2024 and 2023. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the supplementary schedule Form 5500 - Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally mutual funds and collective investment trust) and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying mutual funds and collective investment trust (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$456,204. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

### NOTE 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy, which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in methodologies used to measure fair value as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: Fair value is determined by comparing the rates in effect on that date to the rates on which the actual interest is determined and the book value is adjusted based on the difference in those rates as calculated by John Hancock. Although there is no secondary market for the Stable Value Guaranteed Income Fund to which those fair values can be compared, the rates are applied to both new deposits and the calculation of fair value to constitute an active market.

### **NOTE 5. RELATED PARTIES**

The Company is the Plan's employer and sponsor and absorbs virtually all administrative expenses of the Plan except for investment administration fees.

### **NOTE 6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

### **NOTE 7. TAX STATUS**

The Plan is exempt from Federal income taxes under Internal Revenue Code (IRC) and, therefore, no provision for Federal income taxes has been made. In addition, the Plan is required to operate in conformity with the IRC to maintain the tax-exempt status. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no such positions have been taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes that the Plan is no longer subject to such audits for tax periods prior to December 31, 2021

### **NOTE 8. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments may include shares of investments managed by John Hancock, which has fiduciary responsibility. This makes transactions between the Plan and John Hancock party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

Additionally, the Plan pays John Hancock for contract administration fees. This expense amounted to \$46,430 for the year ended December 31, 2024, and has been included in the accompanying statement of changes in net assets available for benefits as part of administrative fees.

### **NOTE 9. SUBSEQUENT EVENTS**

Management has evaluated subsequent events for the Plan through August 22, 2025, the date the financial statements were available to be issued.


