Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SACHEM, Inc. Employees Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule of Assets Held at End of Year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements Year Ended December 31, 2024

1. Description of Plan

The following brief description of SACHEM, Inc. Employees Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering substantially all employees of SACHEM, Inc. (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The trustee of the Plan is Fidelity Management Trust Company (the “Trustee”). Company management personnel act as the administrator of the Plan.

Eligibility - Employees who are at least eighteen years of age are eligible to participate in the Plan on the first day of the month following the date the eligibility requirement is met. A participant must also be employed on December 31 to be eligible for a discretionary employer contribution. Certain employee classes are excluded from participation in the Plan, as defined.

Contributions - Eligible employees have the option to contribute pre-tax, after-tax and Roth contributions. Eligible employees may authorize the Company to withhold pre-tax and Roth contributions up to 60% of his or her eligible compensation and up to 100% of his or her eligible compensation for after-tax contributions, not to exceed the annual limit established by the Internal Revenue Code (“IRC”). All newly eligible and rehired employees, other than eligible temporary employees, are automatically enrolled in the Plan with a pre-tax deferral percentage of 3%, unless the employee elects otherwise. The automatic deferral contributions increase annually by 1%, not to exceed 8% of eligible compensation. A participant’s pre-tax, after-tax and Roth contributions will be separately accounted for, as will the gains and losses attributable to each. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees, including those who have not met the age requirement for Plan participation, may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts.

The Company contributes safe harbor nonelective employer contributions equal to 3% of each eligible participant’s Plan compensation during the Plan year. The Company made a safe harbor contribution totaling \$444,436 for the year ended December 31, 2024.

The Plan also provides for discretionary employer contributions. The Company did not elect to make a discretionary nonelective employer contribution or discretionary employer matching contribution for the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings, and may be charged with an allocation of Plan expenses, as applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of 1) \$50,000 reduced by the excess, if any, of i) the highest outstanding note receivable balance during the prior twelve-month period, over ii) the outstanding note receivable balance on the date the new note receivable is made or 2) 50% of their vested account balance, whichever is less. Participant notes receivable are secured by the vested balance in the participant's account and bear interest at the prime rate. Participants may have two notes receivable outstanding at a time although a participant may only apply for one note receivable during a calendar year. Notes receivable repayments are deducted through after-tax payroll deductions over a period not to exceed five years, unless the note receivable is for the purchase of a participant's primary residence, in which case the repayment period may not exceed ten years.

Vesting - Participants are immediately vested in their voluntary and safe harbor nonelective contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions plus actual earnings thereon is based on years of credited service. A participant is 100% vested after five years of credited service, as defined, or upon reaching retirement age, if they become disabled while employed with the Company or terminate employment due to death.

Payment of Benefits - Benefits are generally payable upon age 59.5, disability, death, retirement or termination of employment. Benefits equal to the participant's vested account balance may be paid to a participant or beneficiary by lump sum, annuity, installments or rollover into a qualified plan, subject to regulatory requirements. Required minimum distributions are made to applicable participants in the absence of adequate distribution elections. Generally, if no longer employed by the Company, participants must either take a lump sum distribution or begin systematic, actuarially determined withdrawals by April 1 of the year following the year in which the participant turns 73 years of age. The Plan administrator may, without the participants' consent, distribute separated participants' account balances that are less than \$1,000 in a lump sum. In-service distributions of rollover and other after-tax contributions may be taken at any time. Other in-service distributions, including hardship distributions, are permitted if certain criteria are met.

Spousal Consent - A note receivable or distribution request generally requires spousal consent prior to approval if a married participant has a vested account balance that exceeds \$5,000 when the request is made.

Forfeitures - Forfeitures by participants of unvested Company contributions are used to reduce future employer contributions and pay Plan administrative expenses. The forfeited unvested account balance totaled \$32,216 and \$70,327 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures totaling \$51,543 were utilized to pay administrative expenses and \$83,021 was used to reduce the Company's 2023 employer contributions remitted in 2024.

Current Legislation - The SECURE 2.0 Act of 2022 (“SECURE 2.0”), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date, and any SECURE 2.0 amendments must be adopted by the Plan no later than December 31, 2026, although it may operate under the new provisions as required or elected prior to amending the Plan document. The Company is currently evaluating the impact of the remaining required and voluntary provisions of SECURE 2.0 on the Plan and its participants.

2. Significant Accounting Policies

Basis of Accounting - The Plan’s financial statements are prepared on the accrual basis of accounting.

Accounting Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The SACHEM, Inc. Retirement Plan Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held, during the Plan year.

Contributions Receivable - Contributions from participants are recorded in the year in which the participant contributions are withheld from compensation. The Company recognizes an allowance for credit losses based on factors such as the age of the contribution receivable balance, historical experience, current economic conditions, and reasonable and supportable forecasts. There was no allowance for estimated credit losses as of December 31, 2024 or 2023 as management deemed the outstanding contribution receivable balances collectible.

Notes Receivable from Participants - Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. The Plan distributes each year’s excess contributions to the applicable participants prior to March 15 of the following year.

Benefits Paid to Participants - Benefits are recorded when paid.

Expenses - The Company may pay certain administrative and operating costs of the Plan at no obligation to the Plan. Fees related to the administration of notes receivable from participants and distributions, and certain other fees paid to service providers, are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses, such as management fees and operating expenses, are deducted from earnings recorded to net appreciation in fair value of investments.

Risks and Uncertainties - Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer contribution portion of their accounts.

3. Information Certified by the Trustee

Certain information in the accompanying financial statements, notes and supplemental schedule related to the Plan's investments and notes receivable from participants held as of December 31, 2024 and 2023, and the related net investment gain and interest income on notes receivable from participants during the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution.

4. Fair Value Measurements

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Common/collective trusts are pooled investment vehicles designed primarily for certain qualified retirement plans. The fair value of these investments has been estimated using the net asset value per unit as a practical expedient, as provided by the fund managers, and is based on the fair value of the underlying investments held by each fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported net asset values. There are no restrictions on participant redemptions, units may be redeemed daily and there are no unfunded commitments. If the Plan initiates a full redemption of the Reliance Trust New York Life Anchor Account Series I 0 Fund, the issuer reserves the right to require a twelve-month notice prior to distribution. If the Plan initiates a redemption of more than \$1 million of the MFS Mid Cap Growth CIT Fee S Fund, the issuer reserves the right to require a five-business-day notice prior to distribution.

5. Tax Status

The Company has adopted a pre-approved plan document from FMR LLC that received an Internal Revenue Service (“IRS”) opinion letter dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-in-Interest and Related Party Transactions

Certain Plan investments are shares of mutual funds managed by the Trustee or its affiliates. The Plan paid both direct and indirect fees to these entities for recordkeeping and investment management services. Additionally, the Plan paid fees to an investment advisor and an auditor. Transactions such as these, as well as notes receivable from participants, qualify as exempt party-in-interest transactions. The Company also pays directly certain other fees related to the Plan’s operations.

7. Subsequent Events

The Company has evaluated subsequent events through August 29, 2025, the date the financial statements were available to be issued.

During the year ending December 31, 2025, management determined that the Plan experienced a partial termination. As a result of the partial termination, all affected participants became fully vested in the Company’s contributions plus actual earnings thereon.
