To the Plan Administrator
Readerlink Distribution Services, LLC Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Readerlink Distribution Services, LLC Retirement Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Empower Trust Company, LLC and Empower Annuity Insurance Company of America as of December 31, 2024 and for the period from April 25, 2024 to December 31, 2024, and Vanguard Fiduciary Trust Company for the period from January 1, 2024 to April 25, 2024 stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section,

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying 2024 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

ERISA-Required Supplementary Information

The schedule of assets (held at end of year) as of December 31, 2024 and schedule of delinquent participant contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Readerlink Distribution Services, LLC Retirement Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through July 28, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Readerlink Distribution Services, LLC is the plan sponsor, employer and plan administrator. Prior to April 25, 2024, Vanguard Fiduciary Trust Company ("Vanguard") was the trustee that held custody of plan investment assets, recordkeeper that maintained participant accounts and related information, third party administrator that maintained plan documents, and tax counsel that performed various compliance tests. Effective April 25, 2024, Empower Retirement, LLC assumed the recordkeeping, third party administrator and tax counsel responsibilities. Empower Trust Company, LLC became the trustee that holds custody of the plan's mutual funds and common/collective trust investment. Empower Annuity Insurance Company of America holds custody of the plan's guaranteed investment contract. The Empower entities discussed above are collectively referred to as "Empower". Creative Planning is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings on investments bought, sold and held during the years are reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - The mutual funds held by the plan are valued at the daily quoted market prices as reported by the funds. The mutual funds are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common/collective trust - The plan invests in the Vanguard Retirement Savings Trust. The trust is a direct filing entity valued at NAV based on the underlying value as reported by the fund. The NAV is used as a practical expedient to estimate fair value and is generally based on the fair value of the underlying investments held by the common/collective trust less its liabilities. This practical expedient would not be used if it determined to be probable that the common/collective trust would sell the investment for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

Investment at contract value - The plan invests in the Guaranteed Income Fund, a general account product of Empower. The investment is a fully benefit-responsive guaranteed income fund through a group fixed annuity contract issued by Empower. As a general account product, participants' principal and interest amounts are fully guaranteed by the general assets of Empower. The guaranteed interest rate is announced in advance and is guaranteed for a six-month period. A minimum rate will apply.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value at any time. Empower has the option to limit participant transfers from this investment to other investments within the plan, however, Empower has never exercised this option so it does not have practical effect.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan administrator is not aware of any events that might limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was adopted effective November 28, 1952 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to participate in the plan and receive employer QACA safe harbor matching contributions once they have completed 30 days of service. Part-time, temporary, and seasonal non-union employees are eligible to participate in the plan and receive employer QACA safe harbor matching contributions once they have completed 1,000 hours of service. Part-time, temporary, and seasonal union employees are eligible to participate in the plan and receive employer QACA safe harbor matching contributions once they have completed 90 days of service. An employee can enter the plan immediately following completion of eligibility requirements.

For purposes of nonelective contributions, employees are eligible if they have completed 12 months of service and must be employed on the last day of the plan year. An employee can start receiving nonelective contributions on the first day of the calendar quarter following completion of the eligibility requirements.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Eligible employees with no existing salary reduction agreement are automatically enrolled in the plan and have 5% of compensation withheld as elective deferral contributions. Such participant deferral percentages automatically increase by 1% each October 1 until they reach a maximum of 10%. Such employees have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.

- c. Employer safe harbor matching contributions are made equal to 100% of the first 1% contributed by the employee and 50% of the next 5% contributed by the employee. These contributions are funded on an annual basis subsequent to year-end.
- d. Additional nonelective employer contributions may be made at the employer's discretion. No such contributions were made in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions, any rollover contributions, and an allocation of employer contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their elective deferral contributions, rollover contributions, safe harbor contributions and related earnings. Participants become 20% vested in any nonelective employer contributions and related earnings upon two full years of service. The participant then vests at the rate of 20% for each year thereafter. Upon death or disability participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age (defined as 59 ½). Distributions can be made in the form of a single lump sum or installment payments. In-service withdrawals can commence upon attaining the age of 59½. Hardship withdrawals are also permitted under certain circumstances as defined in the plan documents.

Administrative expenses - Certain administrative fees of the plan are paid by the employer and not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expenses include participant directed charges for loan and distribution fees and nonparticipant directed charges for services and administrative fees. Nonparticipant directed fees are allocated on an account value basis.

Forfeitures - Forfeited nonvested accounts can be used to reduce any employer contributions or pay plan expenses. Forfeitures used to pay plan expenses were \$58,000 in 2024 and \$7,000 in 2023. Unapplied forfeitures were insignificant as of December 31, 2024 and 2023.

Notes receivable from participants - Participants may obtain a loan from their accounts with approval of the plan administrator. Participants may only have two loans outstanding at any given time. The minimum loan amount is \$1,000 and the total outstanding loan cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000. The repayment term cannot exceed five years unless used to purchase a primary residence. As of December 31, 2024, loans outstanding had various repayment schedules through December 2029 with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Vanguard was the trustee that held custody of the plan's investment assets and also managed certain of the plan's investment options. As such, transactions between Vanguard and the plan qualified as party-in-interest transactions. Vanguard also provided certain administrative services to the plan pursuant to a service agreement between the plan sponsor and Vanguard. Vanguard received revenue from certain mutual fund service providers for services Vanguard provided to the funds. This revenue was considered indirect compensation and was used to offset certain amounts that would otherwise be owed by the plan to Vanguard for its administrative services to the plan. Direct fees paid by the plan to Vanguard were \$88,000 in 2024 and \$204,000 in 2023.

Effective April 25, 2024, Empower holds custody of the plan's investment assets and also manages the guaranteed income fund. As such, transactions between Empower and the plan qualify as party-in-interest transactions. Empower receives indirect compensation from the plan's mutual fund investment providers for services Empower provides to the funds. Certain revenues received by Empower from such service providers are remitted to the plan in the form of service credits (as part of an administrative services agreement between the plan sponsor and Empower). Such service credits received by the plan are used by the plan to pay advisory services and other plan fees. There are also certain other plan expenses that Empower charges that are paid by the plan directly. Direct fees paid by the plan to Empower were \$90,000 in 2024.

Activity related to notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any discretionary employer contributions and related earnings.

5. INCOME TAX STATUS

The plan was operating under a Vanguard Fiduciary Trust Company pre-approved profit sharing plan through April 24, 2024. The pre-approved profit sharing plan obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Effective April 25, 2024, the plan adopted an Empower Retirement LLC pre-approved profit sharing plan that received a favorable opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believe the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY VANGUARD AND EMPOWER

Management has obtained certifications from Vanguard and Empower, which are qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values and contract values of such and notes receivable from participants as of December 31, 2024 and 2023;
- b. Dividends and interest income from investments, net appreciation (depreciation) of investments and interest income on notes receivable from participants during 2024 and 2023;
- c. Purchases and sales of investments during 2024 and 2023; and

- d. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023.

7. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

During 2023, the plan sponsor remitted employee elective deferral contributions to Vanguard later than required by Department of Labor Regulation 2510.3-102. The plan sponsor will calculate and remit lost earnings related to the late contributions in 2025 to account for the investment income that would have been earned had the contributions been remitted on a timely basis. In addition, the plan sponsor will file the Internal Revenue Service Form 5330 and pay the associated excise tax.
