## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of  
DGI Communications, LLC Retirement Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of DGI Communications, LLC Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Supplemental Schedule Required by ERISA***

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. ## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the DGI Communications, LLC Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General** – The Plan is a defined contribution plan established on March 10, 1989 covering all employees of DGI Communications, LLC (the “Company”) who are an active participant on the day on which they become an employee. Enrollment and changes to contributions can be made at any time. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

**Contributions** – Each year, participants may contribute up to 100% of compensation, to the maximum allowed by the Internal Revenue Code (the “Code”). Participants may also contribute amounts representing distributions from other qualified retirement plans to the extent permitted by the Plan. The Plan allows participants, who are projected to be age fifty or older by the end of the Plan year and who are making deferral contributions to the Plan, to make catch-up contributions of up to \$7,500. The Company may make matching contributions at the discretion of Company ownership. The Company made discretionary contributions to the Plan for the years ended December 31, 2024 and 2023 of \$84,228 and \$105,759, respectively, calculated as 50% of the first 6% of employee contributions, limited to \$1,000 per year. All contributions are subject to certain limitations imposed by the Plan and the Code.

**Participant Accounts** – Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options** – Participants may direct their contributions to a variety of options, including fully benefit-responsive investment contracts, a self-directed brokerage account, and mutual funds held at John Hancock Trust Company (the trustee of the Plan). These options offer various objectives and degrees of financial risk.

**Notes Receivable from Participants** – Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or one-half of their vested account balance. Note terms range from one to five years (excluding principal residence loans that can have terms up to 15 years). The notes are secured by the balance in the participant’s account and bear interest at a rate which professional lenders would charge, as determined by the Plan Administrator. The maximum amount of loans outstanding at any one time is one. The outstanding notes currently bear interest between 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

**1. DESCRIPTION OF THE PLAN (CONTINUED)**

**Vesting** – Participants are immediately vested in their deferral contributions and rollovers including the earnings on these amounts. Effective February 1, 2020, the Plan was amended to adopt a new vesting schedule. Prior to that date, participants immediately vested in discretionary matching contributions. Under the new schedule, vesting in the Company’s matching contributions, plus earnings thereon, is based on years of continuous service. A participant is 100% vested in the matching contributions after four years of credited service using the elapsed time method. The following represents the vesting schedule for matching contributions for participants entering the Plan after February 1, 2020:

4 years or more	100%

In the event of death or permanent disability, a participant’s employer contribution account becomes fully vested.

**Forfeited accounts** – A participant who leaves the Company forfeits any non-vested balance after the date the participant incurs five consecutive one-year breaks in service. The Plan uses such forfeitures to first reduce administrative expenses under the Plan. Any remaining amounts will be used to reduce future employer contributions. At December 31, 2024 and 2023, there was \$53,423 and \$33,491 in the forfeitures account. There were no forfeitures used in 2024 or 2023.

**Payment of Benefits** – Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account. The Plan also provides for in-service withdrawals for qualified participants. Distributions will be paid by lump sum or in installments over several years. Upon financial hardship, a participant may request an amount up to the value of any of his or her deferral accounts, but not the earnings thereon.

**Expenses** – Expenses of the Plan will be paid in accordance with the most recent service and expense agreement or such other documents duly entered into by or with regard to the Plan that govern such matters. Such expenses include expenses for bonding required by ERISA; expenses for recordkeeping and other administrative services; fees and expenses of the Custodian or Annuity Contract; expenses for investment education service; and direct costs that are incurred with respect to the Plan. Administrative expense paid by the Plan to John Hancock (the trustee of the Plan) or their affiliates totaled \$45,893 and \$42,695 for the years ended December 31, 2024 and 2023, respectively.

**Termination** – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

***Basis of Accounting*** – The accompanying financial statements have been prepared on the accrual basis of accounting.

***Use of Estimates*** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Payment of Benefits*** – Benefit payments to participants are recorded when paid.

***Notes Receivable from Participants*** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis.

***Investment Valuation and Income Recognition*** – The Plan’s investments are reported at fair value, except for fully benefit-responsive contracts that are recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan’s valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Risk and Uncertainties*** – The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term, and those changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

***Subsequent events*** – The Company has evaluated subsequent events through August 7, 2025, the date the financial statements were available to be issued.

## 3. INVESTMENT INFORMATION CERTIFIED BY JOHN HANCOCK TRUST COMPANY

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company (the trustee of the Plan).

## 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described below:

#### 4. FAIR VALUE MEASUREMENTS (CONTINUED)

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation method include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds* – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Assets held in self-managed accounts* – Assets held in self-managed accounts include cash equivalents and common stock. These assets are stated at fair value based on quoted market prices of the assets held in the accounts.

## **5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The Plan holds a guaranteed investment contract in the John Hancock Life Insurance Company Stable Value Guaranteed Income Fund that meets the criteria of a fully benefit-responsive investment contract and is therefore reported at contract value. Contract value presents contributions made under the contract plus earnings, less participant withdrawals, and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contract.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

## **6. INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan document effective January 2022. The Internal Revenue Service has determined and informed the Trustee by a favorable opinion letter dated June 30, 2020, that the plan is designed in accordance with the applicable sections of the Code. The plan's opinion letter is being relied on by the Plan. The Plan has since been amended. Despite the amendments, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

**6. INCOME TAX STATUS (CONTINUED)**

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PARTY-IN-INTEREST**

Certain plan investments are shares of mutual funds managed by affiliates of John Hancock, the recordkeeper and trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.
