## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Berkshire Corporation 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Berkshire Corporation 401(k) Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Berkshire Corporation 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

#### **Other Matter — Supplemental Schedules Required by ERISA**

The supplemental Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Berkshire Corporation (the Company) 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all full-time and part-time employees of the Company who have six months of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

The Plan is for the benefit of the employees of Berkshire Corporation, Berkshire Holding Corporation, and Monument Mountain Trust.

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is a nondiscretionary trustee and custodian of the Plan assets as of December 31, 2024 and 2023. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company provides record keeping services for the Plan.

##### **Plan Contributions**

Each year participants may contribute a portion of pretax annual compensation, up to \$23,000 and \$22,500 for the calendar years 2024 and 2023, respectively, as defined by the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make "catch-up" contributions of \$7,500. At the discretion of the Plan Administrator participants may also make rollover contributions which represent distributions from other qualified plans and certain individual retirement accounts (IRAs). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual and money funds as investment options for participants.

Profit sharing by the Company consists of discretionary matching contributions of fifty cents on the dollar, up to 7% (seven percent) of the participant's compensation for each of the Plan's years ended December 31, 2024 and 2023, and a discretionary profit sharing contribution. The discretionary employer contributions, which are contributed at the option of the Company's Board of Directors, are invested in a portfolio of investments as directed by the participants.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, (c) forfeitures of terminated participants' nonvested accounts, and (d) certain Plan expenses. Allocations of Plan earnings are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

## **NOTE 1 - (Continued)**

### **Participants Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years, but may be longer if obtained for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate considered reasonable by the Plan Administrator. Principal and interest are paid ratably through bi-weekly payroll deductions. The amount of the unpaid loan at the date of termination of employment reduces the vested balance of the participant.

### **Payments of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period not to exceed life expectancy. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$37,102 and \$13,777, respectively. Non-vested forfeited amounts are used to offset future employer contributions. During 2024 and 2023, respectively, \$21,667 and \$9,112 in forfeited accounts were used to offset employer contributions.

### **Participant Investment Rollovers**

Participants are allowed to transfer or rollover funds into the Plan from another qualified employer plan.

### **Plan Expenses**

Expenses of the Plan are shared by the Company and the plan participants. Individual participant accounts are charged directly for loan recordkeeping, benefit disbursement processing, and custodial fees, if applicable.

## **NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

### **Use of Accounting Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Quoted prices in actual markets are used to value investments on a recurring basis. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest and other investment income is recorded as earned on an accrual basis. Net investment appreciation (depreciation) in fair value includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### **Payment of Benefits**

Benefits are recorded when paid.

## **NOTE 2 - (Continued)**

### **Plan Expenses**

Expenses of the Plan are shared by the Company and the plan participants.

### **Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving this determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

### *Uncertain Tax Positions*

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Subsequent Events**

Management has evaluated subsequent events through August 26, 2025, the date which the financial statements were available to be issued, and has determined that there are no additional adjustments or disclosures required.

## **NOTE 3 - RISKS AND UNCERTAINTIES**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

## **NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participants accounts and distributed in such a manner as the Company may determine.

## **NOTE 5 - INFORMATION CERTIFIED BY THE CUSTODIANS**

As noted in the independent auditors' report, the Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employment Retirement Income Security Act of 1974 (ERISA). Accordingly, no auditing procedures with respect to the information certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodians, were performed by the independent auditors except for comparing the information to the financial statements and supplemental schedule.

## **NOTE 5 - (Continued)**

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company has certified as to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, the related investment activity reflected in the statements of changes in net assets available for benefits as of December 31, 2024 and December 31, 2023, and the information contained in the schedule of assets (held at end of year) as of December 31, 2024.

## **NOTE 6 - INVESTMENTS**

### **Fair value measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit.

Financial Accounting Standards Board (FASB) Accounting Standards Codification 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

#### *Level 1 Fair Value Measurements*

Level 1 inputs are quoted prices for identical assets or liabilities in active markets that the plan has the ability to access. Mutual funds are valued at the net asset value of the shares held by the plan at year end.

Mutual funds of \$12,270,970 and \$11,206,525 as of December 31, 2024 and 2023, respectively, were measured and recorded on a recurring basis and, therefore, are classified as Level 1 with respect to fair value measurements.

#### *Level 2 Fair Value Measurements*

Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, and include quoted market prices for similar assets or liabilities in active markets. There were no assets with Level 2 fair value measurements at December 31, 2024 or 2023.

#### *Level 3 Fair Value Measurements*

Level 3 inputs are unobservable inputs for an asset or liability and would be used to measure the fair value to the extent that relevant observable inputs are not available. There were no assets with Level 3 fair value measurements at December 31, 2024 or 2023.

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated (depreciated) in value by \$1,069,598 and \$1,465,803 respectively.

### **Guaranteed Investment Contracts**

Guaranteed Investment Contracts are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. Plan management has various processes and controls in place to ensure that fair value is reasonably estimated. Valuation approaches are reviewed on an ongoing basis and revised as necessary based on changing market conditions to ensure values represent a reasonable exit price.

## **NOTE 7 – GUARANTEED INVESTMENT CONTRACTS**

The Plan has a fully benefit-responsive group annuity contract with Principal Life Insurance Company (Principal Life). The contract has a guarantee backed by the assets in the multi-billion dollar general account of Principal Life. The general account consists of over 7,000 investments, which include corporate bonds, asset-backed securities, commercial real estate mortgages, government bonds, and short-term cash equivalents. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum crediting interest rate for the contract is 1.75%, minus quarterly fees. The contract has no maturity date.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs or a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at the contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

The balance of the Plan's investments reported as fully benefit-responsive was \$1,931,801 and \$1,854,878 at December 31, 2024 and 2023, respectively.

## **NOTE 8 - PARTY-IN-INTEREST**

Certain Plan investments are shares of mutual funds managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. Principal Trust Company is the recordkeeper as defined by the Plan, therefore, these transactions qualify as permitted party-in-interest transactions.
