Report of Independent Auditors

To the Administrator of Hadady, LLC Profit Sharing and 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Hadady, LLC Profit Sharing and 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements
December 31, 2024 and 2023

1. Plan Description

The following description of the Hadady, LLC Profit Sharing and 401(k) Savings Plan (the "Plan") (f/k/a Hadady, Corporation Profit Sharing and 401(k) Savings Plan) provides only general information. Participants should refer to the Plan document for more complete information regarding the Plan.

Effective June 1, 2024, the Plan was amended and renamed Hadady, LLC Profit Sharing and 401(k) Savings Plan.

General

The Plan is a profit sharing plan that includes a cash or deferred arrangement under Section 401(k) of the Internal Revenue Code ("IRC"). The Plan is maintained and sponsored by Hadady LLC (the "Company") (f/k/a Hadady Corporation), a 100 percent-owned subsidiary of Caterpillar Inc., and enables eligible employees of the Company to accumulate funds for retirement. The Plan is governed by the provisions of the Employee Retirement Income Security Act, as amended ("ERISA").

Participation

Employees of the Company who are not covered by a collective bargaining agreement, who are age 21 or older with one year of service (1,000 hours) and who are designated for participation by the Company, are eligible to participate in the Plan. Participating eligible employees (the "participants") elect to defer a portion of their eligible compensation through pre-tax and after-tax contributions.

Contributions

All participants are eligible to make participant contributions through a pre-tax deferral arrangement and an after-tax Roth 401(k) arrangement as elected by each participant. Participants who are at least 50 years old by the end of the calendar year are allowed to make a catch-up contribution for that year. Contributions are subject to certain limitations set by the IRC.

The Company may, at its discretion, make employer matching contributions to the Plan, as well as an additional profit-sharing contribution. For the year ended December 31, 2024, the Company contributed a discretionary employer matching contribution of one-half of the first \$1,200 of a participant's contributions to the Plan. There were no additional profit-sharing contributions.

Participants direct the investment of their participant contributions, employer matching and profit-sharing contributions into various investment options offered by the Plan. Participants may change their contribution elections and prospective investment elections on a daily basis.

Newly eligible participants are subject to an automatic enrollment process. Unless electing otherwise, participants who become newly eligible will be enrolled with a default 3 percent deferral of their eligible compensation.

Participant Accounts

Accounts are separately maintained for each participant. The participant's account is credited with the participant's contributions, employer matching contributions, profit-sharing contributions, Plan earnings/losses (based on each participant's investment elections) and charged with administrative expenses. Participants are entitled to the benefit that can be provided from the participant's vested account.

Rollover Contributions

Participants are allowed to make rollover contributions of amounts received from other qualified retirement plans. Rollover contributions are allocated to a separate rollover account maintained on behalf of the participant.

Vesting and Distribution Provisions

Participants are fully vested in their participant contributions, employer matching contributions and related earnings thereon. Participants fully vest in the profit-sharing contributions and the related earnings thereon after being credited with three years of benefit service. The Plan provides for 100 percent vesting of the profit-sharing contributions and the related earnings thereon upon a participant becoming totally and permanently disabled or deceased while actively employed, or reach early retirement age.

Employer contributions forfeited by terminated participants may be used to reduce future employer contributions to the Plan or to pay Plan expenses. None were forfeited and used to reduce the Company's contributions or to pay Plan expenses for the year ended December 31, 2024.

Upon termination of employment, the balance in a participant's vested account is distributable in a single lump sum cash payment. If the termination of employment is due to death, disability, or retirement the Participant (or beneficiary) may elect to receive periodic withdrawals. Participants also have the option to leave their vested account balances in the Plan, subject to certain limitations and required minimum distribution rules. In addition, participants may withdraw portions of their vested account at any time after reaching age 59 ½.

Notes Receivable from Participants

The Plan provides for participant loans against eligible participant account balances. Loan amounts are limited to the lesser of \$50,000 or 50 percent of the individual participant's vested account balance, with certain regulatory restrictions. The minimum loan permitted is \$1,000 and participants may only have two outstanding loans at any time. Each loan specifies a repayment period that cannot extend beyond five years. However, the five-year limit shall not apply to any loan used to acquire any dwelling unit which within a reasonable time is to be used as the principal residence of the participant (determined at the time the loan is made). Loans bear interest at the prime interest rate plus 1%, as determine at the time of loan origination. Repayments, including interest, are made through payroll deductions and are credited to the individual participant's account balance. Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. For participant loans that are in default, the amount of the unpaid loan principal and interest due to the Plan will be treated as a deemed distribution. Deemed distributions are reported as a taxable distribution and remain part of the participant's account balance until a distributable event occurs (i.e., termination of employment).

Administration

The Plan is administered by the Company. To assist in operating the Plan efficiently and accurately, the Company may appoint others to act on its behalf or to perform certain functions.

Plan Termination

The Company has the right under the Plan at any time to terminate the Plan, subject to provisions of ERISA. In the event of Plan termination, participants will become fully vested in all benefits which have been accrued up to the date of Plan termination and Plan assets will be distributed in accordance with the provisions of the Plan.

Plan Qualification

The Plan is an adopter of a standardized prototype plan sponsored by Ascensus, LLC. The prototype plan document has received an opinion letter on June 30, 2020, from the Internal Revenue Service ("IRS") as to the prototype document's form and compliance with the applicable sections of the IRC. The prototype plan opinion letter has been relied upon by the Plan. The Plan has been amended since the prototype plan received the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no material uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Company believes the Plan is no longer subject to income tax examinations for tax years prior to 2021.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments

Investments are valued as described in Note 4. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. All costs and expenses incurred in administering the Plan are charged to the Plan, unless paid by the Company. Administrative expenses related to processing qualified domestic relations orders and participant loans are paid directly from participant accounts.

Participant Withdrawals

Participant withdrawals are recorded when paid.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimated.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

3. Information Certified by Ascensus Trust Company

The following is a summary of the Plan's investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA supplemental schedule, that was prepared by or derived by information certified by Ascensus Trust Company ("the Trustee") and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided by the Trustee related to the Plan's investments is complete and accurate in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Investments are stated at fair value and are valued as described below:

- Registered investment companies: Stated at net asset value ("NAV") of units held based on the quoted market prices of the fund as reported on public exchanges.
- Common collective trust: Stated at NAV of units held. The Plan's management elected the practical expedient to use NAV in measuring the fair value of the underlying investments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Company believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The guidance on fair value measurements defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants. This guidance also specifies a fair value hierarchy based upon the observability of inputs used in valuation techniques. Observable inputs (highest level) reflect market data obtained from independent sources, while unobservable inputs (lowest level) reflect internally-developed market assumptions. In accordance with this guidance, fair value measurements are classified under the following hierarchy:

- **Level 1** - Quoted prices for identical instruments in active markets.
- **Level 2** - Quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuations in which all significant inputs or significant value-drivers are observable in active markets.
- **Level 3** - Model-derived valuations in which one or more significant inputs or significant value-drivers are unobservable.

When available, quoted market prices are used to determine fair value, and such measurements are classified within Level 1. In some cases where market prices are not available, the observable market based inputs are used to calculate fair value, in which case the measurements are classified within Level 2. If quoted or observable market prices are not available, fair value is based upon valuations in which one or more significant inputs are unobservable, including internally developed models that use, where possible, current market-based parameters such as interest rates, yield curves and currency rates. These measurements are classified within Level 3.

Fair value measurements are classified according to the lowest level input or value-driver that is significant to the valuation. A measurement may therefore be classified within Level 3 even though there may be significant inputs that are readily observable.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The significance of transfers between levels was evaluated based upon the nature of the financial instrument and size of the transfer relative to total net Master Trust assets. For the year ended December 31, 2024, there were no transfers into or out of Levels 1, 2 or 3.

The Plan assets that are measured at fair value as of December 31, 2024 and 2023 are summarized below. Investments measured at net asset value per share using the practical expedient have not been classified in the fair value hierarchy, but are presented in order to permit reconciliation to Investments at fair value disclosed on the Statements of Net Assets Available for Benefits.
