Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Guiding Eyes for the Blind 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan.

General

The Plan is a defined contribution plan sponsored by Guiding Eyes for the Blind, Inc. (Employer). The Plan was established and effective on January 1, 2015 and conforms to the legislative requirements of the final regulations under the Internal Revenue Code (the IRC) Section 403(b). All employees who are not temporary employees are eligible and are automatically enrolled to make deferrals at 3% upon date of hire. Eligible employees of the Plan who have reached the age of 21 are eligible to receive Employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Principal Trust Company is the trustee of the Plan.

The Plan, at certain times, is amended and restated for regulatory and certain other administrative Plan changes.

Contributions

Annually, participants are permitted to contribute to the Plan an amount not to exceed the dollar limitation of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, as prescribed by the IRC. Effective January 1, 2024, all eligible participants were enrolled in an automatic escalation on their current contribution by 1% annually up to a maximum escalation rate of 10%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 for the years ended December 31, 2024 and 2023. Rollover contributions are permitted from prior employers' qualified plans. Qualified nonelective contributions are made each payroll period by the Employer to eligible participants of the Plan in an amount of 4% of the participant's eligible compensation. Matching contributions are made each payroll period by the Employer to eligible participants of the Plan at 100% of the participant's elective deferral contributions, up to a maximum of 6% of eligible compensation.

Participant Accounts

Participants are provided a selection of mutual funds and a fully benefit-responsive investment contract in which to invest contributions. Each participant's account is credited with the contributions described above. Earnings are credited to each participant's account, which are distributed by the respective mutual funds and fully benefit-responsive investment contract. Each investment account is revalued daily on the basis of fair market value. Periodic statements are provided to all participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions are fully vested at all times with respect to their contributions. Employer qualified nonelective contributions of 4% are 100% vested and matching contributions vest at the following rates:

Years of Service	Vested (%)
Less than 1	-
1 but less than 2	20
2 but less than 3	40
3 but less than 4	60
4 but less than 5	80
5 or more	100

If the Plan is amended to change the vesting schedule and the employee is an active participant when the Plan is amended, the vesting percentage will not be less than it would have been had the Plan continued unchanged. Participants are fully vested upon retirement age, disability, or death.

Payment of Benefits

On termination of service due to separation, retirement, death, or in-service withdrawals after age 59½, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For reasons of hardship, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Notes Receivable from Participants

Effective September 1, 2024, participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator, which would be made under similar circumstances and is fixed for the term of the loan. The interest rate on notes outstanding in 2024 ranged from 8% to 8.50%. The notes are repaid ratably through payroll deductions over a period of five years or less. These loans are subject to certain restrictions, as defined by the Plan document and applicable restrictions under the IRC. Also, each participant may not have more than one loan outstanding at any time.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan. Administrative expenses paid by the Employer for the Plan are excluded from these financial statements. Transaction fees, such as distribution, withdrawal, and investment buying or selling fees, are paid by the Plan and charged directly to the participants.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$36,905 and \$16,500, respectively. This account is used to reduce future Employer contributions or Plan expenses. During

the years ended December 31, 2024 and 2023, \$36,748 and \$16,500, respectively, was used to reduce Employer contributions and to pay Plan expenses. As of December 31, 2024 and 2023, non-vested forfeiture account balances were \$157 and \$0, respectively.

SECURE 2.0 Act of 2022

Effective January 1, 2024, in compliance with Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (SECURE Act 2.0), the Plan adopted all required provisions related to Required Minimum Distributions, Small Amount Force-Out distributions and Top-Heavy testing minimum contribution requirement, no formal amendment of the Plan was required.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the Plan's financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect reported amounts of assets, liabilities, revenue, and expenses, as well as the disclosures of contingent assets and liabilities. These estimates include the fair value of investments. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for a discussion of fair value measurements and see Note 5 for a discussion on contract value measurement.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in the fair value of investments, which consists of realized gains or losses on investments sold and unrealized gains or losses on investments held.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

3. Risks and Uncertainties

The Plan is invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Fair Value Measurements

GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that inputs that are most observable be used when available. The input hierarchy is broken down into three levels based on the degree to which the exit price is independently observable or determinable.

Level 1 - These inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - These inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - These inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

The following is a description of the valuation methodology used for the Plan's investments. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds - These investments are public investment securities valued using the net asset value (NAV) provided by the trustee. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is quoted in an active market and, therefore, Level 1 is the most appropriate classification for these investments.

The Plan had no financial assets that were measured at fair value on a nonrecurring basis or Plan liabilities recorded at fair value at December 31, 2024 or 2023.

5. Investment Contract

The Plan has a benefit-responsive investment contract with Principal Life Insurance Company. Contributions are maintained in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Principal Life Insurance Company has assessed that contract value approximates fair value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with Principal Life Insurance Company. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (v) premature termination of the contract. The Plan sponsor does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without consent of the issuer.

6. Information Certified by Principal Trust Company

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts.

8. Tax Status

Effective October 1, 2020, the Plan was amended and restated under a Volume Submitter 403(b) Plan that received an advisory letter from the Internal Revenue Service (IRS), dated March 31, 2017, stating that the form of the Volume Submitter 403(b) Plan was acceptable under Section 403(b) of the IRC and was therefore exempt from federal income taxes. The Employer believes that the Plan, as amended, is designed and currently being operated in compliance with the applicable requirements of the IRC, thus no provision for income taxes has been provided for in the accompanying financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Party-in-Interest Transactions

Plan investments are managed by Principal Trust Company, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to this entity qualify as party-in-interest transactions and amounted to \$38,323 and \$98,987 for the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants also qualify as party-in-interest transactions.

10. Subsequent Events

In 2025, the Plan's Committee reviewed the optional provisions of the SECURE Act 2.0 and approved an amendment to the Plan to incorporate the increased catch-up contribution limit for participants between the ages of 60 and 63, as permitted under the Act.

The Plan evaluated the accompanying financial statements for subsequent events through August 20, 2025 and transactions on the date these financial statements were available for issue, and has determined that no material subsequent events have occurred that would affect the information presented in the accompanying financial statements or required additional disclosure.
